## Independent Auditors' Report

To the Plan Administrator of

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Haynes and Boone Investment Directed Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits—modified cash basis as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits—modified cash basis for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Haynes and Boone Investment Directed Profit Sharing Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. ## **Emphasis of Matter - Basis of Accounting**

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America, and as a result the financial statements may not be suitable for another purpose. Our opinion is not modified with respect to this matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2; this includes determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. ## 1. Description of Plan

The following description of the Haynes and Boone Investment Directed Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

### General

The Plan is a defined contribution plan established effective December 17, 1968, as restated January 1, 2017. The Plan covers all employees, excluding employees covered by a collectively bargaining agreement, nonresident aliens and leased employees, of Haynes and Boone, LLP (the Firm or Employer) who have completed two years of service. Long-term part-time employees who met eligibility requirements under the SECURE Act are also eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Retirement Plan Committee is responsible for oversight of the Plan. The Retirement Plan Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

### Master Trust

The Plan's investments are held in the Haynes and Boone Retirement Savings Plan & Investment Directed PS Plan Master Trust (the Master Trust), which was established for the investment of assets of the Plan and another Haynes and Boone, LLP sponsored retirement plan. Each participating retirement plan has an undivided interest in the Master Trust. The assets of the Master Trust are held by Charles Schwab Trust Bank (Trustee).

### Contributions

The Plan is funded through Firm profit sharing contributions based upon a formula that considers each participant's annual compensation and employment position, such as attorney, partner or non-attorney employee. The Plan does not permit participant elective deferrals. Pre-tax rollover contributions representing distributions from other qualified defined benefit or defined contribution plans are permitted by the Plan.

### Investment Options

The Plan provides for Firm profit sharing contributions to be invested by the participant into a variety of mutual funds of registered investment companies and common collective trusts (Core Funds), in accordance with participant investment elections and provisions of the Trust agreement. Participants may also elect to invest in the self-directed option (SDO), which offers a wide array of investments including equity, debt, mutual funds of registered investment companies and other investments as elected by the participant. Participants should refer to the Plan website for additional fund information.

Each participant's Core Fund investment account is credited with the allocation of the Firm's profit sharing contributions. A participant's investments in the Core Fund account are charged with plan earnings or losses and charged with an allocation of certain administrative expenses based on each participant's account balance in relation to the total plan balance related to those investments. Allocations of plan earnings or losses are based on a participant's account balance in each investment as a percentage of the total of participants' account balances in each investment.

Each participant's SDO account is credited with the participant's allocation of the Firm's profit sharing contributions. A participant's investments in SDO accounts are charged or credited with the net earnings, gains, losses, expenses and allocation of any administrative expenses based on each participant's SDO account balance in relation to the total plan balance, as well as appreciation or depreciation in fair value attributable to such account.

## Participant Accounts

Each participant's account is credited with the participant's contributions, allocations of the Firm's contributions and an allocation of the Plan's earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

## Vesting and Forfeitures

Participants are vested immediately in their contributions and the Firm's contributions plus actual earnings thereon. As such, there are no forfeitures available for use at December 31, 2024 and 2023.

## Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined by the Plan Administrator, is set at 1% above the prime rate, as defined. Principal and interest are paid ratably through payroll deductions. Terms range up to five years or greater or max of 10 years for a residential loan.

## Payment of Benefits

On termination of service due to death, disability, retirement or other reasons, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. If a terminated participant's vested balance is less than or equal to \$7,000, the amount may be automatically distributed in the form of lump sum cash payment, balances of \$1,000 or less are cashed out, and balances greater than \$1,000 but less than \$7,000 are rolled into an individual retirement account. In addition, the Plan allows for in-service and hardship distributions, if certain criteria are met.

## Due From Affiliated Plan

The Plan Administrator determined the rollover contributions from the Haynes and Boone, LLP Partners' Cash Balance Plan were not properly reflected as rollover contributions to this Plan as a result of a reporting error by the Trustee. These rollovers were incorrectly recorded in the Haynes and Boone Retirement Savings Plan. As a result, a due from affiliated plan (Haynes and Boone Retirement Savings Plan) in the amount of \$1,326,690 was been recorded as of December 31, 2023.

## 2. Summary of Accounting Policies

### Basis of Accounting

The Plan is maintained on the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America, and is an acceptable method under ERISA. Under the modified cash basis of accounting, the Plan records administrative expenses and interest and dividend income on a cash basis, and purchases and sales of investments on settlement date basis. Had the Plan prepared the accompanying financial statements on the accrual basis of accounting, the Plan would have recorded an adjustment for the aforementioned items in an amount insignificant to the overall financial position of the Plan.

## Use of Estimates

The preparation of financial statements in accordance with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

## Investment Valuation and Income Recognition

Investments held in the Master Trust are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

The Plan's interest in the investment gain of the Master Trust, in the accompanying Statement of Changes in Net Assets Available for Benefits—Modified Cash Basis includes the Plan's allocation of interest, dividends, realized gains or losses from the sale of investments and unrealized appreciation or depreciation in the fair value of investments held by the Master Trust, and fees charged to the Master Trust, which are netted against or included with net appreciation (depreciation) in fair value of investments. These fees represent charges by the Trustee for services provided in connection with recordkeeping and investment management. Net unrealized appreciation (depreciation) in fair value of investments represents the net change in the fair value of the investments held during the period. The net realized gains or losses on the sale of investments represent the difference between the sale proceeds and the fair value of the investments as of the beginning of the period or the cost of the investment if purchased during the year.

## Contributions

Contributions from the Firm are recorded in the year in which the contributions are earned.

## Payment of Benefits

Benefits are recorded when paid.

## Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Firm. Expenses that are paid by the Firm are excluded from these modified cash basis financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

## Recent Accounting Standards

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the year ended December 31, 2024, and continues to evaluate the impact of the adoption and implementation of this legislation on the Plan. The application of SECURE 2.0 Act did not have a material effect on the Plan's financial statements.

## Subsequent Events

Subsequent events were evaluated through September 10, 2025, the date the modified cash basis financial statements were available to be issued.

## 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Self-directed option:* Primarily consist of common stock, mutual funds of registered investment companies, interest-bearing cash, unit investment trusts and are valued at NAV or quoted market prices held by the brokerage funds at year-end.

Bonds consist of the United States (the U.S.) and non-U.S. fixed income securities. The Master Trust's managers value these securities utilizing cash flow projections, models or matrix pricing, which incorporate yield and/or price with respect to bonds that are considered comparable in characteristics such as rating, interest rate and maturity date and quotations from bond dealers to determine current value.

Insurance contracts are valued by each insurance carrier based on the cash surrender values of each policy.

Common collective trusts are valued at the NAV of shares held by the Master Trust at year-end, as determined by Charles Schwab Trust Bank. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The NAV is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Master Trust to initiate a full redemption of the common collective trust, the Trustee reserves the right to temporarily delay withdrawals from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

#### 4. Interest in Master Trust

The value of the Plan's interest in the Master Trust is based on the beginning of year value of the Plan's interest in the trust plus actual contributions and allocated investment income less actual distributions and allocated administrative expenses. At December 31, 2024 and 2023, the Plan's interest in the net assets of the Master Trust was approximately 45%. Total investment income (including net appreciation (depreciation) in the fair value of investments) and administrative expenses of the Master Trust are allocated to the individual plans based upon the amount of the time the Plan's assets were invested in the Master Trust.

## 6. Related-Party and Party in Interest Transactions

Certain plan investments are managed by Charles Schwab Trust Bank, the Trustee, and therefore, these transactions qualify as party in interest transactions.

The Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party in interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Firm. No such officer or employee receives compensation from the Plan.

## 7. Plan Termination

Although it has not expressed any intent to do so, the Firm has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will have a nonforfeitable, 100% vested interest in his or her account balance, including all Firm profit sharing contributions, subject to payment of liquidation costs and expenses.

## 8. Tax Status

The Internal Revenue Service (IRS) has determined and informed the Firm by a letter dated November 21, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving this letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## 9. Risks and Uncertainties

The Master Trust invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, concentration and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits—Modified Cash Basis.
