Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's responsibilities for the audit of the financial statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with US GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with US GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures

responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other matter - supplemental schedules required by ERISA

The supplemental schedule of assets (held at end of year) as of November 30, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such supplementary information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures. These additional procedures included comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with US GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 - PLAN DESCRIPTION

The following description of the Pella - Vinyl Portland Operations 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Vinyl Northwest, LLC (the "Company"), the Plan Sponsor and a wholly-owned subsidiary of Pella Corporation, who are covered by the Iron Workers collective bargaining agreement and the Glass Workers collective bargaining agreement. The Plan is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). The Investment Committee is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings and monitors investment performance.

On March 27, 2020, the Coronavirus Aid, Relief and Economic Security Act (CARES Act) was signed into law. Plans were permitted to adopt these provisions immediately provided the Plan agreement disclosed above is retroactively amended on or before December 31, 2025. Plan management elected to adopt the following provisions:

- On or after March 27, 2020 and before December 31, 2020, any qualified individual, as defined in the CARES Act, was permitted to request a distribution from his or her vested account in the Plan, up to a maximum of \$100,000. Active employees who receive a coronavirus-related distribution from the Plan (or from any other eligible retirement plan) may repay all or any portion of the distribution to the plan within the three-year period beginning on the date after the distribution.
- Qualified individuals were permitted to make loans up to \$100,000 or 100% of the participant's vested balance through December 31, 2020. Participants were also permitted to request that their loan payments through December 31, 2020 be deferred. Where payments were deferred, the loan was re-amortized in January 2021 to reflect interest accrued during the delay, and payments recommenced for the remainder of the loan period, plus one year.

Plan Operations

Effective January 1, 2020, Charles Schwab Trust Bank (the "Custodian") is the Custodian and Trustee of the Plan. The Custodian is responsible for holding the investment assets and notes receivable from participants of the Plan, making investment transactions and making distributions to participants and former participants. Certain expenses incurred in administering the Plan are paid by the Company and are not reflected in the Plan's financial statements.

Eligibility

Employees are eligible to participate in the Plan upon completing three months of service and attainment of age 21.

Contributions

Participants may make pretax contributions to the Plan through uniform payroll deductions up to the annual limit of \$23,500 for 2024. Participants aged 50 or older may make voluntary "catch up" contributions to the Plan up to an annual maximum of \$7,500 for 2024. Participants direct their elective contributions into various investment options offered by the Plan and can change their investment options on a daily basis. Participants may also contribute amounts representing distributions from other qualified plans. The Company may elect to make a matching contribution to each participant based on his or her elective deferrals in a percentage set by the Company prior to the end of the plan year. For the year ended November 30, 2024, the Company did not elect to make a matching contribution.

Participant Accounts

A 401(k) account is established for each participant who makes a contribution. Each participant's account is credited with the participant's contribution, any employer discretionary matching contribution, and the participant's earnings on the account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. Participant accounts are valued daily.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's discretionary matching contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. The participant's vested percentage shall be determined from the following vesting schedule based on the participant's years of vesting service at the time of the participant's termination of employment.

Payment of Benefits

Upon termination of service due to death, disability or retirement, participants whose account balances equal or exceed \$5,000 may elect to receive either a lump sum payment equal to the value of the participant's vested interest in his or her account or installment payments over any period that does not exceed the life expectancy of the participant and his or her beneficiary.

If a participant's employment is terminated for any reason and their Vested Interest is \$5,000 or less (excluding the participant's Rollover Account balance) it will be distributed in a lump sum, or, if elected by the participant, will be rolled over to another qualified retirement plan or to an individual retirement account ("IRA") of their choosing. However, if participants do not make an election, then the distribution will be rolled over to an IRA that Charles Schwab establishes for them at an IRA provider. The IRA provider may charge the IRA for any expenses associated with the establishment and maintenance of the IRA and with the investments of the IRA.

Notes Receivable from Participants

Except for COVID related provisions adopted in 2020, a participant with a vested aggregate account balance greater than \$20,000 may borrow up to, but not exceeding, the lesser of \$50,000 or 50% of his or her vested

account balance, with a \$1,000 minimum. Note terms are not to exceed five years unless to purchase or construct a principal residence for which purpose the note term is ten years. The notes are secured by the balance in the participant's account, unless otherwise noted, and bear an interest rate which is commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions. A participant can have no more than three loans outstanding at one time. At November 30, 2024 and 2023, all outstanding loans bear interest at rates ranging from 3.25% to 8.5%, respectively.

Forfeitures

Forfeitures may be used to pay administrative expenses, restore previous forfeitures of participants who are re-participating in the Plan and are eligible for a restoration as per the Plan agreement disclosed above, or to reduce or increase employer contributions. During the year ended November 30, 2024, there were no forfeited nonvested amounts, and no amounts were used to reduce employer contributions. At November 30, 2024 and 2023, there were no forfeitures outstanding.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Valuation of Investments and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

In accordance with the policy of stating investments at fair value, the net appreciation in the fair value of investments reflects both realized gains and (losses) and the change in the unrealized appreciation (depreciation) of investments held at year-end. Purchases and sales of securities are reported on a trade-date basis (the date the order to buy or sell is executed). Interest is accrued as earned and dividend income is recorded on the ex-dividend date.

Payments of Benefits

Benefits are recorded when paid. As of November 30, 2024, no participants had elected to withdraw from the Plan but had not yet been paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan agreement disclosed above. No allowance for credit losses has been recorded as of November 30, 2024 or 2023.

Administrative Expenses

Administrative costs of the Plan may be paid by the Company at its discretion or, alternatively, may be paid by the Plan. Expenses incurred in the purchase or sale of investments are added to the cost or deducted from the proceeds of the respective investment. Administrative expenses are charged to each participant's account.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make significant estimates and assumptions that affect the reported amounts of net assets available for plan benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan provides for various investment options in any combination of several investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility and credit. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to amend or terminate the Plan subject to the provisions of ERISA. In the event of plan termination, the participants will become fully vested in their accounts and the Plan's assets will be distributed to participants in accordance with the Plan's provisions and as set forth under ERISA.

Subsequent Events

The Plan has evaluated subsequent events through September 10, 2025, which is the date the financial statements were available to be issued. Plan management is not aware of any subsequent events that would require recognition or disclosure in the financial statements.

NOTE 3 - INTEREST IN PELLA CORPORATION MASTER TRUST

The Plan's investments are held in a Master Trust, which was established to hold and invest the assets of the Plan and several other Pella Corporation sponsored retirement plans. Each participating retirement plan has an undivided interest in the Master Trust. The assets of the Master Trust are held by the Custodian.

The value of the Plan's interest in the Master Trust is based on the beginning-of-year value of the Plan's interest in the trust plus actual contributions and allocated investment income less actual distributions and allocated administrative expenses. At November 30, 2024 and 2023, the Plan's interest in the net assets of the Master Trust was approximately 0.20% and 0.20%, respectively. Investment income and administrative expenses relating to the Master Trust are allocated to the individual plans based upon average monthly balances invested by each plan.

Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below.

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at November 30, 2024 and 2023.

Interest Bearing Cash - Due to their short-term nature, the fair value of interest-bearing cash balances is determined by reference to their face value.

Stable Value Fund - Valued based on the net asset value (“NAV”) of the underlying securities determined on quoted market prices, dealer quotations or valuations provided by alternative prices supported by observable inputs in markets that are not considered to be active, which is a practical expedient to fair value.

Collective Funds - Valued at the daily closing price as reported by the fund. Collective trusts are funds that are only available to institutional investors and are regulated by the National Securities Clearance Corporation. The funds publish their daily unit value and transact at that price. The unit value is calculated as the underlying value of the assets, less fee and expenses, divided by the number of outstanding units, value based on the NAV, which is a practical expedient to fair value.

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds are open-ended mutual funds that are regulated by the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-Directed Brokerage Accounts - Accounts primarily consist of mutual funds and common stocks that are valued on the basis of readily determinable market prices.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different estimate of fair value at the reporting date.

NOTE 4 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are issued and managed by the Custodian and, therefore, transactions related to these investments qualify as party-in-interest transactions.

On behalf of the Plan, the Company pays a quarterly fee to a consulting firm for advice related to investment decisions. The Company also pays the Plan's audit fees on behalf of the Plan. All other fees are paid by the Plan.

NOTE 5 - FINANCIAL DATA CERTIFIED BY THE CUSTODIAN

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Charles Schwab Trust Bank (effective January 1, 2020), certifies that the following information included in the financial statements is complete and accurate:

- Investments, at fair value and notes receivable from participants, as shown in the statements of net assets available for benefits as of November 30, 2024 and 2023.
- Investment income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended November 30, 2024.
- Schedule H, line 4(i) - schedule of assets (held at end of year) as of November 30, 2024.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements.

NOTE 6 - INCOME TAX POSITION

The Internal Revenue Service (the "IRS") has determined and informed the Trustee by a letter dated September 21, 2020 that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (the "IRC"). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance, in all material respects, with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of November 30, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
