INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of the Hensel Phelps Construction Co. Employee Benefit Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of the Hensel Phelps Construction Co. Employee Benefit Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits – modified cash basis as of December 31, 2024, and the related statement of changes in net assets available for benefits – modified cash basis for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from Comerica Bank and Trust, N.A., a qualified institution as of December 31, 2024, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion on the 2024 Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section—

- the amounts and disclosures in the 2024 financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America.
- the information in the 2024 financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion on the 2024 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Basis of Accounting

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements and supplemental schedules are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the 2024 Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with the modified cash basis of accounting described in Note 2; this includes determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements, including omissions, are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.



In performing an audit in accordance with GAAS, we:

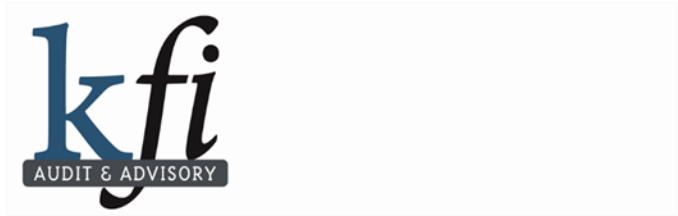

(1) Description Of Plan

Hensel Phelps Construction Co. Employee Benefit Plan (the “Plan”) was established on September 1, 1972. The following description of the Plan provides only general information. Participants should refer to the Plan document for a complete description of the Plan’s provisions. Hensel Phelps Construction Co. (the “Company” or “Plan Sponsor”) has the right to terminate, suspend, withdraw, or amend the Plan in whole or in part at any time, subject to the provisions set forth in the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. The Plan is administered by the Board of Directors of the Company (the Board). The Hensel Phelps Retirement Plan committee determines the appropriateness of the Plan’s investment offerings and monitors investment performance. The Plan is subject to the provisions of ERISA.

The Plan entered into a trust agreement (the “Trust”) with Comerica Bank and Trust, N.A. (the “Trustee”) on May 1, 2009, for the purpose of funding Plan benefits. The Plan assets are held in the Trust, which is a Voluntary Employees’ Beneficiary Association (VEBA) Trust. The Trust, consisting of a Self-Insured Medical Account and an Hour Bank Funds Account, acts as a conduit for payment of claims and other Plan expenses. The Trust is funded by irrevocable cash contributions paid by or at the direction of the Company to be held, invested, reinvested, managed, administered, and distributed for the exclusive benefit of the participants. Boon Administrative Services, Inc. (“BAS”) serves as the third-party administrator for the Trust.

(a) General

The Plan was established as an employee health and welfare benefit plan for the exclusive benefit of all salaried employees and eligible hourly employees of the Plan Sponsor and its affiliates, as amended. The Plan benefits include life insurance, disability, wellness, medical and pharmacy, dental, and vision benefits.

At each annual enrollment, provisions, such as participant contribution rates, coverage deductibles, copays, and out-of-pocket maximums, may change. Coverage is continued for employees who are on approved short-term disability leave or leave under the Family and Medical Leave Act of 1993 (“FMLA”). Former employees and their dependents are eligible for continued coverage for the number of months specified under the Consolidated Omnibus Budget Reconciliation Act of 1985 (“COBRA”), if they so elect. Pharmacy benefits are also provided with respect to the Medicare Prescription Drug, Improvement, and Modernization Act of 2003.

(b) Eligibility

In general, all employees of the Company, its subsidiaries and affiliates and their dependents are eligible to participate in a portion of, or all of the benefits offered by the Plan, as further described in the Plan documents. Salaried employees are eligible following a service waiting period of 90 days. Hourly employees are eligible on the first day of the month following completion of a service waiting period of 60 days. Qualified dependents and spouses are eligible, as further described in the Plan document.

(c) Contributions and Premiums

Plan participants and the Company share the cost of coverage. Participants are responsible for copayments, deductibles, and coinsurance amounts, if applicable and costs are dependent on the level of coverage selected. Participants pay a portion of their premiums based on their specific benefit coverage elections (based on annually determined contribution rates) through payroll deductions. In addition, participants contribute to the Plan for various other purposes including COBRA continuation

of coverage. The Company pays its share of the cost of coverage as contributions to the Plan to be used to fund benefits. Contributions made by the Company for hourly employees are based on a specified fringe rate and the number of hours worked by the employee. Contributions made by the Company for salaried employees are based on a set dollar amount per employee, per month, pursuant to the prevailing administrative service agreement in place. These contributions are held in the Trust. BAS pays authorized benefits from the Trust as claims are processed by the Plan's claims administrator.

COBRA and retiree premium contributions received by the Plan for eligible covered participants totaled \$801,395 and \$761,032 for the years ended December 31, 2024 and 2023, respectively, and is included in the Participant contributions on the statement of changes in net assets available for benefits.

Contributions are invested in assets held in Trust accounts. The Trustee invests the Plan's funds as set forth in the Trust Agreement. Investments consist of money market funds and are reported at fair value.

Underwriters and actuaries of the insurance carriers have developed a set of rates applicable to the policies that have been issued to the Plan. The Plan Sponsor is quoted a premium rate based upon Plan design, location, and other demographic data. These rates are subject to change annually.

(d) Benefits

The Plan provides self-insured medical and pharmacy benefits and fully-insured health (Guam participants only), dental, vision, life, accidental death and dismemberment, long-term disability insurance, and COBRA insurance to participants, retirees, and their beneficiaries and dependents based on eligibility. Through COBRA, eligible retirees and participants subject to continuation of coverage are eligible for the same benefits as if they were still employed. The self-insured medical health plan benefits are provided through CIGNA Health and Life Insurance Company ("CIGNA"). The fully insured dental and vision plan benefits are provided through Delta Dental, the fully insured disability, and life insurance benefits are provided through New York Life, and the fully insured Guam health plan benefits are provided by Calvos. Contributions related to the self-funded medical and pharmacy plans are remitted to a lockbox maintained by BAS to be transferred into the Trust. Dental, vision, health, disability, and life insurance of active participants, dependents, and beneficiaries are processed by individual carriers, but the responsibility for payments to providers is retained by the Plan. Payments for fully insured dental, vision, life, accidental death and dismemberment, and long-term disability, and Guam health coverage are made directly by the Plan Sponsor to providers and do not flow through the Trust. For the year ended December 31, 2024, these amounts totaled \$4,398,904 and are included in both contributions and premium payments on the statement of changes in net assets available for benefits - modified cash basis.

(e) Stop Loss

The Plan Sponsor holds a stop loss policy on medical and pharmacy claims. The Policy is issued by Construction Liability Insurance Company (CLIC), a related party of the Plan Sponsor. Premium payments to CLIC totaled \$4,649,191 and \$4,065,806 for the years ended December 31, 2024 and 2023, respectively. If a participant specific medical or pharmacy claim reaches \$325,000, the stop-loss insurance will reimburse the excess costs. The policy has an aggregate stop-loss limit of \$5,750,000 for the total claims of all covered participants during the policy year. Stop-loss recoveries are paid directly to the Plan Sponsor, not to the individual plan participants. For the year ended December 31, 2024, recoveries from the stop-loss coverage totaled \$2,606,064, which are netted against health care benefit payments on the statement of changes in net assets available for benefits.

(f) *Hour Bank*

The Plan includes an allocation of the fringe contributions paid by the Company for hourly participants who are covered under the Davis-Bacon Act. Amounts contributed in excess of premiums and expenses are retained in the Plan for the benefit of these participants and is known as the “hour bank reserve.” These contributions are accounted for on an individual participant basis. The hour bank balance available to participants was \$2,900,554 and \$2,452,612 as of December 31, 2024 and 2023, respectively, and is eligible to be distributed as long as the participant has terminated employment and can show proof of new insurance coverage. Alternatively, participants may use the hour bank balance to purchase COBRA. These funds are restricted from any other use. The Hour Bank Funds Account included in net assets available for benefits was \$2,900,554 and \$2,452,612 as of December 31, 2024 and 2023, respectively. Distributions of hour bank balances are treated as W-2 wages for the respective participants.

(2) *Significant Accounting Policies*

(a) *Basis of Accounting*

The financial statements of the Plan are prepared on the modified cash basis of accounting, which is a comprehensive basis of accounting other than generally accepted accounting principles (“GAAP”). GAAP requires the accrual basis of accounting whereby revenues are recognized as earned and expenses are recognized as incurred. Under the modified cash basis of accounting, incurred but not reported claims are disclosed in the notes to financial statements rather than accrued in the financial statements (see Note 5).

(b) *Use of Estimates*

The preparation of financial statements in conformity with the modified cash basis of accounting, which is a comprehensive basis of accounting other than GAAP, requires the Plan administrator to make estimates and assumptions that affect the amounts reported in either the financial statements, accompanying notes, or supplemental schedules. Actual results could differ from those estimates.

(c) *Risks and Uncertainties*

The Plan provides for investments in various investment securities which, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits - modified cash basis and participant account balances. The Plan’s investments are managed and monitored by the Trustee in accordance with the Plan’s Trust Agreement. All plan assets were invested in Goldman Sachs & Co as of December 31, 2024 and 2023.

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.

(d) Contributions Receivable and Current Expected Credit Losses

Historical write-offs continue to be the basis for the Company's allowance for current expected credit losses. To calculate the reserve, the Company considered the processes surrounding the contributions receivable since the inception of the Plan. The Company has not historically written off the contributions receivables that were accrued at Plan year-end. The Company expects business conditions for the Plan calendar year ended December 31, 2025, the collection period for the contributions receivables, to remain consistent with current conditions. As a result, the Company has recorded expected credit losses of \$0 as of December 31, 2024.

(e) Investment Valuation and Income Recognition

The Plan's investments are recorded at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value of the money market fund is based on quoted prices in active markets. See Note 3 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Dividend income is recorded on the accrual basis.

(f) Payment of Benefits and Claims

Premiums paid by either the Company or the Trust are recorded as payments in the accompanying statement of changes in net assets available for benefits – modified cash basis. Health claims are recorded when paid. Any refunds due to overpayments, subrogation, or adjustments are recorded in the period received and are shown netted with benefit payments. Premiums are reported when incurred. Hour bank distributions to participants are recorded by the Plan when actual payment is made.

(g) Administrative Expenses

Administrative expenses such as, but not limited to, administrative service fees, Trustee fees, audit fees, and investment management fees, can be paid by the Plan, as allowed by the Plan document. The Company pays all other expenses not paid by the Plan.

(h) Prescription Rebates

Prescription drug rebates are recorded in the period to which the related claims were paid and are shown netted with benefit payments.

(i) Insurance Premiums

Insurance premiums consist of the cost of premiums paid for the coverage for eligible participants.

(j) Claims Incurred But Not Reported (IBNR)

The Plan's liability for eligible claims incurred but not reported at year-end is estimated using actuarial methods that use historical trend information developed through studies of claim lag patterns incurred in the prior years. Factors were then applied to paid claims amounts to estimate the IBNR at year-end. The IBNR is not recorded in the financial statements, as they are reported within Note 6 - Claims Incurred But Not Reported.

(k) Subsequent Events

The Plan's management has evaluated subsequent events through October 23, 2025, the date which the financial statements were available to be issued. Based upon this evaluation, the Plan has determined that no subsequent events have occurred which require adjustment to or disclosure in the financial statements.

(3) Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, Fair Value Measurements and Disclosures, are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023:

Money Market Funds: Valued at the daily closing price as reported by the funds. The money market funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. The funds are required to publish their daily net asset value ("NAV") and to transact at that price. The money market funds held by the Plan are deemed to be actively traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(4) Summary Of Information Provided and Certified by Trustee

No auditing procedures were performed by the independent auditor with respect to the information certified as complete and accurate by Comerica Bank and Trust, N.A, the Plan trustee, except for comparing such information with the information reported in the financial statements. Based on the information provided and certified by the trustee, there are no fixed income obligations, leases, or debt instruments in default or deemed uncollectible, as defined by ERISA, as of December 31, 2024 and 2023. Accordingly, the trustee of the Plan assets has certified the completeness and accuracy of:

- a. Investments reflected on the accompanying statements of net assets available for benefits – modified cash basis as of December 31, 2024 and 2023, as well as the supplemental schedule of assets (held at end of year) – modified cash basis as of December 31, 2024, and the schedule of reportable transactions – modified cash basis for the year ended December 31, 2024.
- b. Dividend income reflected on the accompanying statement of changes in net assets available for benefits – modified cash basis for the year ended December 31, 2024.

(5) Benefit Obligations

The benefit obligation consists of claims incurred but not reported (“IBNR”).

The actuarial present value of the expected IBNR is determined by a third-party actuary, Milliman, and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and the probability of payment (by means of decrements such as those for death, disability, or withdrawal) between the valuation date and the expected date of payment. The following were other significant assumptions used in the valuation as of December 31, 2024 and 2023:

- Annual trend rates based on regression analysis of the most recent 36 months of actual claims and enrollment. The calculated trend rates were blended with national and regional averages, to arrive at final trend rates of 3.2% for medical and 9.5% for prescription drugs for the year ended December 31, 2024, final trend rates of 3.6% for medical and 7.4% for prescription drugs for the year ended December 31, 2023, and with the assumption that claims would continue at that level.

- Claims will continue to be incurred and paid at the same rate as identified.
- IBNR is adjusted based on historical patterns of actual large claims for January 2021 through November 2024. Each plan year is weighted according to credibility, with the most recent claims being most credible and oldest claims being least credible.

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligation.

(6) Claims Incurred But Not Reported

The Plan has not recorded an accrual for IBNR at year-end. IBNR as of December 31, 2024 and 2023, for health claims incurred by active participants but not reported at that date, for accumulated eligibility of participants are estimated by Milliman, Inc. Such amounts are disclosed at an undiscounted amount because amounts typically are payable within one year. Any differences in the amounts estimated and actual amounts will be disclosed in future years. As of December 31, 2024 and 2023, the total estimated liability for IBNR was \$3,606,901 and \$4,019,349, respectively. Such amounts are paid by the Plan only if claims are submitted and approved for payment.

(7) Party-In-Interest Transactions

Plan assets include investment accounts managed by the Trustee. BAS, Cigna, and Rocky Mountain Reserves (RMR) are third-party administrators. Transactions with the Trustee and third-party administrators qualify as exempt party-in-interest transactions under ERISA. Fees paid to the Trustee were \$6,000 for the year ended December 31, 2024. Payments to CIGNA related to medical claims administration services for the year ended December 31, 2024, totaled \$3,081,351. The Boon Insurance Agency, Inc., an affiliate of BAS, receives allowable commissions and BAS receives administrative fees paid out of premiums received by the Plan's insurance carriers for fully insured Plan benefits. Payments to BAS related to services rendered for self-insured Plan benefits for the year ended December 31, 2024, totaled \$402,000. Flood & Peterson Insurance, Inc. ("F&P") is a licensed insurance agency and provides certain ministerial services for the proper execution of the Trust and Plan. Payments to F&P for enrollment and participant support, including

interfacing with providers of benefits, for the year ended December 31, 2024, totaled \$70,020. COBRA is administered by RMR. Payments to RMR related to services rendered for administration of COBRA mailings and enrollment for the year ending December 31, 2024, totaled \$59,771. Express Scripts, Inc. is used as a third-party administrator for pharmacy/prescription drug related claims. Payments made to Express Scripts, Inc. were \$364,181 for the year ended December 31, 2024.

Other liabilities at December 31, 2024 and 2023, include \$1,781 and \$3,175, respectively, due to BAS for reimbursement of payroll taxes due on hour bank distributions.

(8) Plan Termination

Upon termination of the Plan, the Trustee would distribute all remaining net assets in a nondiscriminatory manner for the benefit of participants and eligible persons. Remaining net assets are deemed to be those monies remaining after payment of all reasonable and necessary obligations and expenses of the Plan. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

(9) Income Tax Status

The Trust funding the Plan has received an exemption letter from the Internal Revenue Service ("IRS") dated June 26, 2010, stating that the Trust is exempt from federal income tax under Section 501(c)(9) of the Internal Revenue Code ("IRC") as a Voluntary Employee Beneficiary Association, effective May 1, 2009. The Plan and Trust are required to operate in conformity with the IRC and ERISA to maintain the tax-exempt status of the Trust. The Plan administrator believes that the Plan and Trust are being operated in compliance with the applicable requirements of the IRC and ERISA, and therefore believes the Trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. Furthermore, there are no tax related interest or penalties for periods presented in these financial statements.

(10) Change In Presentation

The Plan has revised the presentation of contributions receivable on the Statement of Net Assets Available for Benefits – Modified Cash Basis as of December 31, 2024 to present the participant and employer contributions receivable separately from one another.
