## NOTES TO FINANCIAL STATEMENTS

### NOTE 1 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Nature of Business** - EdgeWater Power Boats, LLC (the “Company”) was organized in 1992 to design, develop and manufacture boats, sold primarily to dealers throughout the United States.

**Use of Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amount of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Accordingly, actual results could differ from those estimates.

**Cash and Cash Equivalents** - The Company includes cash on hand, and unrestricted demand deposits with financial institutions, in “Cash and Cash Equivalents” as used in the Statements of Cash Flows. The Company also considers short-term, highly liquid investments with maturities of three months or less from the date of original acquisition to be cash equivalents.

**Accounts Receivable** - The Company carries its accounts receivable at cost less an allowance for credit losses. On a periodic basis, the Company evaluates its accounts receivable and establishes an allowance for credit losses, when deemed necessary, based on its history of past write-offs and collections, and current credit conditions. The Company does not accrue interest on accounts receivable.

**Inventories** - Inventories are stated at the lower of cost (first-in, first-out method) or net realizable value. Net realizable value is the estimated selling price in the ordinary course of business, less reasonably predictable costs of completion, disposal, and transportation. Inventories are presented net of an allowance for obsolescence in the amount of \$77,000 at December 31, 2024.

**Property and Equipment** - Property and equipment is recorded at cost. Maintenance and repairs are charged to expense as incurred. Depreciation is computed on the straight-line method over the estimated useful lives of the assets, which range from three to twenty years.

**Warranty Costs** - Warranty costs are accrued based upon the experience rate of different product lines. The estimated liability for warranty exposure as of December 31, 2024 was \$639,923.

**Advertising Costs** - Net advertising costs, which are expensed as incurred, were \$683,533 in 2024. Advertising costs are partially offset by an advertising allowance from one of the Company’s vendors in the amount of \$3,825 in 2024.

**Revenue Recognition** - Revenues are generally recognized when control of the promised goods or services is transferred to the customer either at a point in time or over time, in an amount that reflects the consideration the Company expects to be entitled to in exchange for those goods or services. All of the Company’s contracts have one performance obligation and all consideration is allocated to that performance obligation.

#### **NOTE 1 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

**Leases** - In February 2016, the FASB issued ASU No. 2016-02, *Leases* (Topic 842). This standard supersedes the existing accounting standards for leases in Topic 840, *Leases*. This standard is effective for nonpublic entities for years beginning December 15, 2021. The standard requires a lessee to recognize right of use ("ROU") assets and related lease liabilities on the balance sheet for all leasing arrangements longer than twelve months. The related lease expense is recognized on the income statement. The lease guidance under Topic 842 was adopted on January 1, 2022. See Note 8, *Leases*, for further details.

**Income Taxes** - The Company is wholly owned by Nimbus Group USA, LLC, and is considered a disregarded entity for federal and state income tax purposes. Accordingly, no provision or liability for federal or state income taxes is reflected in the accompanying financial statements. Instead, the Company's income and expenses are reported by Nimbus Group USA, LLC on its income tax return.

**Uncertain Tax Positions** - Management has determined that the Company does not have any uncertain tax positions and associated unrecognized benefits that materially impact the financial statements or related disclosures. Since tax matters are subject to some degree of uncertainty, there can be no assurance that the Company's tax returns will not be challenged by the taxing authorities and that the Company or its members will not be subject to additional tax, penalties, and interest as a result of such challenge. As of December 31, 2024, the Company's tax returns generally remain subject to examination by major tax jurisdictions for the last three years.

**Disclosure of Subsequent Events** - Management has evaluated subsequent events through April 2, 2025, the date the financial statements were available to be issued. Management is not aware of any events subsequent to the balance sheet date which would require additional adjustment to, or disclosure in, the accompanying financial statements.

#### **NOTE 2 - CREDIT RISK**

The Company maintains cash accounts in financial institutions which insure deposits up to \$250,000 per depositor with the Federal Deposit Insurance Corporation ("FDIC"). As of December 31, 2024, the aggregate cash balances on deposit at the financial institutions used by the Company exceeded the FDIC deposit insurance limits by \$375,012.

During 2024, sales to two customers represented approximately 31% of total sales. The Company had a balance due from one other customer, a related party, at December 31, 2024 which comprised approximately 98% of total accounts receivable at that date. See Note 8.

The Company believes that the concentration of credit risk in its accounts receivable is substantially mitigated by the Company's credit evaluation procedures, the diversity of its client base, and establishing credit terms consistent with industry practices.

**NOTE 3 – ALLOWANCE FOR CREDIT LOSSES**

Management pools accounts receivable between boat sales and parts sales. Receivables related to boat sales are financed by boat dealers through various third party lenders and result in the Company being paid timely by the third party lenders. Receivables related to parts sales requires management to assess credit worthiness of customers. The Company has not experienced significant losses from parts sales receivable historically and does not forecast a significant change in customer behavior as of December 31, 2024.

**NOTE 4 - REVENUE RECOGNITION**

The Company derives revenue principally from the following sources: (i) boat sales, including engines and (ii) part sales. The following describes the Company’s revenue recognition policies in further detail for the major revenue sources of the Company.

- Boat sales, including engines
- Part sales

The company designs, develops and manufactures boats, which are sold to boat dealers throughout the United States. The Company also sells engines with its boats. In addition, the Company sells parts to boat dealers and individual customers. Revenues associated with these services and products are recognized at a point in time when the performance obligations are satisfied. The Company’s contracts are accounted for as a single unit of account (i.e., as a single performance obligation).

The Company’s revenues do not include variable consideration. The Company’s payment terms are cash on delivery, in which the customer takes ownership of the boat and engine upon picking it up at the Company’s manufacturing facility. The Company’s contracts with customers do not generally result in significant obligations associated with returns or refunds.

**NOTE 7 - REVOLVING LINE OF CREDIT**

The Company has a line of credit agreement with Centennial Bank with a maximum borrowing limit of \$3,500,000. Terms for this line of credit include interest on the unpaid balance at the Prime Rate plus 1.0% (8.5% at December 31, 2024). As of December 31, 2024 the balance outstanding on the line was \$2,626,174.

**NOTE 8 - RELATED PARTY TRANSACTIONS**

The Company had accounts receivable due from Nimbus Boats USA LLC, an entity related through common ownership. As of December 31, 2024 the balance due from Nimbus Boats USA LLC was \$807,132.

The Company received cash advances from Nimbus Boats USA LLC. As of December 31, 2024 the balance due to Nimbus Boats USA LLC was \$688,400.

The Company received cash advances from Nimbus Group AB (pub), an entity related through common ownership. As of December 31, 2024 the balance due to Nimbus Group AB (pub) was \$1,949,230.

Total interest paid to these related parties was \$63,460.

**NOTE 9 - FLOOR PLAN NOTES PAYABLE**

Floor plan notes payable are maintained with Yamaha Engine. The notes are secured by inventory and require repayment within thirty days of the sale of such inventory. Interest on the notes is payable monthly beginning thirty days after the purchase at a base rate of prime (7.50% as of December 31, 2024) plus 4.00% for amounts 31 to 180 days old and a base rate of prime plus 8.00% (15.50% as of December 31, 2024) for amounts over 180 days old. At December 31, 2024, total floor plan notes payable were \$719,492.

**NOTE 10 – LEASES**

The Company determines if an arrangement is a lease at inception of the contract. The right of use assets represent the Company's right to use the underlying assets for the lease term and the lease liabilities represent its obligation to make lease payments arising from the leases. Right of use assets and lease liabilities are recognized at commencement date based on the present value of lease payments over the lease term. The Company uses the risk free rate in determining the present value of lease payments.

The operating leases are for real estate and office equipment. The real estate and equipment lease agreements have terms of five years. The Company leased equipment under a two year financing lease arrangement. The Company does not record leases with an initial term of 12 months or less ("short-term leases") in the balance sheet.

The Company has elected the practical expedient that allows lessees to choose to not separate lease and non-lease components by class of underlying asset and are applying this expedient to all relevant asset classes. The Company has also elected the practical expedient package to not reassess at adoption (i) expired or existing contracts for whether they are or contain a lease, (ii) the lease classification of any existing leases, or (iii) initial indirect costs for existing leases.

**NOTE 11 - EMPLOYEE BENEFIT PLAN**

The Company's employees participate in a 401(k) plan sponsored by Nimbus Boats USA, LLC, which covers all eligible employees as defined in the plan document. The Company contributes 100% of the employees' contribution up to 3% of salary, and 50% of the next 2%, not to exceed IRS established limits. Total matching contributions were \$251,430 in 2024.

**NOTE 12 - COMMITMENTS**

The Company has a vendor agreement with Wells Fargo, which was obtained through Wells Fargo's acquisition of GE Commercial Distribution Finance Corporation. Under the agreement, Wells Fargo extends credit to customers of the Company to finance inventory under a floor plan arrangement. If inventory is repossessed by Wells Fargo under actual or constructive receipt, the Company is required to repurchase the inventory at 80%-100% of the initial sale price, dependent on the lapse of time from the sale date.

The Company has a similar arrangement with North Point Financial. Under this agreement, up to three years after the sale date the Company is required to repurchase inventory from the lender at 85%-100% of the sales price, dependent on the amount of time lapsed.

**NOTE 13 – CONTINGENCIES**

No repossessions have taken place under the above agreements within the past five years. In the event a repurchase requirement was to occur, the Company is confident the inventory could be resold to other customers and, therefore, does not believe it has any significant risk related to these agreements.

**NOTE 13 – CONTINGENCIES (Continued)**

The Company entered into a six-year joint marketing agreement with a vendor through June 30, 2021. The agreement called for a total minimum purchase volume of \$30 million, and a minimum of 90% utilization of the vendor’s product within its vessels for sale in the United States. On April 14, 2021, this agreement was extended for an additional six-year term through June 30, 2027. The agreement calls for a total minimum purchase volume of \$35 million, and a minimum of 90% utilization of the vendor’s product within its vessels for sale in the United States. In return, the Company is provided with discounts on its purchasing and a reimbursement of some of its advertising costs.

The Company is or may be involved in various legal actions arising from time to time in the ordinary course of business. The Company intends to vigorously defend against any and all claims asserted against it. The likely outcome, cost of litigation, or the potential loss, if any, cannot be assessed at this time, thus no provisions for such amounts have been made in the accompanying financial statements. Management believes its accrual for warranty costs will sufficiently cover settlement amounts, if and when they materialize.

**NOTE 14 - ACCRUED WARRANTY COSTS**

The Company offers a limited lifetime warranty to the original consumer for the fiberglass portion of each boat. If the vessel is resold, the warranty is limited to three years from the original purchase date. The Company computes its accrued warranty costs based upon historical claims incurred and expected future claims.
