INDEPENDENT AUDITOR'S REPORT

To the Plan administrator and Trustees of

Opinion

We have audited the accompanying financial statements of Aspira Health and Welfare Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and changes in benefit obligations for the years then ended, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

1. DESCRIPTION OF PLAN

The following description of Aspira Health and Welfare Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a contributory defined benefit health and welfare plan established by RA Outdoors, LLC d/b/a Aspira (the Company or Plan sponsor) on January 1, 2022. The Plan sponsor established a trust fund effective June 2, 2022, to serve as a funding vehicle for the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility and Benefits

The Plan provides medical, dental, vision, prescription drugs, life insurance, short-term disability, long-term disability and other fringe benefits. All employees of the Company, including employees who worked under federal contracts covered by the McNamara-O'Hara Service Contract Act (the Act), or any other federal, state or local prevailing wage law, who are regularly scheduled to work at least 30 hours per week are eligible to participate in the Plan on the first day of the month following their date of hire. Effective July 31, 2024, the Plan divested the contracts of employees covered by the Act and those employees are no longer participants of the Plan. Approximately 52% of the Plan's participants were covered under the Act prior to the divestiture.

The benefits are generally reserved for employee coverage, but employees may purchase additional coverage for their spouse and dependents through pre-tax and after-tax deductions as allowable under Internal Revenue Service (IRS) and ERISA rules and regulations. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Self-Insured Benefits

The Plan's medical and prescription drug benefits are self-insured. The claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative services only (ASO) arrangements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by either the Plan's trust or the general assets of the Company. Despite the Plan's utilization of third-party claims processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

The Plan utilizes a pharmacy benefit manager (PBM) which periodically makes refunds to the Plan based on the Plan's actual utilization pattern of specific drugs.

1. DESCRIPTION OF PLAN (Continued)

Fully Insured Benefits

The Plan fully insures all other benefits. The Plan purchases annual insurance contracts for these benefits. Premiums for these benefits are paid to the insurance companies from assets of the Plan's trust or general assets of the Company.

Health Savings Accounts

The Plan provides health care coverage and convenience with Health Savings Accounts (HSA) that participants can use for out-of-pocket medical costs. Contributions to the HSA's totaled \$182,603 and \$242,113, respectively, for the years ended December 31, 2024 and 2023. The activity related to the HSAs is excluded from the Plan's financial statements as the Plan is not obligated to pay the benefits associated with these accounts.

Stop-Loss Coverage

The Plan has entered into a stop-loss insurance arrangement to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims). The Plan's self-insurance retention is \$150,000 for individual losses on a per-person basis.

Contributions

The Plan is funded by employer, employee, and COBRA contributions. In addition to deductibles and copayments, participants contribute specified amounts, determined annually, for coverage of themselves and their dependents. This determination is based on a review of the Plan's payment trends and an estimation of expected costs for the following year, as recommended by an independent third-party specialist.

For employees who were covered under the Act through July 31, 2024, employer contribution rates were established annually by the Plan in accordance with prevailing wage rates and health and welfare rates for employees covered under the Act. The Plan sponsor adjusted the health and welfare contribution rates annually upon renewal or modification of the contract by the federal government. The Plan sponsor provided qualified fringe benefits for each employee covered by the Act up to the statutory limitations. For the years ended December 31, 2024 and 2023, the Act's effective health and welfare contribution rate established by the Department of Labor was \$4.23 per hour through July 2023 and then increased to \$4.41 per hour.

The Plan sponsor may also elect to take premium rebate credits against the required health and welfare contributions for qualified fringe benefits provided by the Company outside of the Plan in meeting the health and welfare contribution rate requirement under the Act and as required for the Plan to meet its obligations to Plan participants and service providers. The Company also contributes excess funds in participant premium reserve accounts, as defined and maintained by the Plan, to a qualified retirement plan established for the benefit of Plan participants.

Contributions (Continued)

The Company makes contributions to the Plan as needed to fund claims in excess of participants' contributions. Any deficiency of the Plan's net assets over benefit obligations is funded by the Company on a pay-as-you-go basis.

Plan Administration and Expenses

Under the Act, employers are required to ensure compliance with the prevailing wage and health and welfare benefit requirements. Accordingly, many employers establish separate trusts or other funded arrangements, which receive and administer the health and welfare contributions. If such contributions are paid to a trust, the trust must preclude the employer from recapturing any of the contributions paid into the trust in meeting the minimum prevailing wage requirement and from diverting any of the funds of the trust for its own benefit or use. The Plan established a trust to satisfy the Act's requirements which effective July 31, 2024 has been dissolved. The Plan is managed by trustees (the Trustees), who are primarily representatives of the Company. The trustees retained the services of a third-party administrator, Government Service Administrators (GSA), that specializes in providing administrative and accounting services for employee benefit plans.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Cash Reserve

The Plan is required to maintain a cash reserve with an insurance company, which is a deposit that can be drawn against to reduce future premium payments when premiums paid to the insurance company exceed the total claims paid and other charges. The cash reserve has been reported as an asset of the Plan until such amounts are used to pay premiums. The reserve is non-forfeitable should the insurance contract terminate.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (US GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, estimated health claims incurred but not reported (IBNR) and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates. Estimates that are particularly susceptible to significant change in the near-term are the liabilities for IBNR. Although it is not possible to measure the degree of variability inherent in these estimates, management believes that the liabilities reported are adequate. Any adjustment determined to be necessary is reflected in current operations.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator and Trustees determine the Plan's valuation policies and procedures utilizing information provided by the custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis.

Concentrations

As of December 31, 2023, the Plan had investments that represented more than 10% of net assets of \$90,818, that were concentrated in one fund.

As of December 31, 2024 and 2023, the Company maintained cash balances at financial institutions in excess of the federally insured limits provided by the Federal Deposit Insurance Corporation (FDIC). The FDIC insures balances up to \$250,000 per depositor, per institution. These uninsured cash balances represent a concentration of credit risk. Management monitors the financial condition of the institutions in which deposits are held and believes the risk of loss is minimal.

Payment of Benefits

Premiums paid by either the Company or the trust are recorded as insurance premium payments in the accompanying statements of changes in net assets available for benefits.

Claim payments are recorded when paid by the third-party claims processors. Amounts due to claims processors that have not been reimbursed by the Plan, if any, are recorded as payables to claims administrators in the accompanying statements of net assets available for benefits.

Experience-rated Contracts

For experience-rated contracts, premium surpluses are recorded as a receivable from the insurance company. To the extent that premium surpluses are attributable to premiums paid by the Company, a payable to the Company is also recorded for surplus amounts attributable to Company-paid coverage.

If the insurance company requires payment of additional premiums due to a premium deficit, an obligation for the additional premiums is included in benefit obligations. If the deficit relates to Company-paid coverage, a receivable from the Company is also recorded. Periodically, a premium deficit is due related to participant-funded coverage, but the trust is unable to pay the entire amount. In this case, the Company pays the difference to the insurance company and a receivable from the Company is recorded.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Stop-Loss Insurance

Premiums for stop-loss insurance are included in insurance premiums paid in the accompanying statements of changes in net assets available for benefits. Stop-loss refunds totaling \$12,133 and \$461,820, respectively, were received for the years ending December 31, 2024 and 2023 and are netted with self-insured claims paid, net in the accompanying statements of changes in net assets available for benefits.

Rebates

Rebates due from the Plan's PBM are recorded when known and earned, with the offset against health and prescription drug benefits. Pharmacy rebates owed to the Plan as of December 31, 2024 and 2023 totaled \$44,741 and \$44,130, respectively, and have been included in receivables in the accompanying statements of net assets available for benefits. Pharmacy rebates totaling \$307,451 and \$341,022, respectively, have been netted with self-insured claims paid, net in the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.

Subrogation and medical refunds are recorded when received. Subrogation and medical refunds are netted with self-insured claims paid, net in the accompanying statements of changes in net assets available for benefits.

Benefit Obligations

Claims incurred but not yet reported are estimated by the Plan's benefit broker based on claims data provided by the Plan's self-insured claims administrator. This analysis and estimate is determined using a historical analysis of claims paid subsequent to year end as well as subsequent benefit payments actually made, classified according to the date that the related services were provided.

Where required, the Plan maintains accounts for each participant who worked on contracts covered by the Act. Any "accrued premium reserve" would be reported in the accompanying statements of benefit obligations and represents the unexpended contributions remaining in the participants' premium reserve accounts.

3. CASH RESERVE

Cigna, the self-insured medical claims administrator of the Plan, requires a cash reserve account to be maintained with them in an amount sufficient to fund Plan benefits, fees and charges when due. This amount was determined to be \$47,429 and \$138,448, respectively, as of December 31, 2024 and 2023, and is included in the cash reserve total on the statements of net assets available for benefits. The cash reserve requirement will be periodically reviewed and adjusted by Cigna, as deemed necessary.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Topic 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.
- Level 2: Inputs to the valuation methodology other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:
- a. Quoted prices for similar assets or liabilities in active markets,
 - b. Quoted prices for identical or similar assets or liabilities in inactive markets,
 - c. Inputs other than quoted prices that are observable for the asset or liability,
 - d. Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full-term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There were no changes in the methodology used at December 31, 2023.

Money market mutual fund: Valued at the daily closing price as reported by the fund. The mutual fund held by the Plan is open-ended mutual funds and is registered with the U.S. Securities and Exchange Commission. This fund is required to publish their daily net asset value and to transact at that price. The mutual fund held by the Plan is deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan sponsor has the right under the Plan to modify or discontinue any terms, conditions, or benefits of the Plan at any time and terminate the Plan subject to the provisions of ERISA, the insurer's contract, and the contract administration agreement. Expenses incurred prior to a termination, modification, or amendment of the Plan would be paid as provided under the terms of the Plan prior to its termination, modification, or amendment. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

6. ACCRUED PREMIUM RESERVE AND REBATES

The accrued premium reserve represents the unexpended balance in the participant accounts from contributions made at the prevailing health and welfare contribution rates established under the Act, less the benefit premiums, retirement plan allocations, and other benefit payments made on behalf of the participants. Amounts remaining in the participant premium reserve accounts at termination of employment are generally used to fund benefits or are contributed by the Company to a qualified retirement plan for the benefit of the participants. Any premium rebate credits unpaid as of the end of the reporting period are reflected as an accrued premium rebate liability. As of December 31, 2023, the Plan reported an accrued premium rebate liability of \$2,825 which is included in liabilities in the accompanying statements of net assets available for benefits. The Plan did not report any accrued premium reserve liability as of December 31, 2024.

7. PARTY-IN-INTEREST TRANSACTIONS

Cigna and Express Scripts (through December 31, 2023) are the self-insured claims administrators of the Plan and Cigna maintains the Plan's cash reserve account. GSA is the Plan's third-party administrator. Therefore, transactions with these parties qualify as party-in-interest transactions. The Plan paid fees to Cigna, and GSA related to administrative services rendered for the years ended December 31, 2024 and 2023.

The Plan's investment was managed by Wilmington Trust, NA, the custodian; therefore, these transactions qualified as party-in-interest.

Certain administrative functions are performed by officers or employees of the Plan sponsor. No such officers or employees receive compensation from the Plan.

8. TAX STATUS

The trust established under the Plan to hold the Plan's assets has not applied for exemption from federal or state income taxes. The Plan is required to pay federal and state taxes on unrelated business income as defined by the Internal Revenue Code (IRC). Unrelated business income consists of investment income earned on the excess of the net assets available for plan benefits over the required reserve balance allowable under the IRC. The Plan sponsor believes the Plan does not have any net taxable income for the years ended December 31, 2024 and 2023; therefore, no tax liability is reflected in these financial statements.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

Claims and premiums that have been processed and approved for payment at year end, but not paid and claims incurred but not reported are not considered liabilities under US GAAP and, therefore, are not presented as liabilities or claims and premiums paid in the accompanying financial statements but are recorded on the Form 5500 as a liability.

10. RISKS AND UNCERTAINTIES

The Plan is subject to various risks and uncertainties that may affect its ability to provide benefits to participants. These include changes in healthcare regulations, fluctuations in healthcare costs, demographic shifts in the covered population, and potential changes in employer contributions or plan design. Although the Plan does not currently hold any investments, it remains exposed to operational and external factors that could impact future funding requirements and benefit obligations. Plan management monitors these risks and works with advisors and service providers to mitigate potential adverse effects.

11. SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 24, 2025, which was the date that these financial statements were available for issuance and determined that there were no significant nonrecognized subsequent events through that date.
