(1) Description of Plan

The following description of the i3 Technology Group, LLC 401k (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

(a) General

The Plan was established on January 1, 2022 and is a defined contribution plan covering all employees of i3 Technology Group, LLC (Company or Plan Sponsor). Prior to January 2022, employees of the Company were eligible to participate in Georgian Bay 401(k) Plan, a plan controlled by a related party of the Company. In January 2022, \$15,006,724 of assets were transferred to the Plan from the Georgian Bay 401(k) plan.

Employees become eligible to make elective deferrals to the Plan after completing one month of service and attaining 18 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

(b) Contributions

Participants may make elective deferrals of a minimum of 1% of eligible compensation up to the annual Internal Revenue Service (IRS) contribution limit of pretax annual compensation, as defined by the Plan agreement. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into investment options offered by the Plan, which include a common collective trust fund and various mutual funds.

The Company contributes a 100% match of the participant's contributions up to 3% of the participant's compensation for all eligible participants, plus 50% of the participant's contributions up to the next 2% of the participant's compensation, for a maximum total of 4% employer match. Employer matching contributions amounted to \$336,334 and \$421,651 for the years ended December 31, 2023 and 2022, respectively.

(b) Contributions, Continued

The Company may also elect to make discretionary non-elective contributions on an annual basis, based on a participant group allocation formula. All active participants are eligible for discretionary non-elective contributions. The Company will allocate discretionary contribution amounts based on years of service and projected retirement age to eligible participants. The Company did not make any discretionary non-elective contributions for the year ended December 31, 2023 and 2022.

(c) Participant Accounts

Each participant's account is credited with the participant's contribution and Company discretionary contributions, as well as allocations of Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(d) Vesting

Participants are vested immediately in their contributions and employer matching contributions plus actual earnings thereon. Vesting in the discretionary employer's contribution portion of participant accounts is based on years of continuous service and is as follows:

(e) Payment of Benefits

On termination of service due to death, disability, retirement or other reasons, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account.

(f) Forfeited Accounts

At December 31, 2023 and 2022, there were no forfeited nonvested accounts. Forfeited accounts may be used to reduce future employer contributions.

(g) Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rates range from 3.25% to 8.50%, which is fixed based on the prime rate at the date of the loan request. Principal and interest are paid ratably through payroll deductions.

(2) Summary of Significant Accounting Policies

(a) Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

(b) Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(c) Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the custodian. See note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(2) Summary of Significant Accounting Policies, Continued

(d) Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

(e) Payment of Benefits

Benefits are recorded when paid.

(f) Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

(g) Subsequent Events

The Plan has evaluated subsequent events through August 26, 2025 the date the financial statements were available to be issued.

(3) Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies during 2023 and 2022.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust fund: Valued at the NAV of a bank collective trust. The NAV, as provided by the trustees, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trusts, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

(4) Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA -required supplementary schedule, including investments and cash held at December 31, 2023 and 2022, and interest and dividends for the years ended December 31, 2023 and 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by NBT Bank, the custodian of the Plan.

(5) Party-in-Interest Transactions

All Plan investments are managed by NBT Bank. NBT Bank is the custodian for the Plan. The Plan issues notes receivable to participants, which are secured by the balances in the participants' accounts. Therefore, related transactions qualify as party-in-interest transactions. Fees paid out of Plan assets to the custodian were \$20,989 and \$18,622 for the years ended December 31, 2023 and 2022, respectively. The Plan sponsor pays directly any other fees related to the Plan's operations.

(6) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

(7) Tax Status

The Plan and trust have been established using a prototype plan designed and maintained by the Plan's third party administrator, in accordance with applicable requirements of the IRC. The prototype plan received a determination letter from the IRS dated June 30, 2020. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's advisor believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(8) Risks and Uncertainties

The Plan invests in various investment securities. Investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
