The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Note A - Description of Plan

The following description of David Lawrence Mental Health Center, Inc. 401(k) Plan (“the Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a 401(k) defined-contribution plan and is intended to provide participants with future retirement benefits for those who may qualify for participation therein. The Plan covers all eligible employees of David Lawrence Mental Health Center, Inc. (the “Organization”). Employees become eligible to participate in the Plan after attaining the age of 21, and completing sixty days of service, as defined in the Plan Document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Plan Administration

The management and administration of the Plan is the responsibility of David Lawrence Mental Health Center, Inc. as Plan Sponsor. The Organization utilizes Fidelity Management Trust Company as the trustee and record keeper of all the Plan’s assets including substantially all the responsibility for investment, reinvestment, control and disbursement of the funds of the Plan.

Contributions

Each year, participants may contribute up to the maximum percentage of allowable compensation, as defined in the Plan Document. Participants may also contribute amounts representing distributions (rollovers) from other qualified plans. Participants who have attained age 50 before the end of the Plan year are eligible to make catch up contributions.

The Organization may make a matching contribution for participating employees based on a percentage of the employee contributions. The Organization matches employee contributions, based on a percentage ranging from 5% to 7% of qualified employee compensation and years of service. A participant is not eligible to receive matching contributions until one year from the date of hire or 1,000 hours. The Plan also allows for a discretionary profit-sharing contribution if authorized by the Organization’s board of directors. In order for a participant to share in any discretionary profit-sharing contributions, they must be employed on the last day of the Plan year, have worked 1,000 hours unless termination is due to death, disability, or retirement. There were no discretionary profit sharing contributions for the years ended December 31, 2024 and 2023.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, allocations of the Plan’s earnings, and Organization contributions, and charged with benefit payments and allocations of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. The portion of the participant’s account attributable to employer matching and discretionary contributions vests 20% after one year credited service, increasing 20% each of the following year, until 100% vested after five years of service. Participant accounts become fully vested upon retirement, death, or disability regardless of years of service.

Investment Options

Upon enrolling in the Plan, a participant may select investments in various mutual funds and an insurance company fixed interest account. Participants may make changes in their investment elections at any time.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested balance. Principal and interest is paid ratably through payroll deductions. Note terms for notes under \$2,000 are three years and up to five years for all others. An exception can be made for notes to fund the purchase of a principal residence, for which the note may be repaid over a reasonable period that may exceed five years but not more than fifteen years. Note transactions are treated as a transfer to (from) the investment fund from (to) the participant note fund. The notes are secured by the balance in the participant's account and bear interest at Prime plus 1%.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's vest interest in his or her account in either a lump-sum amount or various installment and annuity options as provided by the Plan. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. In-service withdrawals may occur upon demonstration of financial hardship, or after the participants reach age of 59.5 years. If a participant terminates employment and has a vested account balance less than \$5,000, the Plan Administrator will authorize the benefit payment without the participant's consent.

Forfeited Accounts

Forfeitures are used to pay certain administrative expenses or to reduce the employer contribution requirements. There were \$38,034 used to reduce employer contributions for the year ended December 31, 2024. Forfeited non-vested accounts as of December 31, 2024 totaled \$7,790.

Note B - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's assets are primarily invested in mutual funds managed by Fidelity Management Trust Company. Investments are reported at fair value. Fair value of a financial instrument is the provide that would be received when selling an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Changes in fair value, along with realized gain and losses, are reflected as net appreciation (depreciation) in fair value of investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024, and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expense of maintaining the Plan is paid by the Plan or the Organization as provided by the Plan document, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expense is included in net appreciation of fair value of investments. Certain administrative functions are performed by employees of the Organization. No such employee receives compensation from the Plan.

Note C - Investments

Unaudited Information Certified by the Plan Custodian

The December 31, 2024 and 2023 Statements of Net Assets Available for Benefits, the investment activities included on the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, and the accompanying notes to the financial statements were prepared in part or entirely from information certified by the custodian in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The Plan's investments were held in custodial accounts maintained by Fidelity Management Trust Company for the years ended December 31, 2024 and 2023. The Plan administrator obtained a certification from the custodian as of December 31, 2024 and 2023 years ended from Fidelity Management Trust Company. The information certified includes total investments of \$14,168,544 and \$12,030,821 as of December 31, 2024 and 2023, respectively, and related total net investment income of \$1,565,312 for the year ended December 31, 2024.

Note D - Fair Value Measurements

FASB ASC Topic 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of value hierarchy under FASB ASC Topic 820 are described as follows:

Level 1 Fair Value Measurements

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Fair Value Measurements

Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are delivered principally from or corroborated by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Fair Value Measurements

Inputs to the valuation methodology are unobservable and significant to the fair value measurements.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used to maximize the use of observable inputs and minimize the use of unobservable measurements.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered Investment Companies: Valued at the daily closing price as reported by the fund. Registered Investment Companies held by the Plan are open-ended funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded and are reported as level 1.

Note E - Investment at Contract Value

The Plan offers the Lincoln Stable Value Fund as an investment option. The Lincoln Stable Value Fund seeks to preserve principal while providing a stable return over time. The fund is primarily composed of a diversified portfolio of fixed-income securities and investment contracts, including wrap agreements with financial institutions, designed to provide for benefit-responsive withdrawals by participants.

The fund is held in custody by Fidelity Management Trust Company. Fidelity, as custodian, maintains the assets of the fund and executes transactions on behalf of the Plan. The crediting rate for the Lincoln Stable Value Fund is based on the performance of the underlying investments, adjusted for fees and the terms of the wrapper contracts.

Investments in the Lincoln Stable Value Fund are reported at contract value, which is the relevant measurement attribute for fully benefit-responsive investment contracts. Contract value represents contributions plus credited earnings, less participant withdrawals and administrative expenses. Under most circumstances, participants transact at contract value. However, certain events (such as Plan termination, a significant Plan amendment, or Plan sponsor bankruptcy) may limit the ability of the Plan to transact at contract value. The Plan administrator does not believe that such events are probable.

The average crediting rates for the Lincoln Stable Value Fund were 2.94% at December 31, 2024 and 3.00% at December 31, 2023.

Note F - Plan Termination

Although it has not expressed any intent to do so, the Employer reserves the right at any time to amend, modify, or terminate the Plan without the consent of any participant or beneficiary, subject to the provisions of ERISA. In the event of such termination, the Plan document provides that the participants will become 100% vested in their account balances.

Note G - Income Tax Status

The Plan adopted a prototype submitter profit sharing plan sponsored by FMR, LLC doing business as Fidelity Investments which received a favorable opinion letter from the IRS on June 30, 2020, which stated that the prototype submitter profit sharing plan is designed in accordance with applicable sections of the IRC. The Plan has not received a determination letter specific to the Plan itself, and the Plan has been amended since receiving the opinion letter. However, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to business income tax and, therefore, the Plan and related trust continue to be tax-exempt. Required nondiscrimination testing, as applicable, has been completed for the Plan, and any excess deferrals or contributions have been disposed of in accordance with regulations.

Note H - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

Note I - Related Party and Party-In-Interest Transactions

Certain Plan investments and the related transactions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, were in investments managed by the Custodian; therefore, these investments and transactions qualify as party-in-interest transactions. Fees paid during the year for accounting and other services rendered by parties-in-interest were based on customary and reasonable rates for such services. Notes receivable from participants also qualify as party-in-interest transactions.

Note J - Plan Amendments

The Plan was amended for the following provision:

- Effective January 1, 2025, an Automatic Contribution Arrangement was added to the Plan which will automatically contribute 2% of an employee's eligible compensation to his or her pre-tax elective deferral contribution account for Participants who have not affirmatively elected a salary deferral as of the effective date of the amendment.

Note K - Subsequent Events

Subsequent events have been evaluated through October 08, 2025, the date the financial statements are available to be issued.
