INDEPENDENT AUDITOR'S REPORT

To the Retirement Committee and participants of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Perkins + Will, Inc. Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements (the financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section of the report,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

1. Description of the Plan

The following description of the Perkins + Will, Inc. Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document, copies of which are available from the Plan administrator, for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering employees of Perkins + Will, Inc. (the Company) who are age 21 or older. The Plan does not cover those employees who are members of a collective bargaining agreement, nonresident aliens, leased employees, or temporary employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

During 2024, the Company acquired Health Architecture LLC dba HYL Architecture. The employees of that company became eligible to participate in the Plan on January 1, 2025. On March 7, 2025, a qualified retirement benefit plan sponsored by Health Architecture LLC transferred approximately \$2,400,000 of assets into the Plan.

Contributions

Participants may elect to contribute pre-tax and/or Roth contributions of up to 100% of eligible compensation, as defined by the Plan document, and includes post-severance pay, not to exceed a maximum of \$23,000 in 2024, plus catch-up contributions of \$7,500 for those participants who have attained age 50. Eligible employees are automatically enrolled at 6% of their eligible compensation, unless they elect otherwise. Participants may also elect to contribute on an after-tax basis.

Once an employee is enrolled, the deferral percentage will automatically increase by 1% increments on April 1st of each year up to 15%, unless the participant elects otherwise. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Company may make a discretionary matching contribution to participant accounts. During 2024, the Company elected to match a participant's elective deferrals up to a maximum of 67% of 6% of the participant's total eligible compensation, subject to IRS limits. The Company may also make a discretionary profit-sharing contribution. The Company elected not to make a discretionary profit-sharing contribution in 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution, rollovers, the Company's matching contribution, earnings and losses on the investments in their account and an allocation of the Company's profit-sharing contribution, if any, and is charged with certain administrative expenses. Participants direct the investment of their account into investment options offered by the Plan. The Plan also offers a self-directed brokerage account as an additional investment option for participants. Participants may change their investment options on a daily basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Company discretionary matching and profit-sharing contributions and the earnings thereon vest 20% per year and are fully vested after 5 years of service in which the employee is credited with at least 1,000 hours of service in each calendar year. The Plan allows new participants who joined the Plan due to acquisitions made by the Plan sponsor to carry over prior service credit earned at predecessor employers when determining vesting calculations for these participants.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$463,733 and \$360,592, respectively. These accounts can be used to reduce future Company contributions to the Plan or pay administrative expenses. During 2025, the Plan used \$463,734 of forfeitures to reduce 2024 employer contributions remitted subsequent to year end. During 2024, the Plan used \$411,803 of forfeitures to reduce 2023 employer contributions.

Notes Receivable from Participants

A participant may have two notes outstanding at any time, each subject to certain monetary limits. The notes are secured by the balance in the participant's account and must bear a reasonable rate of interest as defined in the Plan document. During 2024, notes had fixed rates ranging from 4.25% to 9.50% for the term of the notes, not to exceed 5 years, or 15 years if used for the purchase of a residence. Principal and interest are paid through payroll deductions.

Payment of Benefits

On termination of service due to death, disability, termination of employment or retirement, a participant or their beneficiary may elect to receive payment of the vested interest in their account in a lump-sum distribution or annuity payments. The participant may also receive a distribution for certain hardship situations. If a participant terminates employment and has an account balance less than \$7,000, then the participant will automatically receive a lump sum payment equal to the value of their account.

Administrative Expenses

The Plan allows for payment of Plan expenses to be made from the Plan's assets which will generally be allocated among the accounts of all participants in the Plan proportionately based on the value of the account balances. Advisory service charges and recordkeeping fees are paid to service providers of the Plan and qualify as party-in-interest transactions. Fees to obtain a participant loan are charged to that participant.

During 2024, the Company paid certain administrative expenses for the Plan, including legal and accounting fees and the Plan paid fees for recordkeeping, trust, administrative services, and investment management services. The Company does not expect reimbursement from the Plan for any expenses paid on behalf of the Plan.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Contributions

Participant contributions are considered payable to the Plan upon the withholding of contributions from the participant's paycheck. The employer discretionary matching contributions are considered payable to the Plan when the related participant's contributions are payable to the Plan. Profit-sharing contributions are considered payable to the Plan when declared. Any unfunded participant or employer discretionary matching contributions are included in the participant or employer contributions receivable on the statements of net assets available for benefits as of December 31, 2024 and 2023.

Valuation of Investments and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Net change in fair value of investments includes realized and unrealized gains and losses on investments and interest and dividends. Interest income is recorded when received.

Notes Receivable from Participants

Notes receivable from participants are carried at their outstanding balance. Interest income is recognized when received by the Plan. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make note repayments and the Plan administrator deems the participant note to be in default, the participant note balance is reduced and a benefit payment is recorded. Notes receivable from participants also qualify as party-in-interest transactions.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through August 1, 2025, which is the date the financial statements were available to be issued.

3. Information Certified by the Qualified Institution

All information in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants as of December 31, 2024 and 2023 and net change in fair value and interest income for the year ended December 31, 2024 was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Charles Schwab Trust Bank (Schwab), the Plan's qualified institution.

4. Fair Value Measurements

As of December 31, 2024 and 2023, the Plan investments include shares of mutual funds, and a money market fund managed by Schwab. In 2023, the investments also included common/collective trusts. Schwab is the qualified institution for the Plan; therefore, transactions in the investments qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net change in fair value as they are paid through revenue sharing, rather than a direct payment.

Investments are exposed to various risks, such as market, currency, interest rate, and credit risks. Market risks include U.S. and global events which could impact the value of Plan investments. Such events would include healthcare crises, such as a pandemic, international conflicts, supply chain disruptions, global monetary policy decisions, significant exogenous economic influences, and significant cybersecurity attacks. It is at least reasonably possible that changes in their fair value will occur in the near term and that such changes could materially affect participants' account balances.

The Financial Accounting Standards Board established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into three levels. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities, and the lowest priority to unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 – unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access

Level 2 – other observable data, including quoted prices for identical assets in inactive markets

Level 3 – unobservable inputs

Observable inputs are those based on market data obtained from sources independent of the Plan, and unobservable inputs reflect the Plan's own assumptions based on the best information available. The input levels are not necessarily an indication of the risk or liquidity associated with financial instruments at that level but rather the degree of judgment used in determining those values.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Investments in mutual funds and the money market fund are stated at quoted market prices for the identical security in an active market (Level 1).

Investments in common/collective trust funds are valued daily using net asset value (NAV). The NAVs are based on quoted prices determined daily based on the fair value of the mutual funds, stocks, debt instruments, and other securities in the accounts. The common/collective trust funds may be traded daily at their NAV (Level 1).

The Plan invests in the Galliard Retirement Income Fund held in the Wells Fargo Synthetic Stable Value Fund. The stable value fund invests in security-backed contracts which include fully benefit-responsive guaranteed investment contracts (GICs), which are general obligations of the insurance companies that issue the contracts, as well as synthetic GICs and a short-term investment fund. These investment contracts are backed by a portfolio of bonds. The stable value fund trades daily at the NAV which is based on the contract value, which approximates fair value, of the underlying investments (Level 1).

Investments in the self-directed brokerage accounts include mutual funds, common stock, unit investment trusts, US government securities, REIT's, and interest-bearing cash. All assets are traded through a broker and are considered Level 1 assets except U.S. Government securities. U.S. government securities are government backed obligations that are valued based on yields

currently available on comparable securities of issuers with similar credit ratings. Purchases and sales of securities are recorded on a trade-date basis. These securities are considered Level 2 assets.

5. Income Tax Status

The Plan is a prototype plan created by Schwab Retirement Plan Services, Inc. (Schwab Retirement), an affiliate of Schwab, the qualified institution. The Internal Revenue Service has determined and informed Schwab Retirement by a letter dated September 21, 2020, that the prototype is designed in accordance with applicable sections of the Internal Revenue Code (the Code). Although the Plan has not received an individual determination letter and has been amended, the plan administrator believes that the Plan is designed and operated in compliance with the applicable requirements of the Code and has no income subject to unrelated business income tax. The Plan's income tax returns for the past three years are subject to examination by taxing authorities and may change upon examination.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their accounts.
