I am writing regarding the late filing of Form 5500 for the plan year ending in 2024. I respectfully request that any penalties associated with the late filing be waived due to reasonable cause.

The delay was not the result of willful neglect but occurred due to a miscommunication between our company and ADP RUN regarding the filing requirements. In addition, the primary contact who receives notifications about the filing status was absent and out of office prior to the deadline due to a personal injury and was unable to forward the communications for timely action.

As soon as we became aware of the oversight, we took prompt steps to file the form and bring the plan into full compliance. We have since implemented additional internal controls to ensure that all future filings are completed accurately and on time in accordance with IRS regulations.

We remain committed to maintaining the integrity of our retirement plan and fulfilling all responsibilities as a plan sponsor. In light of the above, and pursuant to the IRS's authority to waive penalties when a failure is due to reasonable cause and not willful neglect, we kindly request a waiver of any penalties associated with this late filing.
