Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audits of the financial statements of KBRA Holdings, LLC 401(k) Profit Sharing Plan Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor ("DOL")'s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained a certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the KBRA Holdings, LLC (the “Company” or “Employer”) 401(k) Profit Sharing Plan Trust (the “Plan”) is provided for general information only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all full-time employees of the Company who have performed at least one month of service (as defined by the Plan document) and are age 21 or older. The Plan was established effective January 1, 2020. The Plan is currently designed to be qualified under the applicable requirements of the Internal Revenue Code (“IRC”) and the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan was amended and restated effective January 1, 2024 to include the most recent regulations.

Plan Administration

The Company is the administrator of the Plan and, as such, carries out the duties imposed by ERISA. The Company has appointed the Administrative Committee to oversee the operation and administration of the Plan. Ascensus Trust Company and Newport Trust Company LLC. (“Ascensus” or the “Trustee”) are the Trustee of the Plan’s assets and Ascensus, LLC provides recordkeeping services as subcontracted by Vanguard.

Contributions

Each year, participants may contribute to the Plan up to 100% of compensation on a pre-tax basis, with dollar limits established by the IRC. Employer matching and profit sharing contributions are discretionary. For 2024, Employer matching contribution is 100% of the first 6% of an employee’s total eligible compensation for each employee who made a pre-tax deferral or a Roth deferral Plan during the year, worked 1,000 hours during the Plan year, and was still employed on the last day of the Plan year. For the year ended December 31, 2024, the employer discretionary matching contributions totaled \$4,590,622. There were no profit sharing contributions for 2024.

Participant Accounts

Each participant’s account is credited with the participant’s contribution, the Employer’s contribution, if any, and an allocation of the Plan investment results. Allocations of the earnings or losses are based on participant’s account balances. The benefit to which a participant is entitled is the participant’s vested account balance.

Vesting

Participants are immediately vested in their contributions and Employer contributions plus actual earnings thereon.

Investment Options

Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may change their contribution investment options daily and may transfer part or all of past investments to other investment options daily. Participants may elect to change their salary deferrals on a daily basis.

Notes Receivable from Participants

The Plan permits participants to borrow a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balances or \$50,000. All loans are secured by the borrowing participant's vested account balance. The loans may be repaid through payroll deductions over the period of the loan. The interest rate for monies borrowed is equal to the Prime rate (7.50% and 8.50% as of December 31, 2024 and 2023, respectively) plus 1%. As of December 31, 2024, notes receivable from participants had maturities through August 2029 at interest rates ranging from 4.25% to 9.50%. The Plan permits participants to have a maximum of 2 loans outstanding at any given time.

Deemed Distributions

When a participant fails to make loan repayments under the terms of the loan agreement, the loan is considered to be in default. Deemed distributions on defaulted loans are recorded when the loan was defaulted. These amounts are no longer included in net assets available for benefits and are recorded as benefits paid to participants. There were no deemed distributions for the year ended December 31, 2024.

Hardship and In-Service Withdrawals

Plan participants may take hardship withdrawals from the vested portion of their account. The distribution is limited to the amount necessary to meet the financial need created by the hardship. Participants may withdraw all or a portion of any rollover contributions, plus earnings thereon, for any reason. Participants who have reached age 59 ½ may withdraw all or a portion of the vested portion of their account for any reason.

Benefit Payments

Upon termination of service due to death, disability, termination or retirement, the vested interest of the account balance is payable to the participant (or beneficiary, if participant is deceased). The form of payment available includes partial payments, single lump-sum payments or a direct rollover distribution into an eligible retirement plan. As of December 31, 2024, all employees who elected to withdraw from the Plan had been paid.

Expenses of the Plan

Certain expenses, including recordkeeping fees, investment advisory fees, and fees for participants' withdrawals, are generally paid out of the Plan assets; however, the Company may elect to pay expenses. Investment-related fees are included in the net appreciation in fair value of investments. In 2024, audit fees and investment advisory fees were paid by the Plan sponsor.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements are prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets available for benefits and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

All Plan investments are held by the Trustee. The Plan's investments are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (see Note 4 for discussion of fair value measurements).

Security transactions are accounted for on the trade-date basis. Dividend income is accrued on the ex-dividend date. Interest income is recorded on the accrual basis. Net realized and unrealized appreciation/depreciation is recorded in the accompanying statement of changes in net assets available for benefits as net depreciation in fair value of investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses is recorded as of December 31, 2024 and 2023, as the notes are collateralized by the participant's account balance. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. At December 31, 2024, there were no deemed distributions.

Participant and Employer Contributions

Participant and Employer contributions are included in additions to net assets during the period in which the Employer records the related liabilities.

Payment of Benefits

Benefits are recorded when paid.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events

The Plan has evaluated subsequent events for recognition or disclosure through the date these financial statements were available for issuance, October 15, 2025.

NOTE 3 – INFORMATION CERTIFIED BY THE TRUSTEE

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor (“DOL”)’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ascensus, LLC, an agent for the Trustees of the Plan has certified to the completeness and accuracy of:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023;
- Net appreciation in the fair value of the investments, dividend and interest and interest income on notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024; and
- Investments reflected on the schedule of assets (held at end of year) as of December 31, 2024.

NOTE 4 – FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board (“FASB”) established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: The Plan’s mutual funds are traded in active markets. The Plan’s principal markets for these investments are the NYSE and the NASDAQ Stock Exchange. Accordingly, the mutual funds are considered Level 1 assets and are carried at their quoted market values, or net asset value (“NAV”) of shares held by the Plan at year-end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 – INVESTMENTS, AT CONTRACT VALUE

The Plan held investments in the Empower Guaranteed Income Fund (“Empower”) and the Prudential Retirement and Insurance Annuity Company (“Prudential”) Guaranteed Income Fund at December 31, 2024 and 2023, respectively. These investments are fully benefit-responsive traditional investment contracts with Empower and Prudential. As of December 31, 2024 and 2023, the fair value of the investments was \$2,028,960 and \$2,964,023, respectively.

Empower accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and specified interest rate that is guaranteed to the Plan. Interest is credited on contract balances using a “single portfolio rate” approach. Under this methodology, a single interest rate is applied to all contributions made to the fund, regardless of the timing of those contributions. The guaranteed minimum interest rate under the contract is 1.50%.

Prudential maintained the contributions in a general account, which was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Prudential may not terminate the contract at any amount less than contract value. Prudential is contractually obligated to pay the principal and specified interest rate that is guaranteed to the Plan. The guaranteed interest rate is announced in advance and is guaranteed for a six-month period. The Plan may terminate the contract at any time subject to a market value adjustment as specified in the contract, however, under certain emergency conditions, the issuer may defer payment for a period of up to 365 days. Additionally, the Plan may also terminate the contract without a market value adjustment by making withdrawals of the entire amount over a four-year period.

Because the guaranteed interest contract is fully benefit-responsive, contract value is the relevant measurement attribute. Contract value, as reported to the Plan by Prudential, represents contributions made under the contract, plus earnings, minus participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events may limit the ability of the Plan to transact at contract value with Prudential. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal for the Plan, or (4) the failure of the trust to qualify for exemption under ERISA. The Plan Administrator does not believe that the occurrence of any such events, which would limit the Plan's ability to transact at contract value with participants, is probable.

NOTE 6 – EXEMPT PARTY-IN-INTEREST

At December 31, 2024, certain Plan investments were managed by Vanguard, an affiliate of the recordkeeper, and therefore, these transactions qualify as party-in-interest transactions. Administrative fees paid by the Plan to the Vanguard totaled \$52,840 for the year ended December 31, 2024. Notes receivable from participants also qualify as party-in-interest transactions.

NOTE 7 – PLAN TERMINATION

Although it has not expressed any intention to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

NOTE 8 – TAX STATUS

The Company adopted a Non-Standardized Prototype Profit Sharing Plan, sponsored by Ascensus LLC. The Internal Revenue Service has issued a favorable opinion letter dated June 30, 2020 on the prototype plan that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving the determination letter, however, the Plan Administrator believes that the Plan is designed and is being operated in compliance with the applicable provisions of the IRC, and accordingly no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the DOL.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.
