## **INDEPENDENT AUDITORS' REPORT**

To the Participants and Plan Administrator of  
Service Pros Installation Group 401(k) Plan:

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Service Pros Installation Group 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

### A. DESCRIPTION OF THE PLAN

The following description of the Service Pros Installation Group 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General.** The Plan is a defined contribution plan covering substantially all of the employees of Service Pros Installation Group, Inc. and its affiliate, Preferred Carpet One Inc. dba Preferred Floor and Tile Co., (collectively, the “Company”), who have completed one year of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Board of Trustees is responsible for the oversight of the Plan. The Investment Committee determines the appropriateness of the Plan’s investment offerings, monitors investment performance, and reports to the Plan’s Board of Trustees.

**Contributions.** Each year, Participants may contribute up to 90% of annual compensation as pre-tax contributions, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make additional catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit and defined contribution plans (“rollover”).

The Company will make safe-harbor matching contribution equal to 100% of the first 3% of a Participant’s salary deferral plus 50% of the next 2% of a Participant’s salary deferral. The Company made matching contributions of \$369,435 for the year ended December 31, 2024. The Company also makes discretionary matching and profit-sharing contributions at the option of the Company’s Board of Directors. The Company did not elect to make any discretionary contribution for the year ended December 31, 2024.

Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain IRS limitations.

**Participant Accounts.** Each Participant’s account is credited with the Participant’s contributions and allocations of the Company’s contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on Participant earnings, account balances, or specific Participant transactions, as defined. The benefit to which a Participant is entitled is the benefit that can be provided from the Participant’s vested account.

**Vesting.** Participants are vested immediately in their contributions, the Company’s safe harbor matching contributions, plus actual earnings on those contributions. The Company’s discretionary matching and profit-sharing contributions are vest on a graded schedule based on years of continuous service. Participants are 100% vested after six years of continuous service.

**Notes Receivable from Participants.** Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the Participant's account. The loan interest rates, as determined by the Plan Administrator, range from 10.00% to 10.50%. Principal and interest are paid ratably through payroll deductions.

**Payment of Benefits.** On termination of service due to death, disability, retirement, or proven financial hardship, a Participant may elect to receive a lump-sum amount equal to the value of the Participant's vested interest in his or her account, as specified in the Plan document. For termination of service for other reasons, a Participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

A Participant may also request a withdrawal upon demonstration by the Participant to the Plan Administrator that the Participant is suffering from "hardship". Hardship is defined in applicable regulations promulgated or to be promulgated pursuant to Section 401(k) of the Internal Revenue Code or standards established by the Secretary of the Treasury or his delegate.

**Forfeited Accounts.** As of December 31, 2024 and 2023, forfeited, non-vested accounts totaled \$6,957 and \$4,708, respectively. These accounts will be used to reduce future employer contributions and administrative expenses. During 2024, employer contributions were reduced by \$0 and administrative expenses by \$0 from forfeited, non-vested accounts.

### B. SUMMARY OF ACCOUNTING POLICIES

**Basis of Accounting.** The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates.** The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition.** Investments are valued at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and the insurance company. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Contributions.** Contributions from Participants and the matching/additional contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation or the Participant compensation is earned, respectively.

**Notes Receivable from Participants.** Notes receivable from Participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent Participant loans are recorded as distributions on the basis of the terms of the Plan Agreement.

**Excess Contributions Payable.** Amounts payable to Participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan had no excess contributions for the year ended December 31, 2024.

**Payment of Benefits.** Benefits are recorded when paid.

**Administrative Expenses.** Certain expenses of maintaining the Plan are paid directly by the Plan, unless otherwise paid by the Company. Expenses paid by the Plan are excluded from these financial statements. Investment-related expenses are included in the net appreciation (depreciation) of the fair value of investments.

**SECURE Act 2.0.** On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023 which included SECURE Act 2.0. SECURE Act 2.0 contains over ninety new retirement provisions, some of which are mandatory, with effective dates upon enactment through tax years beginning after 2026. SECURE Act 2.0 allows plan sponsors to make related changes in plan operations immediately without formally amending the plan document. Plan documents are required to be formally amended for mandatory and any nonmandatory provisions adopted on or before the last day of the 2025 plan year. The Company intends to make this amendment before the stated deadline.

**Reclassifications.** Certain amounts in the financial statements have been reclassified to conform to the 2024 presentation. These reclassifications had no effect on the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2023.

**Subsequent Events.** The Plan has evaluated subsequent events through October 20, 2025, the date the financial statements were available to be issued.

2024, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by John Hancock Life Insurance Company (the Trustee of the Plan).

### D. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Pooled Separate Accounts - Valued at the daily net asset value ("NAV") of the underlying investments as determined by quoted market prices.

In accordance with FASB ASC 820-10, certain investments that are measured at fair value using the net asset value per share (or its equivalent) practical expedient have not been classified in the fair value hierarchy. ### E. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by John Hancock Life Insurance Company (“John Hancock”). John Hancock is the Trustee and recordkeeper for the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in the net appreciation (depreciation) in the fair value of investments, as they are paid through revenue-sharing, rather than a direct payment. The Plan Sponsor pays directly any other fees related to the Plan’s operations.

### F. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, Participants would become 100% vested in their employer contributions.

### G. TAX STATUS

The Plan was adopted based upon a prototype plan sponsored by the Nova 401k Associates Inc (“Nova”). Nova received a determination letter from the Internal Revenue Service (“IRS”) dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the Internal Revenue Code (“IRC”). Although the Plan has been amended since Nova received the determination letter, the Plan Administrator believes that the Plan is designed, and is currently being operated in compliance with, the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related Trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

### **H. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect Participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
