Reasonable Cause Statement - 401(k) ADP Plan ID #246354

To Whom It May Concern:

We respectfully request penalty relief for the late filing of our Form 5500 for the plan year ending 2024. The delay was due to circumstances beyond our control and was not the result of willful neglect.

Specifically, incorrect participant information was transmitted through our ADP 401(k) recordkeeping platform for one employee. Upon discovering the discrepancy, we immediately contacted ADP and made multiple follow-up requests to have the data corrected so that the annual report would reflect accurate participant information. Despite our diligence and repeated outreach, the issue remained unresolved until 10/16/2025, preventing us from completing and submitting the Form 5500 by the original due date.

We acted in good faith throughout this process, maintaining regular communication with ADP, documenting our efforts to secure the correction, and preparing all other aspects of the filing in anticipation of submission as soon as the data could be verified. Once ADP resolved the error, we promptly finalized and filed the Form 5500.

We take our filing obligations seriously and have implemented additional internal review procedures to ensure future filings are not delayed by third-party administrative errors. Given these facts, we respectfully request that the late-filing penalty be waived on the basis of reasonable cause.
