### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Godolphin, LLC 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year then ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

## Notes to the Financial Statements

### 1. Description of Plan

The following brief description of the Godolphin, LLC 401(k) Profit Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the *Plan Document* for more complete information.

#### General

The Plan is a defined contribution retirement plan which became effective January 1, 1998 and was restated in its entirety effective January 1, 2022. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). The Plan is administered by a trust, the trustee of which is a financial institution.

#### Eligibility

The Plan covers all employees of Godolphin, LLC (the Plan Sponsor and Administrator). Employees become eligible after reaching the age of 21 and completing one year of service with at least 1,000 hours worked. Prior to July 1, 2022, once an employee satisfied the eligibility requirements, he or she could enter the Plan on the first day of January, April, July, or October coinciding with or following the date the eligibility requirements were met. Effective July 1, 2022, once an employee satisfies the eligibility requirements, he or she may enter the Plan on the first day of the month following the date the eligibility requirements are met.

#### Contributions

Each participant is permitted to contribute a percentage of their annual compensation to their individual accounts on a pre-tax basis, not to exceed the annual maximum limit established by the *Internal Revenue Code* (IRC). The Plan permits pre-tax and Roth deferral contributions. The Plan Sponsor makes a safe harbor non-elective contribution equaling 3% of each participants eligible compensation. The Plan Sponsor may also make a discretionary profit-sharing contribution. For 2024, the Plan Sponsor made a contribution equaling 9% of participants' eligible compensation.

#### Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution and the Plan Sponsor's contributions, an allocation of Plan earnings or losses, and administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan document. Administrative expenses are charged to each participant's account when a benefit distribution is processed. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Benefits and Vesting

The benefit to which a participant is entitled is the benefit which can be provided from the participant's account, which includes participant and sponsor contributions and related earnings thereon. Earnings are allocated based on the individual participant's account balance in relation to total participant account balances. Participants are 100% vested in their elective deferrals and sponsor contributions and related earnings thereon at all times.

### Notes to the Financial Statements, continued

#### 1. Description of Plan, continued

##### Forfeited Accounts

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$40,940 and \$36,821, respectively.

As of December 31, 2024, the Plan held an investment in a life insurance policy with a cash surrender value of \$37,206. This policy was originally purchased under a prior plan arrangement that allowed for the acquisition of life insurance within the Plan. The life insurance policy was funded by employer contributions on behalf of a participant who subsequently terminated employment before becoming fully vested.

During 2024, \$2,553 of uncashed benefit payments were placed into forfeitures and reduced benefits paid to participants. As of December 31, 2024, the total amount of uncashed benefit payments that have been placed into forfeitures is \$3,711. The Plan will reissue these checks when the participants, or beneficiaries, are located or claimed. Since these funds have not been placed into participant accounts, the Plan Sponsor would be responsible for funding these payouts when the participants are located or claimed if the forfeitures have been utilized for other purposes.

##### Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual withdrawals. For termination of service due to other reasons, a participant will receive the value of the vested interest in his or her account as a lump-sum distribution. Hardship withdrawals are also allowed up to the amount of participant's elective deferral contributions.

##### Risk and Uncertainties

The Plan provides for participant directed investment in various investment options. Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of the investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits and the statement of changes in net assets available for benefits.

#### 2. Summary of Significant Accounting Policies

The financial statements have been prepared in conformity with accounting principles generally accepted in the United States of America (GAAP) which require management to make estimates and assumptions that affect the reported amounts and disclosures in the financial statements. Actual results could differ from those estimates. The following is a summary of the significant accounting policies consistently followed by the Plan in the preparation of its financial statements:

##### Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

### 2. Summary of Significant Accounting Policies, continued

#### Investment Valuation and Income Recognition

The Plan's investments are stated at fair value with the exception of a fully benefit-responsive investment contract. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains or losses on investments bought and sold as well as held during the year.

Contract value is the relevant measurement for fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan.

The Plan's Administrator determines the Plan's valuation policies utilizing information provided by the investment advisor and custodian.

#### Contributions

Contributions from the Plan participants and the matching contributions from the Plan Sponsor are recorded in the year in which the employee contributions are withheld from compensation.

#### Payment of Benefits

Benefits are recorded upon distribution.

#### Administrative Expenses

Certain administrative expenses are paid by the Plan. All other administrative expenses are paid by the Plan Sponsor.

#### Subsequent Events

The Plan has evaluated subsequent events for accounting and disclosure requirements through October 23, 2025, the date that the financial statements were available to be issued.

### 3. Information Certified and Provided by Trustee

The Plan's investment information included in this note and throughout the Plan's financial statements and supplemental schedule was prepared by or derived from information provided by Empower Trust Company, LLC (Empower), the trustee of the Plan, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the trustee that investment information provided to the Plan Administrator by the trustee related to the investment information is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to investment information in this note which appears throughout the financial statements and the supplemental schedule.

Empower certified the completeness and accuracy of \$2,084,028 of net realized and unrealized appreciation in the fair value of investments and \$1,063,662 of interest and dividends related to the investments for the year ended December 31, 2024.

### 4. Fair Value Measurements

The Plan classifies its investments based on a hierarchy consisting of: Level 1 (valued using quoted prices from active markets for identical assets), Level 2 (not traded on an active market but for which observable market inputs are readily available), and Level 3 (valued based on significant unobservable inputs). The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis:

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Money market fund:* Valued at cost which approximates fair value.

There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan Administrator believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Investment Contracts with Insurance Company

The Plan has a benefit-responsive investment contract with Putnam Investments. Putnam Investments maintains the contribution in a general account, which is credited with earnings on the underlying investments and charged for Plan withdrawals and administration expenses. The contract is included in the financial statements at contract value as reported to the Plan by Putnam Investments. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (i) amendments to the plan documents (including complete or partial plan termination or merger with another plan); (ii) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (iii) bankruptcy of the Plan Sponsor or other Plan Sponsor event (e.g., divestures or spin-offs of a subsidiary) that causes a significant withdrawal from the Plan; or (iv) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate was 3.96% and 4.09% as of December 31, 2024 and 2023, respectively. This rate is reviewed on a quarterly basis for resetting. The weighted average yield for the year ended December 31, 2024 was 4.38%.

### 6. Exempt Party-in-Interest Transactions

Empower is the trustee as defined by the Plan and therefore, transactions with Empower qualify as party-in-interest. Administrative expenses of \$152,197 for the year ended December 31, 2024 are comprised of fees paid by the Plan directly to parties-in-interest for record-keeping and investment management and advisory services.

Additionally, indirect fees are paid to Empower based on investment account values. These fees range from 0.04% to 0.97% of the investment account value. The fees are included in net appreciation in fair value of investments on the statement of changes in net assets available for benefits.

### 7. Tax Status

The Plan uses a prototype Plan document sponsored by Stoll Keenon Ogden, PLLC. Stoll Keenon Ogden, PLLC received an opinion letter from the Internal Revenue Service (IRS), dated November 14, 2022, which states that the prototype document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

### 8. Plan Termination

Although it has not expressed any intention to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, the rights of all affected participants to amounts contributed by them and the sponsor and related earnings thereon would continue to be fully vested.
