

## **1. DESCRIPTION OF THE PLAN:**

The following description of Iron Workers District Council of Southern Ohio & Vicinity Benefit Trust (the "Plan") only provides general information about the plan's provisions. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

### **General**

The Plan is a multiemployer health and welfare benefit plan covering employees of those employers who have agreed to make the required employer contributions to the Plan per collective bargaining agreements with various local Iron Workers unions located in Indiana, Kentucky, Ohio, and West Virginia. Plan assets are held in a voluntary beneficiary association ("VEBA") trust. The Plan provides benefits for eligible participants and their dependents and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. Administration of the Plan is the responsibility of the Board of Trustees and is governed by a joint board consisting of equal representation from the participating employers and the various local Iron Workers unions.

### **Eligibility**

To become initially eligible for benefits, a participant must perform work under the jurisdiction of an Iron Workers Local Union that participates in the Plan and work at least 1,000 hours during a 12 consecutive month period. New employees who have never had hours reported to the plan generally are eligible for coverage after 500 hours of work in covered employment during a five-consecutive month period. Once eligibility requirements are met, certain eligible dependents are also covered under the Plan upon submission of the applicable enrollment form and supporting documents to the Plan Administrator.

Members maintain eligibility for each three months they are credited with a minimum of 40 work hours. Hours for a participant in excess of 1,800 hours are accumulated in an eligibility hour bank to a maximum of 300 hours (270 hours prior to June 1, 2024). Certain participating locals contribute at a higher hourly rate than required. The excess is credited to a money bank. When hours worked for a participant are less than required, the accumulated hour bank and money bank can be used to continue eligibility. In the event that a participant's hours worked, as reported to the Plan, are insufficient to maintain continued coverage, a member is given the opportunity to make self-payments to maintain eligibility.

Retirees may also be eligible to participate in the Plan. Benefits for retirees that are not yet eligible for Medicare are self-funded. Retirees eligible for Medicare may purchase fully insured supplemental policies through the Plan. As the benefits provided by the Plan for Medicare eligible retirees are fully insured and not self-funded, the Plan is not eligible to receive subsidies under Medicare Part D.

### **Contributions**

In accordance with the collective bargaining agreements, employers are required to make monthly contributions at a fixed dollar amount for each hour worked by participants. Participants and retirees may contribute to the Plan under self-pay or COBRA guidelines.

### **Medical benefits**

The Plan provides self-funded health benefits (hospital, surgical, major medical, loss of time, dental and vision) covering eligible members of the participating Iron Workers local unions. Additionally, the Plan provides similar benefits during periods of unemployment, disability or upon termination of employment through COBRA.

The Plan also maintains a Health Reimbursement Account ("HRA"), which permits active participants to obtain reimbursement for eligible medical care expenses on a tax free basis. A portion of the employer contributions are allocated to the individual participants' HRA account balances, which may be carried forward from year to year. If a participant ceases to be eligible for the HRA, then any HRA amounts unused by the participant revert to the general assets of the Plan. Additionally, if the HRA was terminated, unused amounts remaining in the HRA are considered general assets of the Plan.

The claims for self-insured benefits are processed by the Plan's third party claims processors under administrative services only ("ASO") arrangements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by the Plan. Despite the Plan's utilization of third party claims processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

The Plan utilizes a pharmacy benefit manager ("PBM") which periodically provides rebates to the Plan based on the Plan's utilization pattern of specific drugs.

#### **Death benefits**

The Plan provides a \$7,000 death benefit and accidental death and dismemberment insurance for active participants, which is covered under a group term insurance policy.

## **2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

The following are the significant accounting policies of the Plan:

#### **Basis of accounting**

The financial statements of the Plan are prepared using the accrual method of accounting.

#### **Use of estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Plan benefits**

Liabilities for claims payable and health claims incurred but not reported and postretirement benefit obligations are estimated by the Plan's actuary in accordance with accepted actuarial principles.

The Plan recognizes an obligation for HRA benefits based on the total of all individual participants' available account balances.

The Plan recognizes an obligation for future benefits arising from participants' accumulated eligibility credits. This obligation is based upon the aggregate hour bank balances of all active participants plus additional credit for hours worked by participants prior to the end of the year, but not yet posted to their hour bank accounts. The Plan estimates the obligation for participants' accumulated eligibility credits using the monthly per capita cost of benefits as determined by the Plan's actuary.

#### **Investment valuation and income recognition**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net investment earnings includes interest, dividends and the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### **Cash**

Cash includes amounts on deposit with financial institutions. The balances, at times, may exceed federally insured limits. The Plan has not experienced any losses in such accounts and plan management believes that the Plan is not exposed to any significant risk with its cash on deposit with financial institutions.

### **Employer contributions receivable**

Employer contributions receivable represents amounts due from employers that were received subsequent to year end. Therefore, the carrying amount of these receivables is not reduced by an allowance for amounts that will not be collected. In addition, it is impractical to estimate a recognition of revenue for amounts due but erroneously unreported by employers.

### **Reciprocity contributions**

Participants of the Plan and participants of the benefit plans of other affiliated local unions may have temporary employment assignments outside the jurisdiction of their local union. Therefore, the Plan has entered into reciprocity agreements with other affiliated locals to ensure that employer contributions are forwarded to the benefit plans of the affiliated local unions on behalf of the participants. Reciprocal contributions received, and reciprocal contributions paid have been netted with employer contributions on the statements of changes in net assets available for benefits.

### **Prescription rebates**

Rebates due from the Plan's PBM are recorded when earned. Rebates due as of January 31, 2025 and 2024 totaled \$1,928,816 and \$1,649,965, respectively. Rebates totaling \$5,801,740 and \$5,202,943 have been netted with benefits paid for participants in the accompanying statements of changes in net assets available for benefits for the years ended January 31, 2025 and 2024, respectively. The January 31, 2025, prescription rebates balance also includes \$266,186 related to reimbursement for prescription claims that were not approved by the Plan.

### **Stop-loss coverage**

The Plan maintains a stop-loss insurance arrangement with an individual limit of \$375,000 to reduce its exposure for self-insured medical benefits. Stop-loss reimbursements receivable due as of January 31, 2025 and 2024 totaled \$-0- and \$84,500, respectively. Stop-loss reimbursements are recorded as a reduction of medical claims in the accompanying statements of changes in net assets available for benefits. The Plan recognized stop-loss reimbursements of \$1,005,241 and \$929,939 for the years ended January 31, 2025 and 2024, respectively.

### **Furniture and equipment held for use**

Furniture and equipment is used for Plan operations and is recorded at cost. Depreciation is provided using the straight-line method over the estimated useful lives of the respective assets. Depreciation expense prior to allocation to related plans totaled \$59,711 and \$56,795 for the years ended January 31, 2025 and 2024, respectively.

### **Long-lived asset impairment**

The Plan evaluates the recoverability of the carrying value of long-lived assets whenever events or circumstances indicate the carrying amount may not be recoverable. If a long-lived asset is tested for recoverability and the undiscounted estimated future cash flows expected to result from the use and eventual disposition of the asset are less than the carrying amount of the asset, the asset cost is adjusted to fair value and an impairment loss is recognized as the amount by which the carrying amount of a long-lived asset exceeds its fair value. The fair values are determined based on current appraisals. There was no asset impairment during the years ended January 31, 2025 and 2024.

### **Payment of benefits**

Premiums paid are recorded as retiree medical insurance premiums in the accompanying statements of changes in net assets available for benefits. Claim payments are recorded when submitted to the Plan by the third-party claims processor for reimbursement. Claims paid by the claims processor prior to year-end or claim payments submitted to the Plan by the third-party claims processors that are not yet paid are recorded as an amount currently payable in the accompanying statements of net assets available for benefits.

**Fees and other expenses**

The Plan Administrator allocates certain administrative and record-keeping costs to the Plan, in addition to the cost of payroll and related payroll benefits directly attributable to the Plan. In computing these allocated costs, various factors were considered, including the time spent, space used, costs incurred, and volume of transactions related to the Plan in related to the related Pension Trust and Annuity Trust. These expenses are reported in administrative expenses on the accompanying statements of changes in net assets available for benefits. The Plan also pays administrative fees to third-party claims administrators. These expenses are recorded when incurred and reported in claims administration fees and stop-loss premiums in the accompanying statements of changes in net assets available for benefits. Certain investment related expenses are netted against net investment earnings.

**Reclassifications**

Certain reclassifications have been made to the prior year financial statements in order to conform to the current year presentation.

**Significant estimates**

Amounts reported for claims payable and health claims incurred and not reported, future benefits based on participants' accumulated eligibility and postretirement benefit obligations are subject to significant fluctuation due to various factors, including participants' claim experience, actuarial assumptions used and changes in the health care cost trend rate.

**Subsequent events**

The Plan has evaluated subsequent events through October 23, 2025, the date on which the financial statements were available to be issued.

**3. BENEFIT OBLIGATIONS:**

A postretirement benefit obligation has been recognized for future benefits expected to be paid to or for (1) currently retired participants and their beneficiaries and dependents, and (2) active participants and their beneficiaries and dependents after retirement from service with the participating employers. These benefit obligations represent the actuarial present value of the cost of those estimated future benefits that are attributed by the terms of the Plan to participant service rendered to the date of the financial statements, reduced by the actuarial present value of contributions expected to be received in the future from current retirees of the Plan. The obligations represent the amounts that are expected to be funded by contributions from the participating employers and from existing assets of the Plan. Prior to an active participant's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributable to that employee's service with a participating employer or employers rendered to the valuation date.

The actuarial present value of the expected postretirement benefit obligation is determined by the Plan's actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims cost per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those from death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

Postretirement benefit costs are shared by the Plan's participating employers and retirees. In addition to deductibles and co-payments, retiree contributions were assumed to offset approximately 87% of the estimated cost of providing their future postretirement benefits as of January 31, 2025 and 2024.

For measurement purposes at January 31, 2025 and 2024, the net cost of covered medical and prescription drug benefits was assumed to increase as follows:

Non-Medicare Medical and Prescription Drug – 7% graded to 4.5% and 10% grade to 4.5% over 11 years for medical and prescription drug costs, respectively, for 2025 and 7% graded to 4.5% over 11 years for medical and prescription drug costs, respectively, for 2024

Medicare Medical and Prescription Drug – 10% graded to 4.5% over one year for 2025 and 6% graded to 4.5% over 7 years for 2024

The health care cost-trend assumption has a significant effect on the amount reported. If the assumed rates increased by one percentage point each year, that would increase the obligation as of January 31, 2025 by \$10,563,997.

The following were other significant assumptions used in the valuation as of January 31, 2025 and 2024:

Discount rate – 5.25% and 5.00% for 2025 and 2024, respectively.

Retiree contribution increase rate:

Under age 65 – Increase consistent with Non-Medicare and Prescription Drug trend rate for 2025 and 2024.

Over age 65 – 0% until the expected MAPD premiums match the contributions, at which point they will increase at the same rate for 2025; 0% for ten years for 2024.

Assumed age at retirement – various rates from age 55 to 65

Mortality – healthy: 125% of RP-2014 Blue Collar Healthy Mortality Table, projected using Scale MP-2016; if eligible for Social Security Disability benefits: 125% of RP-2014 Disabled Retiree Mortality Table, projected using Scale MP-2016.

Postretirement benefit obligations at January 31, 2025 increased \$9,522,701 compared to the obligations at January 31, 2024. Net benefit obligations increased \$1,260,198 due to actuarial experience gains. Net benefit obligations increased \$1,588,777 due to actuarial assumption changes. These changes included updating the discount rate and future trends on health cost. Net benefit obligations increased \$3,448,645 due to claim and contribution adjustments.

Postretirement benefit obligations at January 31, 2024 decreased \$2,784,769 compared to the obligations at January 31, 2023. Net benefit obligations decreased \$533,914 due to actuarial experience gains. Net benefit obligations decreased \$1,028,060 due to actuarial assumption changes. These changes included updating the discount rate, future trends on health cost, and per capita health cost. Net benefit obligations decreased \$4,761,431 due to claim and contribution adjustments.

Benefit obligations other than postretirement and postemployment benefit obligations include health claims incurred but not yet reported, accumulated eligibility and unused health reimbursement account balances.

Claims incurred but not yet reported are estimated by the Plan's actuary in accordance with accepted actuarial principles based on claims data provided by the Plan. These amounts are paid by the Plan only if claims are submitted and approved for payment.

The Plan is required to provide benefits to certain members, if such members have accumulated credit amounts (expressed in dollars) in excess of that required for current coverage. Participants draw on their accumulated credits whenever their contributions do not fulfill the Plan's eligibility requirements. The estimated future liability represents the present value of an extension of future benefits that occurs prior to eligibility for retirement with medical benefits per the rules specified in the Plan agreement. The calculation of the accumulated eligibility credit reserves at January 31, 2025 and 2024, have been based on assumptions of past underemployment data, usage, and estimated cost of coverage.

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the post retirement benefit obligations.

The Plan's excess of benefit obligations over net assets at January 31, 2025 and 2024, relates primarily to the postretirement benefit obligation. However, the Plan empowers the Board of Trustees to modify the terms and conditions under which retiree eligibility may be maintained; therefore, the cost to the Plan can be reduced or eliminated prospectively by action of the Board of Trustees.

**4. TAX STATUS:**

The VEBA trust funding the benefits of the Plan received an exemption letter from the Internal Revenue Service dated April 4, 1954, stating that the trust is tax-exempt under provisions subsequently codified under Section 501(c)(9) of the Internal Revenue Code (IRC). No federal or state income taxes have been recorded in fiscal 2025 and 2024 for unrelated business taxable income.

In addition, the Plan and trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The Plan Administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trust is tax-exempt.

**6. FAIR VALUE MEASUREMENTS:**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

*Money market fund:* Valued at cost, which approximates fair value.

*Registered investment companies:* Mutual funds are valued at the daily closing prices as reported by the funds. The funds held by the Plan are registered with the Securities and Exchange Commission. The funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

*Common/collective trust:* Valued at the net asset value (NAV) of units of the collective trust. The NAV, as provide by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

There have been no changes in the methodologies used at January 31, 2025 and 2024.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's Trustees believe that the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The common/collective trust held by the Plan is a Direct filing entity (DFE). The Plan is not required to disclose the investment strategies of DFEs that file a Form 5500 annual report directly with the U.S. Department of Labor.

**7. RELATED ORGANIZATIONS AND PARTIES IN INTEREST:**

The Plan pays fees for several arrangements with service providers and affiliated entities. These transactions are considered exempt party in interest transactions under ERISA.

The Plan operates jointly with the Pension Trust and Annuity Trust sponsored by the Iron Workers District Council of Southern Ohio & Vicinity. Transactions between the Plans are as follows:

The Plan leases office space on an annual basis from the Pension Trust. Rent expense is determined annually based on an allocation of square footage. Lease expense under this arrangement was \$72,039 and \$79,054 for the years ended January 31, 2025 and 2024, respectively.

Certain administrative expenses benefiting all three plans are paid by the Plan on behalf of the Pension Trust and Annuity Trust. Such joint costs are allocated to each plan based on factors, including personnel time, governance time, contribution levels, postage usage, etc. Joint administrative expenses allocated by the Plan to the Pension Trust and Annuity Trust were \$585,729 and \$472,971 for the year ended January 31, 2025, respectively, and \$518,653 and \$506,742 for the year ended January 31, 2024, respectively.

Employer contributions to the Plan and related Plans are remitted jointly in a single monthly payment. These contributions are initially deposited into the related Pension Trust and subsequently transferred to the appropriate plan after processing. Amounts held by the Pension Trust on behalf of the Plan are classified as part of accounts receivable from related plans.

At January 31, 2025, \$857,503 was due from the related Pension Trust and \$69,250 was due from the related Annuity Trust. At January 31, 2024, \$525,874 was due from the related Pension Trust and \$171,026 was payable to the related Annuity Trust. These balances are the result of contributions pending transfer, rent charges, the true-up of joint costs allocated from the Benefit Trust and amounts related to the funded status of the defined benefit plan sponsored for Benefit Trust employees, as described in Note 9.

**8. PLAN TERMINATION:**

Although it has not expressed any intention to do so, the Plan's Board of Trustees has the right under the Plan to modify the benefits provided to participants and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward provision of benefits for or on account of the participants. No assets of the Plan may be used for purposes other than for the exclusive benefit of the Plan's participants.

**9. RETIREMENT PLANS FOR BENEFIT TRUST EMPLOYEES:**

The Plan sponsors a defined contribution plan and a defined benefit plan for its active and retired employees. Brief descriptions are as follows:

*Defined Contribution Pension Plan of Iron Workers Benefit Trust* – Defined contribution plan covering all employees of the Benefit Trust who are at least 18 years of age. The Plan contributes to the defined contribution pension plan for each participant at a fixed rate per hour for each hour worked. In addition to the employer contributions, each participant may contribute, on a pre-tax basis, up to a maximum of 5% of gross wages. The annuity plan allows for retirement benefits at normal retirement age or in the case of a qualifying disability.

*Pension Plan for Employees of Iron Workers District Council of Southern Ohio & Vicinity Benefit Trust* – Non-contributory defined benefit plan covering all employees of the Benefit Trust who have completed one year of service with at least 1,000 hours of employment and who are at least 18 years of age. The cost of administering the pension plan and all required contributions are paid by the Benefit Trust and allocated to the related Pension and Annuity trusts. Benefits paid from the defined benefit plan are based on years of service with the Benefit Trust and the average monthly salary during the highest five out of the last 10 consecutive calendar years worked by an employee. Benefits are available as normal retirement benefits, unreduced early retirement benefits (age 62), reduced early retirement benefits (age 55), death benefits, or disability benefits. The Benefit Trust’s funding policy is to contribute to the plan at least the minimum amount required by ERISA.

The Plan contributed \$75,203 and \$78,440 to the defined contribution plan during the years ended January 31, 2025 and 2024, respectively. The Plan made contributions to the defined benefit plan of \$198,097 and \$105,659 for the years ended January 31, 2025 and 2024 (including contributions made subsequent to the June 30 valuation date).

The most recent actuarial valuation for the pension plan was performed as of June 30, 2024. Therefore, actuarial information and market values of investments are shown as of that date. The significant assumptions used in the valuation include a discount rate of 6.00% as of June 30, 2024 and 2023. The amounts recognized in the statements of net assets available for benefits for the pension obligation at January 31, 2025 and 2024 were \$(214,072) and \$(491,754), respectively. Required contributions are allocated to the related Pension Trust and Annuity Trust and settled annually. The impact from other changes in the funded status is allocated to the related Pension Trust and Annuity Trust and will be settled in the future as contributions are made to fund the benefits. Cash contributions charged to expense during 2025 totaled \$198,097, of which \$52,516 and \$48,514 were allocated to the Pension Trust and Annuity Trust, respectively. Cash contributions charged to expense during 2024 totaled \$105,659, of which \$30,102 and \$32,469 were allocated to the Pension Trust and Annuity Trust, respectively. The gross expense related to other changes in the funded status totaled \$277,682 for 2025, of which \$73,613 was attributable to the Pension Trust and \$68,004 was related to the Annuity Trust. The gross expense related to other changes in the funded status totaled \$61,603 for 2024, of which \$17,551 was attributable to the Pension Trust and \$18,931 was related to the Annuity Trust.

The pension plan's overall investment strategy is to diversify investments within both equity and fixed income securities so as to provide a balance that will enhance total return, while avoiding undue risk concentrations in any single asset class of investment categories. To ensure broad diversification among the major investment categories, investments are maintained in mutual funds and asset allocations are set with specific target percentages.

At January 31, 2025 and 2024, the defined benefit plan for office employees had a minimum required contribution of \$196,748 and \$169,853, respectively. The benefit payments are expected to remain consistent, as adjusted for future retirements.

Claims and premiums that have been processed and approved for payment at year-end, but not paid, and claims incurred but not reported, are not considered liabilities under GAAP; therefore, these claims and premiums are not presented as liabilities or claims and premiums paid in the accompanying financial statements but are recorded on the Form 5500 as a liability.

**11. RISKS AND UNCERTAINTIES:**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.

The Plan is involved in various claims and legal actions arising in the ordinary course of business. In the opinion of management, the ultimate disposition of these matters will not have a material adverse effect on the Plan's financial status.

**12. PLAN AMENDMENTS:**

On June 14, 2024, the Plan was amended to modify certain eligibility provisions, including initial eligibility and the eligibility of travelers, individuals who are not a member of a local union affiliated with the Iron Workers District Council of Southern Ohio and Vicinity, but rather is from a local outside of the District Council.

On July 10, 2024, the Plan was amended to increase the maximum number of hours permitted to be accumulated within the hour bank from 270 to 300 hours. Hours worked as a non-bargaining participant and hours worked as a traveler on and after July 1, 2024 are not credited to the hour bank. Additionally, contribution rates pursuant to certain collective bargaining agreements include an extra amount that is credited to the Plan's money bank. Effective with hours worked on and after July 1, 2024, amounts contributed for travelers are no longer credited to the money bank.
