### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Golden State Foods 401(k) Savings and Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### 1. Description of the Plan

The following description of the Golden State Foods 401(k) Savings and Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document, as amended, for a complete description of the Plan's provisions.

#### *General*

Golden State Foods, LLC (the Company or the Plan Sponsor, formerly, Golden State Foods Corp.) established the Plan on May 1, 1994. Effective October 1, 1996, the Plan was amended whereby assets from the Golden State Foods Salaried Employees' Retirement Plan were transferred to the Golden State Foods 401(k) Savings and Retirement Plan and the Plan name was changed to the Golden State Foods Salaried 401(k) Savings and Retirement Plan (the Salaried Plan). Also, at that time, a portion of the assets of the original Golden State Foods 401(k) Plan were transferred to the Salaried Plan. Effective January 1, 2014, the Plan name was changed to the Golden State Foods 401(k) Savings and Retirement Plan. Effective December 31, 2014, Golden State Foods Hourly 401(k) Savings and Retirement Plan (the Hourly Plan), Golden State Foods Hourly Employees' 401(k) Savings and Retirement Plan (the Hourly Employees Plan), and Golden State Foods Midwest 401(k) Savings and Retirement Plan (the Midwest Plan) merged with the Golden State Foods 401(k) Savings and Retirement Plan. All balances under the Hourly Plan, Hourly Employees Plan, and Midwest Plan were combined with the balances under the Plan as of December 31, 2014.

The Plan is a defined contribution plan covering all employees of the Company, as defined in the Plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The plan was most recently restated and amended effective January 1, 2022.

#### *Trustee and Administration of the Plan*

Overall responsibility for administering the Plan rests with the Plan's Retirement Committee, the members of which are appointed by the Board of Directors of the Company. Charles Schwab Bank (the Trustee or Schwab) is the Trustee, and Schwab Retirement Plan Services, a related entity of the Trustee, is the Plan's recordkeeper. The Trustee holds assets of the Plan and executes investment transactions, makes payments as directed by Plan participants and other functions, as defined.

#### *Eligibility*

Plan eligibility excludes non-resident alien employees without U.S. income, leased employees and employees that meet any of the following criteria: (1) employed at McCook, Illinois or Whitewater, Wisconsin facilities; (2) hired by the Company on or before December 1, 2006; (3) classified as a process level 55 or 56 employee; and (4) have continuously met the previous three criteria since December 1, 2006.

Upon their first date of employment, employees who receive either hourly wages or salaried wages from the Company are eligible to participate in the Plan and may make employee pre-tax contributions. The Plan allows for the automatic enrollment of all new employees. Employees who do not affirmatively opt out of automatic enrollment or otherwise elect a specified deferral rate are auto enrolled in the Plan and will have 3% of their compensation deferred upon entry into the Plan and their contributions invested in a designated balanced fund until changed by the participant.

Automatic enrollment deferral contributions are increased by 1% each year subsequent to enrollment up to 6%.

The Plan also allows for Roth, after-tax contributions and in-Plan Roth rollover conversions.

Salaried employees are eligible for Company matching contributions and nonelective contributions after six months of service. Hourly nonunion employees are eligible for Company matching contributions after six months of service. Hourly union employees are eligible for Company matching contributions based on the terms of the union contracts, which ranges from being eligible upon hire to becoming eligible after six months of service.

### ***Contributions***

Each year, participants may contribute up to 50% of pre-tax or after-tax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may contribute amounts representing distributions (rollovers) from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

For salaried employees, the Company contributes 100% of the first 2% of eligible compensation that a participant contributes to the Plan and provides nonelective contributions of 3% of eligible compensation.

For hourly union employees, Company contributions are based on hours worked at rates determined annually and approved by senior management of the Company or pursuant to a collective bargaining agreement.

For hourly non-union employees, Company contributions are based on hours worked at rates determined annually and approved by senior management of the Company. For certain hourly non-union and union employees, the Company generally matches 100% of participant's deferrals up to 3% of compensation, plus 50% of participant's deferrals in excess of 3% but not to exceed 5% of compensation, excluding catch-up contributions. The Company contributions are discretionary and may be changed at any time.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

### ***Participant Accounts***

Each participant's account is credited with the participant's contributions and Company matching contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### ***Vesting***

Participants are vested immediately in their contributions plus actual earnings thereon. Each participant's interest in Company contributions vests according to years of service. For non-safe harbor matching contribution participants are vested according to years of service, which starts as 20% vested during two years of service with an increase of 20% each year until their 6<sup>th</sup> year of

employment at which time they become 100% vested. For non-safe harbor elective contribution participant are 100% vested all times.

For hourly union and non-union employees, Company contributions vest at 20% each year beginning in year two through six. A participant's interest in Company contributions becomes fully vested and distributable upon completing six years of service, total disability, retirement or death, as defined in the Plan document. In the event of termination of employment for any other reason, the vested portion of the participant's account is paid and the unvested portion is forfeited with forfeitures used to offset employer contributions to the Plan.

### ***Notes Receivable from Participants***

Participants are permitted to borrow a minimum of \$1,000 of their vested benefits under the Plan. Participants may borrow up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000, reduced by the highest outstanding loan balance in their account during the prior 12-month period. Loans are secured by the participant's account and bear an interest rate based on prevailing market conditions, unless otherwise determined by the Plan Administrator. The notes are repaid ratably through payroll deductions over a period of five years or less, unless used to purchase a principal residence up to 15 years. These loans are subject to certain restrictions as defined by the Plan Document and applicable restrictions under the Internal Revenue Code (IRC).

Participants formerly in the Hourly Employees Plan may only have one loan outstanding at any time. Participants formerly in the Hourly Plan and Salaried Plan may only have two loans outstanding at any time.

### ***Payment of Benefits***

Participants are eligible to receive a lump sum distribution of their vested account balance upon termination of employment, retirement, disability or death. A participant or beneficiary may elect to (a) receive the lump sum amount directly, or (b) roll over the value into another qualified plan or Individual Retirement Account (IRA). In-service withdrawals from a participant's vested account balance are permitted on attainment of age 59½ or in circumstances of financial hardship, in accordance with provisions specified in the Plan document.

### ***Forfeitures***

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$886,885 and \$274,443, respectively. These accounts will be used to reduce future employer contributions and expenses. During the year ended December 31, 2024, forfeitures of \$2,187,777 were used to reduce employer contributions and \$28,913 were used to reduce expenses.

## **2. Summary of Significant Accounting Policies**

### ***Basis of Accounting***

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with the accounting principles generally accepted in the United States of America (GAAP).

### *Use of Estimates*

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could materially differ from those estimates.

### *Valuation of Investments and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants (an exit price) at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

### *Contributions*

Participant contributions and any related employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation.

### *Payment of Benefits*

Benefits are recorded when paid.

### *Administrative Expenses*

Certain administrative and trustee related expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

### 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under ASC 820, are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Money Market Fund and Mutual Funds* - These assets are valued at the daily closing price as reported by the fund. Money market and mutual funds held by the Plan are open-end money market and mutual funds registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net assets value (NAV) and to transact at that price. The money market and mutual funds held by the Plan are deemed to be actively traded.

*Common or Collective Trust (CCT)* - This asset is a stable value fund that is composed primarily of fully benefit-responsive investment contracts and is valued at the net asset value of units of the collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily without advance notice. There were no unfunded commitments or trading restrictions as of December 31, 2024 and 2023. Further, this fund is a direct filing entity.

in accordance with the presentation and disclosure requirements of GAAP, and in the ERISA-required supplemental schedule, including assessing whether the supplemental schedule is in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

### 5. Related Party and Party-In-Interest Transactions

Certain Plan investments are in funds and accounts that are managed by the Trustee or its affiliates. The Plan paid for certain third-party administrator fees, investment advisory, and certain management fees in the form of an expense ratio charged to each investment option are paid by the Plan and deducted from earnings on investments. The Plan also issues loans to participants which are secured by the vested balance of the participants' accounts. Participant loan and distribution processing fees are paid to Schwab by participants. The Plan also receives revenue credits from Schwab. In addition, Schwab receives fees for recordkeeping services. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

### 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

### 7. Tax Status

The Plan uses a pre-approved plan document sponsored by Charles Schwab Trust Company. Charles Schwab Trust Company received an opinion letter from the IRS, dated September 21, 2020, which states that the pre-approved plan document, as then designed, satisfies the applicable provisions of the IRC. Although the Plan has been amended since the date of the opinion letter, Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statement of net assets available for benefits.

### 9. Subsequent Events

Management has evaluated subsequent events through October 6, 2025, the date the financial statements were available to be issued and has determined that there were no material events requiring recognition or disclosure.
