To the Plan Administrator

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### Note 1 - Organization and Description of Plan

The following description of the De-el Enterprises, Inc 401(k) Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution 401(k) plan covering all eligible employees of De-el Enterprises, Inc (the Company). The Plan does not have an age requirement or service requirement for an employee to participate in the Plan and make contribution. All employees who have completed 500 service hours or are employed on the last day of the Plan year are eligible to receive discretionary profit sharing contribution. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company is the Plan's sponsor and administrator. The Plan's trustees are certain members of the Company's management. Plan management determines the appropriateness of the Plan's investment offerings and monitors investment performance. The Plan's investments are held by Mid Atlantic Trust Company (MATC), the Plan's custodian. The Plan's third-party administrative service provider and recordkeeper is Paychex Retirement Services (Paychex).

**Contributions** - Each year, participants may elect to defer and contribute a percentage of their compensation up to the Internal Revenue Service (IRS) maximum guidelines. Participants may elect to categorize any portion of their contribution under the Plan's Roth deferral feature. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers).

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Entry dates are the first day of the month coinciding with or next following the date they meet eligibility requirements. Automatically enrolled participants have their deferral rate set at three percent of eligible compensation and will increase one percent on the first day of each plan year, up to a maximum of ten percent, unless the participant selects otherwise.

The Company may make annual profit-sharing contributions on a discretionary basis on behalf of all eligible employees whether or not they have made elective contributions to the Plan. Eligible employees for purposes of the annual profit-sharing contribution include those who complete 500 service hours, however, this condition will be waived if the participant is employed on the last day of the Plan Year. No profit-sharing contributions were made for the year ended December 31, 2021.

**Participant Accounts** - Individual participant accounts are maintained by Paychex. Each account is credited with the participant's contributions, the Company's contributions, investment earnings and losses, and administrative expenses, as applicable. Allocations are based on participant compensation, account balances, or specific participant transactions, as defined in the plan agreement. Participants direct the investment of their account balances to any combination of the Plan's investment options. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** - Participants are immediately vested in their own contributions plus actual earnings thereon. Vesting in the employer matching contribution and employer profit-sharing contribution portion of their accounts is based on years of credited service, as defined in the plan agreement, with 20% vesting after two years of service and 100% vesting after six years of service. The Plan has a service requirement of 1,000 service hours for vesting purposes and requires 500 service hours to avoid a break in vesting. Employees who die or become disabled become fully vested in their accounts.

**Payment of Benefits** - On termination of service, a participant or their beneficiary may elect to receive either a lump sum amount equal to the value of the participant's vested interest in their account, partial payments or through the purchase of an annuity contract as defined in the plan agreement. Distributions may also be made in installments to comply with minimum distribution rules required by the Internal Revenue Code (the Code). The Plan permits in-service distributions to participants meeting certain requirements, including distributions for financial hardship.

**Participant Loans** - Participants may borrow from their accounts a minimum of \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance. Terms of the participant loans may not exceed five years, except for the purchase of a primary residence. Participant loans are secured by the balance in the participant's account and bear interest at 1% over the prime rate. Principal and interest are paid ratably through payroll deductions.

**Forfeitures** - Forfeitures by non-vested participants can be used to pay the Plan's administrative expenses, reduce future employer contributions, or allocated amongst eligible participant accounts, as defined in the plan agreement. During 2021, there were no forfeitures used to pay the Plan's administrative expenses, reduce employer contributions or allocated amongst eligible participant accounts. Forfeited non-vested accounts totaled \$0 at December 31, 2021.

### Note 2 - Summary of Significant Accounting Policies

**Basis of Accounting** - The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Note 2 - Summary of Significant Accounting Policies (continued)**

**Use of Estimates** - The preparation of financial statements in conformity with GAAP requires plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

**Investment Valuation and Income Recognition** - The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Participant Loans** – Participant loans are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are recorded as benefits paid to participants on the basis of the terms of the plan agreement.

**Payment of Benefits** - Benefits are recorded when paid.

**Administrative Expenses** - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of certain participant-initiated transactions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation/depreciation in fair value of investments.

**Subsequent Events** - The Plan has evaluated subsequent events through October 14, 2025, which is the date the financial statements were available to be issued.

**Note 3 - Fair Value Measurements**

GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under GAAP are described as follows:

*Level 1 Fair Value Measurements* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Note 3 - Fair Value Measurements (continued)**

*Level 2 Fair Value Measurements* - Inputs to the valuation methodology include (1) quoted prices for similar assets or liabilities in active markets; (2) quoted prices for identical or similar assets or liabilities in inactive markets; (3) inputs other than quoted prices that are observable for the asset or liability; (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3 Fair Value Measurements* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

*Mutual Funds* - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The Plan's investments consist solely of mutuals funds, which are considered level 1 investments within the fair value hierarchy at December 31, 2021.

**Note 4 - Information Certified by Trustee**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2021 and net appreciation/depreciation in fair value of investments and interest and dividends, for the year ended December 31, 2021, was obtained by management and agreed to or derived from information certified as complete and accurate by MATC.

**Note 5 - Related Party and Party-in Interest Transactions**

Expenses paid by the Plan are to parties-in-interest as defined by ERISA. Furthermore, as described in Note 7, the Plan has adopted a pre-approved profit-sharing plan that is sponsored by Paychex.

**Note 6 - Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

**Note 7 - Tax Status**

The Plan has adopted a Paychex pre-approved profit-sharing plan document that received an opinion letter dated August 31, 2020, in which the IRS stated that the Plan, as designed, complied with the applicable requirements of the Code. The plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

GAAP requires the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain positions that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**Note 8 - Risks and Uncertainties**

The Plan allows participants to invest in investment securities that are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with the investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

**Note 9 - Reconciliation to Form 5500**

The Plan's financial statements are prepared on the accrual basis of accounting. The Form 5500 is prepared on the cash basis. Accordingly, the following is a reconciliation of net assets available for benefits per the financial statements as of December 31, 2021 to Form 5500:
