Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements (modified cash basis) of Luse Contracting Group, Inc. Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of March 31, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year ended March 31, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Luse Contracting Group, Inc. Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of March 31, 2025 and 2024, and for the year ended March 31, 2025, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Luse Contracting Group, Inc. Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. A. Description of Plan

The following description of the Luse Contracting Group, Inc. (“Company” or “Plan Sponsor”) Retirement Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

1. *General.* The Plan is a defined contribution plan covering eligible employees of the Company and its wholly owned subsidiaries and is subject to the provisions of the Employee Retirement Income and Security Act (ERISA) of 1974.
2. *Plan Name and Sponsor.* Effective April 1, 2025, the Plan’s name was changed from Luse Holdings Inc. Profit Sharing Plan to Luse Contracting Group Inc. Retirement Plan. In connection with a corporate reorganization under common ownership, plan sponsorship was transferred from Luse Holdings Inc. (EIN 30-0026622) to Luse Contracting Group Inc. (EIN 33-2259043). The effective date of the Plan remains March 31, 1960, and the Plan continues to operate as a single-employer plan covering eligible employees of the Plan sponsor and its participating employers.
3. *Plan Year.* The Plan’s records are maintained on a twelve-month period of time, known as the “Plan Year.” Historically, the Plan Year began on April 1 and ended on March 31. Effective April 1, 2025, the Plan Year will change to a calendar year, beginning on January 1 and ending on December 31. As a result, there will be a short Plan Year from April 1, 2025 through December 31, 2025.
4. *Eligibility.* Employees of the Plan sponsor and its affiliates are eligible to participate in the Plan once they satisfy the eligibility provisions outlined in the Plan document. Generally, an employee becomes eligible after completing six consecutive months of service from their date of employment during which at least 500 hours are worked. Participation begins on the applicable entry date following satisfaction of these eligibility requirements. Excluded employees are certain classes of employees including union employees who are governed by a collective bargaining agreement, leased employees and project employee.

Effective April 1, 2025, the eligibility requirements were amended to provide that employees will become eligible to participate upon completion of three months of service.

5. *Contributions.* Each year, participants may contribute up to 100% of their pretax annual compensation, up to a maximum of \$23,500 in 2025 and \$23,000 in 2024, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company may make a discretionary matching contribution equal to a percentage of an employees’ salary deferrals and/or make a discretionary profit sharing contribution. The Plan also provides that participants who are age 50 or older, and who are making contributions to the Plan may also make a catch-up contribution (not previously made) of up to \$7,500 in 2024 and 2025. Beginning in 2025, participants who attain ages 60 through 63 during the year are eligible for a higher catch-up contribution limit equal to the greater of \$10,000 (as adjusted for inflation) or 150% of the standard catch-up contribution limit (which equals \$11,250 for 2025). Contributions are subject to certain IRS limitations and are subject to change.
6. *Participant Accounts.* Each participant’s account is credited with the participant’s contribution and Company matching contributions, as well as allocations of the Company’s profit sharing

contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

7. *Vesting.* Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company contributions portion of their accounts plus earnings thereon, as outlined in the Plan document, is based on years of continuous service. A participant is 100 percent vested after six years of credited periods of service.
8. *Notes Receivable from Participants.* Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of the lesser of (i) 50 percent of their vested account balance or (ii) \$50,000, reduced by the highest outstanding loan balance, if any, during the one-year period ending on the day before the new loan is made, over the participant's current outstanding loan balance as of the date of the new loan.

In most cases, the notes are secured by the balance in the participant's account and bear interest at a reasonable rate determined by the Plan administrator. The note is required to be paid (principal and interest) in amortized level payments, not less frequently than quarterly, over a period not extending beyond five years from the date of the note; provided, however, that if the proceeds of the note will be used to purchase a principal residence of the participant, the Plan administrator may permit a longer repayment term.
9. *Payments of Benefits.* Benefits are payable to participants upon retirement, disability, death, or termination of employment. Participants may also receive distributions while employed in certain circumstances, such as upon attainment of normal retirement age or in the event of financial hardship, subject to conditions outlined in the Plan. In-service distributions and hardship withdrawals are limited to amounts that are fully vested and are subject to minimum distribution requirements. Participants or beneficiaries may elect to receive distributions in the form of a lump-sum payment, periodic installments, or an annuity, as permitted by the Plan. If a participant's vested account balance does not exceed \$5,000, the balance may be automatically distributed in a lump sum.
10. *Forfeited Accounts.* Forfeitures are retained in the Plan and can be used to pay administrative expenses or can be used to reduce future Company contributions payable under the Plan. At March 31, 2025 and 2024, forfeited non-vested accounts totaled \$6,249 and \$22,457, respectively. During 2025 the amount used as employer contributions and administrative expenses was \$31,161.

B. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the modified cash basis of accounting. The modified cash basis of accounting is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. Under the modified cash basis of accounting, income is recorded when received and expenses are recorded when paid. The modifications to

the cash basis include: (a) the recording of investments at fair value, rather than on a comprehensive cash basis as referenced in the auditor's report, (b) the recording of notes receivable (see "Notes Receivable from Participants" below for more information), and (c) the recognition of deemed distributions from participant loans that are in default in the income statement at the time the distribution is deemed to occur, even though no actual cash outflow has taken place. This contrasts with actual distributions, which are recognized when cash is disbursed from the Plan.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year. See note H for discussion of fair value measurements.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded for the year ending March 31, 2025. If a participant ceases to make loan repayments and the plan administrator deems the participant to be in default, the participant loan is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

Management uses estimates and assumptions in preparing financial statements. Those estimates and assumptions affect the reported amounts and disclosures. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan provides for various investment options in a combination of mutual funds to the participants. The participants' investments in these securities are exposed to various risks, such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risk in the near term could materially affect participants' account balances and the amounts reported in the future statements of net assets available for benefits and the statement of changes in net assets available for benefits.

C. Certified Investments

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at March 31, 2025 and 2024, and net appreciation in fair value of investments, interest and dividends for the year ended March 31, 2025, was obtained or

derived from information supplied to the Plan administrator and certified as complete and accurate by The Standard Insurance Company.

D. Related-Party and Party-In-Interest Transactions

Parties-in-interest to the Plan include the Plan sponsor, fiduciaries, and service providers such as the recordkeeper and insurance carrier. The Plan's investments are held in pooled separate accounts managed by Minnesota Life Insurance Company, with administrative and recordkeeping services provided by Standard Insurance Company ("The Standard"). Because both Minnesota Life and The Standard provide services to the Plan, transactions with them qualify as party-in-interest transactions under ERISA.

Investment management fees are reflected in net appreciation in fair value of investments in the accompanying financial statements. Administrative fees paid by the Plan to The Standard for the year ended March 31, 2025 totaled \$8,704.

E. Employer Match and Profit Sharing Contributions

During the Plan year ended March 31, 2025, the Company deposited discretionary matching contributions equal to 50% of participant contributions up to 4% of each participant's eligible compensation. The total employer matching contributions deposited into the Plan for the year amounted to \$97,091, net of \$22,457 applied from Plan forfeitures. No profit-sharing contribution was made to the Plan for the year ended March 31, 2025.

F. Tax Status

The Internal Revenue Service has determined and informed the Company that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed tax positions taken by the Plan, and has concluded that as of March 31, 2025 there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

G. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in the employer contributions in their account.

H. Fair Value Measurements

Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value, if fair value focuses on the price that would be received to sell the asset or paid to transfer the liability regardless of whether an observable liquid market price existed (an exit price). An exit price valuation will include margins for risk even if they are not observable. As the Plan is released from risk, the margins for risk will also be released through net realized capital gains (losses) in changes in net assets. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1- Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement. Level 3 assets and liabilities measured at fair value are based on one or more of the three valuation techniques:

- Market approach – Prices and other relevant information generated by market transactions involving identical or comparable assets or liabilities.
- Cost approach – Amount that would be required to replace the service capacity of an asset (replacement cost).
- Income approach – Techniques that convert future amounts to a single present amount based on market expectations (including present value techniques, option pricing models, and lattice models).

Guaranteed investment contract: The fair value of the guaranteed investment contracts has been determined to approximate contract value. Contract value is based upon a cost approach, which is equal to principal plus accrued interest.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

I. Guaranteed Investment Contract with National Insurance Company

The Guaranteed Return Account Minnesota Life General Account with Minnesota Life Insurance Company maintains contributions in a general account. The contract is benefit-responsive, in that the full contract value is accessible, but not all at once in the case of certain transfers. General account transfer provisions in the contract prevent the contract from meeting the definition of fully benefit-responsive, since the participant is not allowed immediate full access to the general account balance at contract value in all situations. Reasons for withdrawing money from the general account include participant termination, retirement, death, disability, hardship, loans, contract termination, and participant-initiated transfers between funds. The first six of these types of withdrawals occur at contract value without any conditions, limits, or restrictions. In the case of a contract termination, a market value adjustment and/or liquidation charges may apply.

Participant-initiated transfers between funds always occur at contract value, but the full amount may not be accessible from the General Account at one time. Up to 20% of the contract value or \$2,000, whichever is greater, may be withdrawn at one time, and the remainder is inaccessible for 12 months.

J. Subsequent Events

The Plan has evaluated subsequent events through October 27, 2025, the date the financial statements were available to be issued.
