#### NOTE A--DESCRIPTION OF PLAN

The following description of the Pierre Fabre USA 401(K) Savings & Retirement Plan ("the Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering substantially all employees of Pierre Fabre USA, Inc. ("the Employer" and "Plan Administrator") and Pierre Fabre Pharmaceuticals, Inc., an affiliate. Employees are eligible to participate in the Plan on the first day of the month coinciding with or following their employment date. The Plan excludes employees that are covered by a collective bargaining agreement, are under 21 years of age, or are non-resident aliens without earned income as defined. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Contributions: The Plan provides for employee elective pre-tax contributions and employee elective after-tax contributions (effective January 1, 2022), not to exceed the Federal statutory maximum, with an Employer discretionary matching provision. For the year ended December 31, 2024, the Employer elected to match 50 percent of participant's elective deferrals, up to a maximum of \$9,000 in Employer matching contributions.

Participant Accounts: Each participant's account is credited with their contributions, any Employer's matching contributions, and their account's earnings or losses, net of an allocation of administration expenses. All investments are participant directed. Participants may change their investment options daily.

Vesting: Participants are immediately vested in their voluntary contributions and allocated earnings thereon. Employer contributions and earnings thereon vest on a vesting schedule of 0% for less than 2 years of service, 50% for 2 years but less than three years of service, and 100% for three or more years of service. A participant becomes fully vested after three years of credited service, or in the event of participant death, disability, or retirement.

Forfeitures: Forfeited amounts can be used to pay administrative expenses of the Plan and to reduce future Employer contributions to the Plan.

Notes Receivable from Participants: Participants may borrow from their vested accounts up to a maximum of \$50,000, or 50 percent of their vested account balances, whichever less. Loans are repaid through payroll deductions over periods of up to five years, unless the loan is for the purchase of a participant's primary residence, in which

case, repayment may not extend beyond 30 years. The loans are secured by the balance in the participant's vested accounts and bear interest at the prime rate plus 1% as determined at the inception of the loan.

Withdrawals: A participant may withdraw his vested account balance plus earnings thereon in the case of a financial hardship. Withdrawals are taxable in the year received by the participant and may be subject to a penalty tax. Additionally, after reaching the age of 59½, a participant may request an in-service distribution from vested accounts.

Payment of Benefits: In the case of termination of service due to death, normal retirement (age 65), retirement due to permanent disability, or termination of employment, participants may elect to receive the value of their accumulated Plan benefits, in accordance with the provisions of the Plan, in lump-sum distributions or installment payments assuming the participant's vested account exceeds \$5,000. If the participant's vested account does not exceed \$5,000, then the vested account balance may only be distributed in a single lump-sum payment.

Administration: The Plan is administered by the Employer. All funds in the Plan are held by Ascensus Trust Company and Newport Trust Company, the custodians of the Plan's assets ("the Custodians"). The Custodians invest participants' account balances as directed by the participants.

#### NOTE B--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The Plan follows the Financial Accounting Standards Board Accounting Standards Codification as its sole source of authoritative guidance. The financial statements of the Plan are prepared using the accrual basis of accounting.

The Plan's investments are stated at fair value, as further described in Note C. Investment securities, in general, are exposed to various risks, including credit, interest and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is possible that changes in values of investment securities will occur and that such changes could materially affect the amount reported in the Statements of Net Assets Available for Benefits.

Purchases and sales of securities are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date and interest income is recorded on the accrual basis. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments sold as well as the change in unrealized gains/losses for investments held at the end of the year.

## NOTES TO FINANCIAL STATEMENTS--Continued

### PIERRE FABRE USA 401(K) SAVINGS & RETIREMENT PLAN

#### NOTE B--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES--Continued

Notes receivable from participants are reported separately from Plan investments and measured at their unpaid principal balance.

Contributions are recorded on the accrual basis, which recognizes participants' contributions and Employer matching contributions at the time the participants' contributions are withheld from their wages.

Benefits are recorded when paid, with the exception of amounts refundable by the Plan to Participants for contributions made in excess of amounts allowed by the Internal Revenue Service.

The Plan is responsible for the payment of administrative expenses. Certain administration and custodial expenses are paid by the Employer.

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and the disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Subsequent events have been evaluated through October 8, 2025, which is the date the financial statements were available to be issued.

#### NOTE C--FAIR VALUE MEASUREMENTS

Current accounting guidance establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under the accounting guidance are described below:

Level 1            Inputs to the valuation methodology are unadjusted quoted prices for identical assets and liabilities in active markets that the Plan has the ability to access.

Level 2        Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3        Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024:

Mutual funds: Valued at the quoted market price, which represents the net asset value of shares held by the Plan at year end.

Collective investment trusts: Valued based on quoted prices of securities underlying the collective investment trust.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE D--TRANSACTIONS WITH PARTIES-IN-INTEREST

The Plan has an agreement with the Custodians to maintain the investments of the Plan and to provide administrative and participant recordkeeping services for the Plan. For the year ended December 31, 2024, contributions to the Plan of \$3,436,838 were deposited with the Custodians for investment, and participants in the Plan received distributions of \$3,647,271 from funds held by the Custodians. Additionally, for the year ended December 31, 2024, the Plan recorded \$61,027 in administrative expenses paid to service providers. At December 31, 2024 and 2023, the Plan had \$15,183,439 and \$13,599,171, respectively, of assets held by the Custodians.

NOTE E--TAX STATUS

The Plan is intended to satisfy the tax qualification requirements under Section 401(a) of the Internal Revenue Code; therefore, the trust funds of the Plan are intended to be exempt from federal income taxes. The amended Plan has not requested a favorable determination letter from the IRS since the prototype on which the Plan is based has been determined to be qualified under Section 401(a) of the Internal Revenue Code.

#### NOTE F--RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

For the year ended December 31, 2024, there were no significant differences between the financial statements and Internal Revenue Service Form 5500.

#### NOTE G--FORFEITED NON-VESTED ACCOUNTS

As of December 31, 2024 and 2023, investments included \$96,765 and \$68,579, respectively, in unused forfeitures, which were available to pay for administrative expenses or reduce future Employer contributions. During the year ended December 31, 2024, the forfeiture account was utilized in the amount of \$3,900 to pay administrative expenses.

#### NOTE H--PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their accounts.

#### NOTE I--SUMMARY OF INFORMATION CERTIFIED BY PLAN CUSTODIANS

The total fair value of the Plan's net assets was \$15,183,439 and \$13,599,171 at December 31, 2024 and 2023. Ascensus, LLC, as an authorized agent and representative of the Custodians has supplied the Plan Administrator with a certification as to the completeness and accuracy of all information presented in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and in the statement of changes in net assets available for benefits for the year ended December 31, 2024, in regards to investment activity.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.
