Scope and Nature of the ERISA Section 103(a)(3)(C) Audit on the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of 403(b) Thrift Plan for Employees of The Healing Lodge of the Seven Nations (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

NOTE 1 – DESCRIPTION OF THE PLAN

The following description of 403(b) Thrift Plan for Employees of The Healing Lodge of the Seven Nations (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering employees of The Healing Lodge of The Seven Nation ("Organization"), a youth residential treatment facility owned and operated by seven federally recognized Native American tribes. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The management group oversees governance of the Plan. The Plan's Trustees determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's management group.

Eligibility

There are no minimum age or service requirements to make salary reduction contributions to the Plan. Employees are eligible for employer contributions once they have reached 21 years of age and after completion of one year of service.

Contributions

Participants may contribute up to 100 percent of pretax annual compensation and Roth contributions up to the elective deferral limits set by the Internal Revenue Service. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers pooled separate account investments. The Organization may make a matching contribution for each participant based upon the participant's elective deferrals in a percentage set by the Organization prior to the end of each plan year up to 2 percent of compensation (increased to 4% in 2024) that a participant contributes to the Plan. The Organization matched participant contributions at a rate of 4 percent in 2024.

Effective November 1, 2024, the Organization amended the plan moving matched contribution from 2% to 4%.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Organization's contribution, and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Individual accounts are maintained for each of the Plan's participants to reflect the participant's contributions and related employer matching contributions, as well as the participant's share of the Plan's income and any related administrative expenses.

Vesting

Participants are immediately vested in their contributions and employer matching contributions plus actual earnings thereon.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their non-Roth account balance. The loans are secured by the balance in the participant's account and bears interest, which is determined quarterly by the Plan administrator. Principal and interest are paid ratably through payroll deductions. Interest is recorded on the accrual basis of accounting and is presented in dividends and interest on the statement of changes in net assets.

Payment of Benefits

At a participant's Normal Retirement Age, the participant has the option to have the full value of the participant's account available to be distributed. A participant may receive a lump sum distribution of their entire vested balance or a single sum distribution of a portion of their vested account balance

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates

The preparation of financial statements in accordance with U.S. GAAP requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Quoted market prices are used to value investments. Shares of pooled separate accounts are valued at the net asset value of shares held by the Plan at year-end.

Income Recognition

Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis and interest income from notes receivable from participants is recognized when paid, primarily monthly. Investment income includes interest, dividends, and gains and losses on investments bought and sold as well as held during the year. Net appreciation includes interest, dividends, and gains and losses on investments bought and sold as well as held during the year. The components of investment earning are not separate out as required by GAAP because the custodian does not provide the separate information.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan did not distribute any excess contributions.

Payment of Benefits

Benefits are recorded when approved or deemed a distribution.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

Subsequent events have been evaluated through the date of the auditor's report. This is the date the financial statements were available to be issued.

NOTE 3 – INVESTMENT INFORMATION PREPARED AND CERTIFIED BY TRUSTEE

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the following information included in the accompanying financial statements and supplemental Schedule H, Line 4i – Schedule of Assets (Held at End of Year) was obtained from data that has been prepared and certified as complete and accurate by Mutual of America Financial Group, the plan custodian:

NOTE 4– FAIR VALUE OF INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used during December 31, 2024 and 2023:

Pooled Separate Accounts: Valued at the net asset value (NAV) of units as determined by the insurance company. NAV is a readily determinable fair value and is the basis for current transactions.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 – INVESTMENT RISKS AND UNCERTAINTIES

Investment securities are exposed to various risks that can affect the value of the Plan's investments such as interest rate risk, custodial credit risk, and concentration of credit risk. The Plan invests in registered investment companies (pooled separate accounts). Pooled separate account holdings in equity securities respond to such factors as economic conditions, individual company earnings performance, and market liquidity, while holdings in debt securities are particularly sensitive to credit risk and change in interest rates.

Interest rate risk

Interest rate risk arises from the likelihood that interest rates will rise or fall during the holding period of a fixed-rate security and adversely affect the selling price of the security prior to maturity. The price of a debt security typically moves in the opposite direction of the change in interest rates. As of December 31, 2024, the Plan had the following investments subject to interest rate risk:

Credit Risk – Credit risk exists when there is a possibility that the issuer or other counterparty to an investment may be unable to fulfill its payments on a security under the original term. NOTE 6 – PARTIES-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of pooled separate accounts managed by Mutual of America Financial Group. Mutual of America Financial Group is the plan custodian, as defined by the Plan. Therefore, transactions with Mutual of America Financial Group are considered to be party-in-interest transactions.

The Plan also has notes receivable from participants, which also qualify as party-in-interest transactions.

NOTE 7 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, no further contributions will be made to the plan and the amounts credited to participants account will continue to be 100% vested.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

NOTE 9 – TAX STATUS

403(b) Thrift Plan for Employees of The Healing Lodge of the Seven Nations is a prototype non-standardized 403(b) plan. The Internal Revenue Service has issued an opinion letter to the prototype sponsor dated March 31, 2017, stating the prototype plan is acceptable under section 403(b) of the Internal Revenue Code for use by employers for the benefit of their employees. The Plan has not requested a determination letter from the Internal Revenue Service. 403(b) Thrift Plan for Employees of The Healing Lodge of the Seven Nations has adopted only standardized provisions of the prototype plan.

The Plan is subject to routine audits by taxing jurisdictions. In general, the Plan's returns are subject to examination by federal tax authorities for a period of three years beginning with the later of the due date of the return or the date they are filed. There are currently no examinations in progress.
