## INDEPENDENT AUDITOR'S REPORT

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Baker Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits June 30, 2024, and 2023, and the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**Other Matter - Supplemental Schedules Required by ERISA**

The supplemental Schedule of Assets (Held at End of Year) as of June 30, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In our opinion,

- the form and content of the supplemental, other than the information in the supplemental that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**NOTE 1 - DESCRIPTION OF PLAN**

The following description of the Baker Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement, as amended, for a more complete description of the Plan's provisions.

***A. General***

The Plan is a defined contribution plan covering all eligible employees of Baker Places, Inc. (the Organization), effective July 01, 1994. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and Section 401(a) of the Internal Revenue Code (IRC).

***B. Plan Administration***

The Organization has contracted with Lincoln National Life Insurance Company and Lincoln Financial Group Trust Company, Inc. to act as the trustees, and designated National Benefits Services, LLC to serve as third-party administrator to process and maintain the records of participant data.

***C. Eligibility***

All regular employees of the Organization are eligible to participate, except for any employee covered by a collective bargaining agreement and leased employees.

***D. Contributions***

Participants may elect to contribute deferrals at the lesser of 100% of compensation or up to the Internal Revenue Service (IRS) limitations of their eligible annual pretax compensation, as defined. Additionally, if the employee has attained age 50, then the employee is eligible to make an additional catch-up contribution as specified in the Plan. This contribution cannot exceed \$7,500 in 2024. Rollovers and plan-to-plan transfers from other qualified plans are allowed.

Employer contributions may also be contributed to the Plan. The employer contribution percentage is determined each year by the Organization. The employer contributes 1% of eligible compensation for employees with more than six months but less than two years of service, and 4% of compensation for employees with two or more years of service.

Contributions are subject to certain limitations. The limits include:

***E. Refundable Contributions***

The Plan completes a non-discrimination test pursuant to IRS regulations on an annual basis. Excess contributions determined as a result of this test, if any, are netted against the participant contributions in the Statement of Changes in Net Assets Available for Benefits. For the years ended June 30, 2024, and 2023, the Plan passed the non-discrimination test.

***F. Receivable***

The Plan has participant contributions receivable amounting to \$0 and \$7,200, respectively, as of June 30, 2024 and 2023.

***G. Participant accounts and allocation***

The Plan maintains individual accounts for participants. Each participant's account is credited with the participant's contributions, allocations of (a) the Organization's contribution, (b) plan earnings and losses. Allocations are based on participant earnings or account balances as defined by the Plan document. Each participant may direct the investment of their account in any investment fund maintained by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***H. Vesting***

Participants are immediately vested in their voluntary contributions plus actual earnings (losses) thereon. Vesting in employer contributions begin after the eligibility period of six months of service, and are vested after three years of eligible service.

***I. Loan to participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or one-half (1/2) of their vested account balance. Participants are permitted to have a maximum of two loans outstanding at a time. Loan terms range from one to five years or up to 20 years for the purchase of a primary residence. The loans are secured by the vested balance in the participant's account and bear interest at a rate established by the Plan administrator. As of June 30, 2024, and 2023, interest rates on outstanding loans ranged from 4.25% to 9.50%. Principal and interest are repaid by payroll deductions. Total loans outstanding were \$128,439 and \$164,622 as of June 30, 2024 and 2023, respectively.

***J. Benefits and withdrawals***

Upon termination of service due to death, disability, retirement, or other reasons, a participant will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. A participant's nonvested balance will immediately become vested when the termination is due to death. The Plan has paid the benefits to participants amounting to \$638,861 and \$730,299, respectively, as of June 30, 2024 and 2023.

***K. Deemed Distributions***

Deemed distributions represent the unpaid principal on participant loans actively participating in the Plan who have yet to continue making payments on the outstanding notes as required under the participant loans from the participant's program. Deemed distributions for the years ended June 30, 2024 and 2023 were \$19,998 and \$10,904, respectively

***L. Administrative expenses***

The Organization has elected to pay certain administrative expenses relating to the Plan. Loan administration fees and certain investment management fees are paid by the participants through the Plan. The Plan has paid administrative expenses \$53,481, as of June 30, 2024.

***M. Forfeited Accounts***

Forfeitures of employer contribution amounts are used to offset plan expenses and reduce future employer match contributions, or any remaining amounts may be reallocated as additional contributions. As of June 30, 2024, forfeited non-vested account balances were \$258.

***N. Rollovers Contributions***

Participants may elect to rollover amounts from other qualified plans or individual retirement accounts into the Plan, provided that certain conditions are met. As of June 30, 2024, the Plan had participant rollovers amounting to \$171,897.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***A. Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America. Revenues are recognized when they are earned and expenses are recognized when they are incurred.

***B. Use of Accounting Estimates***

The preparation of financial statements in accordance with generally accepted accounting principles in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of certain assets, liabilities, and disclosures. Accordingly, the actual amount could differ from those estimates.

***C. Investment Valuation and Income Recognition***

The Plan's investments are reported at fair value, with the exception of fully benefit-responsive guaranteed investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note a 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. The net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***D. Notes receivable from participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are recorded as distributions based on the terms of the Plan agreement.

***E. Payments of Benefits***

Benefit payments to participants are recorded when paid.

**NOTE 3 - INFORMATION PREPARED AND CERTIFIED BY TRUSTEES**

The Plan Administrator, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan's independent auditor not to perform any auditing procedures with respect to the Plan's investment information and related activity, certified by the Custodians, determined to be qualified institutions by the Plan Administrator, as complete and accurate, except for comparing such information to corresponding information included in the Plan's financial statements and supplemental schedule. The Custodians have certified the completeness and accuracy of:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of June 30, 2024, and 2023;
- Net appreciation on fair value of investments, interest and dividends, and interest income on notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the year ended June 30, 2024;
- Investments and notes receivable from participants reflected on the schedule of assets (held at end of year) as of June 30, 2024 ("supplemental schedule").

The Plan's assets are held by two trustees.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

The Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

**NOTE 4 - FAIR VALUE MEASUREMENTS (CONT'D)**

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of June 30, 2024 and 2023:

*Mutual funds:* Valued at the net asset value (NAV) of shares, based on quoted market prices, held by the Plan at year-end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan management believes its valuation methodologies are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurements at the reporting date.

**NOTE 5 - INVESTMENT CONTRACTS WITH INSURANCE COMPANY**

The Plan has entered into two benefit-responsive guaranteed investment contracts with the Trustee. The Trustee maintains the contributions in a general account. The account is credited with earnings at guaranteed crediting rates and charged for Plan withdrawals and administrative expenses. The issuer is contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan, however, certain circumstances could result in the contract value being paid out over a period of time. Therefore, this contract is considered to be benefit-responsive.

As described in the basis of accounting disclosure, because the guaranteed investment contract is fully benefit-responsive, the contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by the Trustee, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise. Interest is credited on contract balances using a fixed rate, which is reset on a semi-annual basis. The methodology for calculating the interest crediting rate is set forth within the contract with Lincoln National Life Insurance Company. Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the termination of the contract, Plan Sponsor events that cause a significant withdrawal from the Plan, complete or partial Plan termination, or the failure of the Plan to qualify for exemption from federal income taxes. The Plan administrator does not believe the occurrence of any such event is probable. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

**NOTE 6 - MISTAKE IN FACT**

During the plan year ended June 30, 2024, the Plan Sponsor identified excess employee deferral and employer matching contributions totaling \$43,900. The overfunded amounts were recorded as a liability under "Other Liabilities" in accordance with ERISA Section 403(c)(2)(A) and will be refunded to the Plan Sponsor in the subsequent plan year.

**NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by Lincoln National Life Insurance Company as defined by the Plan. Accordingly, these transactions qualify as party-in-interest transactions. Plan management believes that transactions related to such investments during the normal course of business qualify as exempt party-in-interest transactions. Participant loans also qualify as party-in-interest transactions.

**NOTE 8 - TAX STATUS**

The Plan is designed through a prototype plan and the prototype sponsor as well as the Plan's sponsor believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code (IRC) and has no income subject to business tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 9 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts. The Plan Administrator will facilitate the distribution of account balances in a single lump sum payment to each participant in accordance with the Plan provisions until all assets have been distributed by the trustee.

**NOTE 10 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 11 - ERISA FIDELITY BOND**

In accordance with ERISA Section 412, the Plan covers a fidelity bond intended to protect the Plan from the risk of loss due to fraud or dishonesty on the part of persons who handle funds or other property on behalf of the Plan.

**NOTE 12 - EVALUATION OF SUBSEQUENT EVENTS**

The Plan's management has evaluated all subsequent events through October 22, 2025, the date on which the financial statements were available to be issued, and have determined that no adjustments are necessary to the amounts reported in the accompanying financial statements, nor have any subsequent events occurred, the nature of which would require disclosure.
