Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Kama'aina Care 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)"). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of June 30, 2024 and 2023, and for the year ended June 30, 2024, stating that the certified investment information, as described in Note 9 to the financial statements, is complete and accurate.

Opinion

Note 1 - Description of Plan

The following description of the Kama'aina Care 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all eligible employees of Kama'aina Care, Inc. (the "Organization", "Employer", or "Plan Sponsor"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan administrator is responsible for oversight of the Plan. The Organization's management determines the appropriateness of the Plan's investment offering and monitors investment performance.

Eligibility

Employees who are at least 18 years old and have completed one year of service are eligible to participate in the Plan. The entry dates are the first day of the Plan year or the first day of the seventh month of the Plan year coinciding with or next following the date the eligibility requirements are met.

Contributions

Each year, eligible participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. Contributions are made through payroll deductions and consist of 401(k) contributions and Roth 401(k) contributions. In addition, participants 50 years of age or older are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% and their contribution invested in a designated balanced fund until changed by the participant.

Effective July 1, 2023, the Organization contributes a safe-harbor match of 100% of each participant's salary deferral up to 6% of eligible compensation. The Organization may also elect to make flexible discretionary matching and/or nonelective contributions to the Plan subject to limitations imposed by applicable provisions of the Internal Revenue Code ("IRC"). There were no discretionary contributions made for the year ended June 30, 2024. Participants also direct the investment of Organization contributions.

Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

Participant accounts

Each participant's account is credited with the participant's contributions, Organization contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their salary deferral, rollover contributions, safe-harbor match and any Qualified Non-Elective Employer contributions plus related actual earnings thereon. Vesting in the Organization's discretionary matching and nonelective contributions plus earnings

thereon is based on years of continuous service. A participant is 20% vested in employer discretionary contributions after two years of service and then vest 20% for each year thereafter until fully vested after six years of continuous service.

Payment of benefits

Upon termination of service due to death, disability or early or normal retirement, the participant or the participant's beneficiaries are automatically 100% vested and are entitled to receive the entire contents of the account and may elect to receive either a lump-sum distribution or equal installment payments. Upon termination of service due to other reasons, a participant may receive only the value of the vested interest in his or her account. In the event a participant's vested account balance is less than \$5,000, the balance will be paid in a lump-sum distribution as soon as administratively feasible upon termination of employment. In addition, hardship distributions are permitted if certain criteria are met.

Forfeited accounts

Forfeitures of terminated participant's nonvested accounts arising from the discretionary Organization contributions are retained by the Plan and may be used to pay administrative expenses or to reduce future employer contributions to the Plan. At June 30, 2024 and 2023, forfeited nonvested accounts totaled \$369 and \$501, respectively. During the Plan year ended June 30, 2024, forfeitures of \$157 were used to reduce employer contributions.

Note 2 - Summary of accounting policies

Basis of accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Organization's management determines the Plan's valuation policies utilizing information provided by the investment advisers and custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. Investment-related expenses are included in net appreciation of fair value of investments.

Subsequent events

The Plan has evaluated subsequent events through September 29, 2025, the date the financial statements were available to be issued.

Note 3 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board issued Accounting Standards Codification 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability; and
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

Money market and mutual funds: Valued at the daily closing price as reported by the fund. Money market and mutual funds held by the Plan are open-end money market and mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The money market and mutual funds held by the Plan are deemed to be actively traded.

Common collective trusts: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment

adviser reserves the right to temporarily delay withdrawal from the trust to ensure that securities liquidations will be carried out in an orderly business manner.

Note 4 - Fully benefit-responsive investment contract

The Plan is invested in a Stable Value Guaranteed Income Fund which is provided under a group annuity contract issued by John Hancock Life Insurance Company ("John Hancock"). Such contract is a traditional investment contract (guaranteed investment contract), and it does not have a maturity date. The contract meets the fully benefit-responsive investment criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully-benefit responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses. As of June 30, 2024 and 2023, the balance held in the Stable Value Guaranteed Income Fund was \$17,024 and \$0, respectively.

The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer and may not be less than 1.0%. The annual crediting rate is reviewed on each January 1st and July 1st.

The fund is part of the general assets of John Hancock (its general account). The Plan does not own any underlying securities of John Hancock's general account. John Hancock considers the Stable Value Guaranteed Income Fund to be a benefit-responsive fund. Under the terms of the contract, participants are generally permitted to make benefit distributions and transfers from the Stable Value Guaranteed Income Fund to noncompeting funds at contract value.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Example of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the IRC or the failure of the trust to be tax-exempt under Section 401(a) of the IRC.
2. Premature termination of the contracts.
3. Plan termination or merger.
4. Changes to the Plans' prohibition on competing investment options.
5. Bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Example of such events include the following:

1. An uncured violation of the Plan's investment guidelines;
2. A breach of material obligation under the contract;
3. A material misrepresentation; and

4. A material amendment to the agreements without the consent of the issuer.

Note 5 - Related party transactions and party-in-interest transactions

The Plan invests in a variety of investment vehicles, including collective trust funds managed by John Hancock Retirement Plan Services, LLC ("JHRPS"). JHRPS also provides administrative services to the Plan. JHRPS is the trustee as defined by Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for administration and record-keeping amounted to \$17,492 for the year ended June 30, 2024.

Note 6 - Plan termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in all of their employer contributions.

Note 7 - Tax status

The underlying nonstandard pre-approved plan obtained its latest opinion letter dated June 30, 2020, in which the IRS stated that the form of the Plan, as then designed was in compliance with the IRC and, therefore, the related trust was tax-exempt. Although the Plan has been amended since receiving the latest opinion letter, the Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 - Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9 - Certified investments

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments held at June 30, 2024 and 2023, and investment income for the year ended June 30, 2024, that are disclosed in the accompanying financial statements and supplemental schedule, were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by John Hancock Trust Company LLC, the trustee of the Plan.
