*Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Moore Capital Management, LP 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

#### Note 1 - Description of Plan

The following description of the Moore Capital Management, LP 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### **General**

The Plan is a defined contribution plan covering all employees of Moore Capital Management, LP, (the "Company"), Moore Capital Management, LLC, Belvedere Property Management, LLC and Moore Charitable Foundation, Inc (collectively, the "Companies"). All employees regardless of age are immediately eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Charles Schwab Trust Bank (the "Trustee") is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Trustee.

##### **Participant contributions**

Participants may make contributions to the Plan from 1% and up to 50% of their annual compensation, as defined in the Plan, up to \$23,000 for 2024 on a pre-tax or post-tax basis in accordance with Section 401(k) of the Internal Revenue Code (the "Code"). Participants who have attained age 50 before the end of the Plan year are also eligible to make catch-up contributions. The maximum catch-up contribution for 2024 is \$7,500. Plan participants are 100% vested in their respective contributions in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan also includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan after 45 days unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. All participants with deferral rates between 1% and 11% will be subject to an Automatic Savings Increase Program, whereby their deferral automatically increases by 1% annually on April 1st of each year unless the participant elects otherwise. Effective January 1, 2025, the Plan permits increased amounts of catch-up contributions for eligible participants who will attain ages 60-63 as of the close of the taxable year. The increased catch-up contributions shall be the greater of \$10,000 per year or 150% of the regular amount of catch-up contribution made by a participant in the taxable year.

##### **Employer contributions**

The Companies may contribute a discretionary pre-tax match each year. The matching Companies' contribution is invested based on the existing allocation of the respective employee. For 2024, the Companies made a discretionary pre-tax matching contribution of \$811,932, which was contributed on March 13, 2025 and recorded as a receivable on the statement of net assets available for benefits. Additional profit sharing amounts may be contributed at the option of the Company's board of directors not to exceed the lesser of \$44,000 or 100% of annual compensation. For 2024, the Company did not make a profit sharing contribution to the Plan. Employer contributions are transferred to the participants account during the first quarter of the next fiscal year. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

#### Note 1 - Description of plan (continued)

##### Participant accounts

Each participant's account is credited with the participant's contributions and the Companies' matching contributions, as well as allocations of the Companies' profit sharing contribution Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### Vesting

Vesting of employer contributions occurs immediately if the participant's employment is terminated as a result of attaining the normal retirement age of 65, early retirement, disability, or death. Otherwise, the vesting of benefits is in accordance with the schedule set forth below:

##### Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance and a reasonable rate of interest will be charged. The loans must be repaid within a maximum of a five-year period unless the loan is for the sole purpose of buying a principal residence. The loans are secured by the balance in the participant's account. Principal and interest is paid ratably through monthly payroll deductions.

##### Payment of benefits

A participant may elect, after attaining the age of 59 ½, to withdraw all or any portion of the value of his or her account. Participants are permitted to make withdrawals before the age of 59 ½ only after meeting specified financial hardship criteria and approval of the Plan Administrator, or after employee is terminated from service due to death, disability, or retirement. Any taxable withdrawals to participants from this Plan prior to the attainment of age 59 ½ which are not rolled over into an Individual Retirement Account or other qualified plan may be subject to a 10% penalty by the IRS. Distributions are paid as defined in the Plan document.

##### Forfeited accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$94,840 and \$69,953, respectively. During 2024, \$69,953 of forfeitures were used to reduce the Companies' contributions to the Plan.

#### Note 2 - Summary of accounting policies

##### **Basis of accounting**

The financial statements of the Plan have been prepared in accordance with accounting principles generally accepted in the United States of America ("GAAP") and are presented on the accrual basis of accounting.

##### **Use of estimates**

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from these estimates.

##### **Investment valuation and income recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### **Contributions**

Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from compensation.

##### **Notes receivable from participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

##### **Payment of benefits**

Benefits are recorded when paid.

##### **Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

##### **Subsequent events**

The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

#### Note 3 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") issued Accounting Standards Codification ("ASC") 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability; and
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Participant directed brokerage accounts:* Accounts primarily consist of mutual funds and common stocks that are valued on the basis of readily determinable market prices. Accounts also include money market funds. Money market funds are measured at the closing price reported on the major markets on which the funds trade.

If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

#### Note 4 - Related party transactions and party-in-interest transactions

Certain Plan investments were invested in funds managed by the Trustee or its affiliates, therefore, these transactions qualify as party-in-interest transactions.

Certain officers and employees of the Plan Administrator (who may also be participants in the Plan) perform administrative services related to the Plan's operations, record-keeping and financial reporting. The Plan Administrator pays these individuals' salaries and also pays all other administrative expenses on the Plan's behalf.

The foregoing transactions are not deemed prohibited party-in-interest transactions, because they are covered by statutory and administrative exemptions from the Code and ERISA's rules on prohibited transactions.

#### Note 5 - Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

#### **Note 6 - Tax status**

The Company has adopted a prototype volume submitter plan which received a favorable opinion letter dated September 21, 2020, in which the IRS stated that the Plan, as then designed, was in accordance with applicable sections of the Code. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Code and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 7 - Risks and uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

#### **Note 8 - Certified investments**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Investments and notes receivable from participants held at December 31, 2024 and 2023, and investment income, and interest income on notes receivable from participants for the year ended December 31, 2024, that is disclosed in the accompanying financial statements and supplemental schedule, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Charles Schwab Trust Bank, the Trustee of the Plan.

#### **Note 9 - Nonexempt transactions**

As reported on the supplemental Schedule of Delinquent Participant Contributions (Schedule H, Line 4a), certain Plan contributions were not remitted to the trust within the time frame specified by the DOL's Regulation 29 (CFR 2510.3-102), thus constituting nonexempt transactions between the Plan and the Company. There were unintentional delays by the Company in submitting certain employee salary deferral contributions and participant loan repayments totaling \$20,379, pertaining to the year ended December 31, 2024.
