### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of Tortoise 401(k) Plan (formerly known as TortoiseEcofin 401(k) Plan) ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

### NOTES TO FINANCIAL STATEMENTS

(1) **Description of plan**

The following description of the Tortoise 401(k) Plan (formerly known as TortoiseEcofin 401(k) Plan) (the “Plan”) provides only general information. Participants should refer to the Plan document or Summary Plan Description for a more complete description of the Plan’s provisions, which are available from the plan administrator.

**General** - The Plan is a defined contribution plan sponsored by Tortoise Parent Holdco LLC (formerly known as TortoiseEcofin Parent Holdco LLC) (the “Company”) for the benefit of its full-time employees. Union employees, temporary employees, employees classified as independent contractors, interns, and non-resident aliens are excluded from participation in the Plan. The following affiliated companies have adopted this Plan as adopting employers: TI Services, LLC; Tortoise Capital Advisors, LLC (d/b/a TCA Advisors); Tortoise Index Solutions LLC (d/b/a TIS Advisors); Tortoise Investment Partners, LLC (known as TortoiseEcofin Investment Partners, LLC, dissolved effective March 18, 2024); Tortoise Securities, LLC (known as TortoiseEcofin Securities, LLC, dissolved effective February 8, 2024); and Ecofin Advisors, LLC. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Plan is administered by the Company’s 401(k) Committee (the “Committee”), which is a committee of members of management of the Company. The Committee has overall responsibility for the operation and administration of the Plan.

**Plan amendment** - Effective September 17, 2024, the Plan was amended to change the plan sponsor from TortoiseEcofin Parent Holdco LLC to Tortoise Parent Holdco LLC. In addition, the Plan was amended to change the name of the Plan from TortoiseEcofin 401(k) Plan to Tortoise 401(k) Plan.

Under the provisions of Secure 2.0 Act, effective January 1, 2024, the automatic force out distribution limit was increased from \$5,000 to \$7,000. The Plan implemented this change and will be amended for this provision by the time prescribed.

**Contributions** - Each year, participants may contribute up to 100% of annual compensation as pre-tax or Roth contributions, as defined in the Plan. Participants may also make after-tax employee contributions up to 10% of eligible compensation. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Additionally, participants aged 50 or older, who are making contributions to the Plan, are allowed to make catch-up contributions as defined in the Plan. Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan, make a flat dollar election, or elect to withhold a different percentage of compensation. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation. The automatic deferral percentage will increase by 1% per year up to a maximum of 9% of eligible compensation. The Company may make a non-safe harbor matching contribution. The Company contributed 50% of the first 6% of the eligible compensation that a participant contributed to the Plan. Additional discretionary non-elective contributions may be contributed at the option of the Company.

## NOTES TO FINANCIAL STATEMENTS

### (1) Description of plan (continued)

For the years ending December 31, 2024 and 2023, no discretionary non-elective contributions were made. Contributions are subject to certain Internal Revenue Code ("IRC") limitations.

**Participant investment account options** - The Plan currently offers various mutual funds, a stable value common collective trust, and a self-directed brokerage account as investment options for participants. Each investment option has its own investment strategy, which can be obtained through the prospectus of the respective fund. Participants may change their investment options at any time.

**Participant accounts** - Each participant's account is credited with the participant's contribution and allocations of (a) the Company's matching contribution (if any) and (b) plan earnings (losses) and (c) charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** - Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of service. A participant is 100% vested after three years of vesting service.

If a participant was in the Mariner Holdings, Inc. 401(k) Plan and an employee of Mariner Holdings, LLC on December 31, 2017, and became an employee of the Company as of January 1, 2018, the participant's vested interest in the non-safe harbor matching contributions is 100%.

If a participant was in the Mariner Holdings, Inc. 401(k) Plan and terminated employment with Mariner Holdings, LLC on or before December 31, 2017, the participant's vested interest in the non-safe harbor matching contributions is subject to the following vesting schedule:

**Notes receivable from participants** - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions.

## NOTES TO FINANCIAL STATEMENTS

### (1) Description of plan (continued)

**Payment of benefits** - Upon termination for any reason, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest. If a participant's vested account balance is \$7,000 or less it will be distributed in a lump sum or, if elected, rolled over to another qualified retirement plan or to an individual retirement account. If the vested account balance is less than \$1,000 and the participant has not elected to receive a distribution from the Plan, the amount will be paid to the participant as a lump sum. If the vested balance is between \$1,000 and \$7,000 and the participant has not elected to receive a distribution from the Plan, the amount will be rolled into an individual retirement account established for the participant.

**Forfeited accounts** - At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$16,576 and \$8,347, respectively. These accounts will be used to reduce future employer contributions or pay administrative expenses. Also, for the years ended December 31, 2024 and 2023, employer contributions were reduced by \$8,347 and \$4,708, respectively from forfeited nonvested accounts.

### (2) Summary of significant accounting policies

**Basis of accounting** - The financial statements of the Plan are prepared on the accrual method of accounting.

**Use of estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Investment valuation and income recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Committee agrees upon the Plan's valuation policies utilizing information provided by the investment trustees. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as those held during the year.

**Contributions** - Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

**Notes receivable from participants** - Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

**Payment of benefits** - Benefits are recorded when paid.

#### ( 2 ) Summary of significant accounting policies (continued)

**Administrative expenses** - Certain expenses of the Plan are paid by the Company and are not included in the statements of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investment.

#### ( 3 ) Information prepared and certified by the trustee

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Charles Schwab Trust Bank, the trustee of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule are complete and accurate with respect to investments:

- Investments at fair value
- Notes receivable from participants
- Net appreciation in fair value of investments
- Interest
- Dividends
- Interest income from notes receivable from participants
- Schedule of assets (held at end of year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

#### ( 4 ) Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 are described below:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2      Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Stable value common collective trust:* The fund is composed primarily of fully benefit-responsive investment contracts and is valued at the NAV of units of the bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

*Common stocks and exchange traded funds:* Valued at the closing price reported on the active market on which the individual securities are traded.

*Interest bearing cash:* Stated at cost, which approximates fair value.

*U.S. government securities:* Valued using pricing models maximizing the use of observable inputs for similar securities.

### ( 5 ) Related party transactions and party-in-interest transactions

Participants can direct contributions into a self-directed brokerage account managed by Charles Schwab Trust Bank. Charles Schwab Trust Bank is the trustee as defined by the Plan and therefore, these transactions qualify as party-in-interest transactions. The Plan offers certain mutual funds managed by Tortoise Parent Holdco LLC (formerly known as TortoiseEcofin Parent Holdco LLC), the Plan Sponsor, therefore these transactions qualify as party-in-interest transactions. Also, transactions with the third-party administrator and investment advisor qualify as party-in-interest transactions. The Plan made direct payments to the third party administrator and its affiliate of \$28,225 and \$24,708 for the years ended December 31, 2024 and 2023, respectively. The Plan made direct payments to Mariner Retirement Advisors of \$43,455 and \$36,192 for the years ended December 31, 2024 and 2023, respectively. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment. The Plan paid certain expenses related to the Plan's operations and investment activity to various service providers. These transactions are party-in-interest transactions. The Plan Sponsor pays directly any other fees related to the Plan's operations.

### ( 6 ) Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

As a result of a sale of certain Company divisions in 2024, the Plan experienced a partial plan termination under the IRC. A partial plan termination may occur if a significant percentage of the Plan participants are terminated because of an action taken by the Company. If a partial plan termination occurs, full vesting of the Company's contribution is required for the affected participants. All affected employees who were participants in the Plan will be fully vested in their account balances at the date of the partial plan termination.

### NOTES TO FINANCIAL STATEMENTS

#### ( 7 ) Tax status

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (“IRS”) dated September 21, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### ( 8 ) Risks, uncertainties and concentrations

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rates, market, and credit risk. Market risks include global events which could impact on the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits, participants’ account balances, and the amounts reported in the statement of net assets available for benefits.

At December 31, 2024 and 2023, approximately 21% and 20% of the Plan’s investments were invested in the Vanguard 500 Index Admiral Fund.

#### ( 9 ) Subsequent events

The Plan has evaluated subsequent events through October 10, 2025, which is the date the financial statements were available to be issued and noted the following item for disclosure:

Tortoise Index Solutions LLC (d/b/a TIS Advisors) and Ecofin Advisors, LLC were dissolved July 2025.
