This message is to explain and request penalty relief for the late filing of our Form 5500 for plan #297092. Tax Year 2024

This was our first time filing late, and it was an unintentional oversight.

We rely on ADP to manage our retirement plan and send filing reminders, but unfortunately, those reminders went to spam or were missed due to high email volume. As soon as I realized the error, I filed promptly and have since added multiple safeguards – including annual calendar reminders, internal notifications, and updated email filters – to ensure this does not happen again.

We take compliance seriously and respectfully request consideration for penalty abatement based on our good faith effort to correct and prevent future issues.
