The liability under the unit credit cost method is the value of the accrued pension benefit using service and pay as of the valuation date. The sum of the present value of the accrued benefits for all participants is the ERISA funding target. The normal cost is the present value of the benefits earned during the year. The target normal cost is the sum of the normal costs for all participants and the assumed administrative expenses.

Changes in Method from Prior Year and Rationale for Changes

Effective for this 2025 Plan Year, the valuation date was changed from the last day of the Plan Year to the first day of the Plan Year. This change meets the requirements for automatic approval in accordance with IRS Revenue Procedure 2017-56.




