1. DESCRIPTION OF PLAN:

The following brief description of the Able Health Care Services, Inc. (the “Company”) 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the provisions of the plan.

General:

The Plan is a defined contribution plan covering all full-time, non-union employees of the Able Health Care Services, Inc. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustee of the company also serves as the Board of Trustees of the plan. Empower Retirement Services, a division of Great-West Trust Company determines the appropriateness of the Plan’s investment offerings, monitors investment performance, and reports to the Plan’s trustee. The plan’s effective date is January 1, 1999.

Eligibility:

Employees are eligible to participate in the plan at the next plan entry date subsequent to having completed one full year of service and attaining age 21.

Employee Contributions:

Each year, participants may contribute an amount equal to the percentage of the contributing participant’s compensation, as defined in the plan. The plan permits employees who are 50 years and over to make catch-up contributions. Participants may also contribute amount representing distributions from other-qualified defined benefit or defined contribution plans (roller). Participants direct the investment of their contributions and employer contributions into various investment options offered by the plan.

Employer Contributions:

The Company may match up to 25% of employee’s elective deferrals or 1% of gross compensation (which is calculated as 25% of 4% of employee’s gross compensation), whichever is less. The company made matching contributions of approximately \$61,879 for the year ended December 31, 2024. The employer may also elect to make non-elective annual profit-sharing contributions which are allocated to all eligible participants in the plan.

CARES Act

On March 27, 2020, the CARES Act was signed into law. This aid package was designed to help the economy from the effects of the coronavirus pandemic, several of the provisions of CARES Act affected employee benefit plans. The provisions of the CARES Act were optional. During 2023, the plan has opted into the following provisions.

- Hardship Distributions – Qualified plan participants were permitted to take a coronavirus related distribution of up to \$100,000 from the Plan without a 10 percent early withdrawal penalty. Eligible distributions were permitted to be taken until December 31, 2023. Distributions may be repaid within three years, or a participant may elect these distributions to be included in taxable income on a pro rata basis over three years.
- Participant Loans- Participants may have borrowed up to \$100,000 during 2023 (an increase from \$50,000 previously permitted), these repayments may be delayed to 2023.
- Required Minimum Distributions (RMDs) – A temporary waiver of required minimum distributions rules permitted participants to suspend their RMDs for participants that turned 70 1/2 in 2021 and 72 in 2023.

Limitations:

Congress limits the annual dollar amount of Elective Deferrals that a participant may contribute. For 2023, the limit was \$23,000. The amount for catch-up contributions allowed in 2024 was \$7,500. Congress also limits the annual eligible earnings to be considered for the purpose of qualified plan contributions and testing. For 2024, this limit was \$345,000.

Participants' Accounts:

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and, (b) Plan earnings. Allocations are based on participant's earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

Participants are immediately vested in their contributions and company matching contributions plus actual earnings thereon. Vesting in the company's profit-sharing contributions is based on years of continuous service. A participant is fully vested after six years of continuous service.

Participant Loans:

Except as described above, participants may borrow from their fund accounts a minimum of \$1,000 up to 50% of their vested account balance to a maximum of \$50,000. Loans may not be funded from Roth designated accounts. The loans are secured by the balance in the participant's account and bear a reasonable interest rate. Principal and Interest is paid ratably through payroll deductions.

Payment of Benefits:

On termination of service due to death, disability, or retirement, a participant will be given a lump-sum distribution equal to the participant's vested interest in his or her accounts. For termination of service due to other reasons, a participant may receive the value of the vested interest in his/her account as a lump-sum distribution.

Forfeitures:

Forfeitures will be allocated to pay plan expenses, to reduce the employers match and as a non-elective contribution. On December 31, 2024, and 2023, there were \$0 and \$70,875 in forfeitures respectively. Unallocated forfeited balance as of December 31, 2024, and 2023 were not material.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Investment Valuation and Income Recognition

Investments are reported at fair value. The fair value of a financial statement is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Shares of mutual funds and common/collective trusts are valued at market prices as determined by Fidelity, the Custodian, which represents the net asset value of shares held by the Plan at the year-end. Purchases and sales of mutual funds and common/collective trusts are recorded on a settlement date basis. Mutual funds and common/collective trusts dividends are recorded when paid. Benefits and withdrawals are recorded when paid.

Corrective Distributions

Corrective distributions represent refunds due to participants for contributions made in excess of the amount allowed by Plan provisions. These amounts are generally reimbursed to the participants in the subsequent year.

Administrative Expenses

All actuarial and audit fees for the Plan are paid by the company whereas the plan administration & investment advisory fees are paid by the plan.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, as well as disclosures of contingent assets and liabilities. Actual result could differ from those estimates.

3. FAIR VALUE MEASUREMENTS:

Financial Accounting Standards board (“FASB”) Accounting Standards Codification (“ASC”) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1:

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2:

Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the assets or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term the asset or liability.

Level 3:

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2018.

Mutual funds: Valued at the quoted market prices that represent the net asset value of shares held by the Plan at year end.

Common/ collective funds: Valued at the quoted market prices.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. INVESTMENTS

The plan's investments are held in trust by the trustee. The plan's trust agreement requires the trustee to invest the plan's assets into various investment fund options as directed by each participant through web portal.

During 2024, the Plan's investments (including gains and losses on investment bought and sold, as well as held during the year) appreciation (depreciation) resulted primarily from mutual funds.

5. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under DOL Regulations as any fiduciary of the Plan, any party rendering service to the plan, the company, and other certain matters. Participants' loans are also considered party-in-interest transactions. Fees paid by the plan for management services were included as a reduction of the return earned one each fund.

6. CONCENTRATION OF CREDIT RISK

In the normal course of business, all of the Plan's assets are transacted with and held by the Trustee. The plan is subject to credit risk to the extent the Trustee is unable to fulfill contractual obligations on its behalf. The company has not experienced and does not expect any loss from this arrangement.

The plan invests in various investment types. Those investments are exposed to various risks, such as interest rate, credit, and overall market volatility risk. Due to the level of risk associated with certain mutual funds, it is at least reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the Statements of Net Assets Available for Benefits.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the company has the right under the plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

8. TAX STATUS

The underlying nonstandard prototype plan has received an opinion letter from Internal Revenue Service (IRS) dated March 31, 2014, stating that the form of the plan is qualified under section 401 (a) of the code and, therefore, the related trust is tax-exempt. In accordance with Revenue procedures 2006-6, the plan sponsor has determined that it is eligible to and has chosen to rely on

the current IRS prototype plan opinion letter. Once qualified, the plan is required to operate in conformity with the code to maintain its qualification. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the code and, therefore, believes that the plan is qualified, and the related trust is non-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan is subject to routine audits by tax jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for year prior to 2017.
