Opinion

We have audited the financial statements of United Independent Union Welfare Fund, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and plan's benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and changes in plan's benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits and plan's benefit obligations of United Independent Union Welfare Fund as of December 31, 2024 and 2023, and the changes in its net assets available for benefits and changes in plan's benefit obligations for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of United Independent Union Welfare Fund Employee Benefit Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about United Independent Union Welfare Fund's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

A. Purpose of Organization

United Independent Union Welfare Fund (“The Fund or The Plan”) was established on October 1, 1962, as a multiemployer Health and Welfare Fund to provide quality health and welfare benefits to all participants under the terms of the collective bargaining agreement in effect.

B. Description of the Plan

The following description of the United Independent Union Welfare Fund provides only general information. Participants should refer to the Plan agreements for a more complete description of the Plan's provisions.

General

The Plan provides health and death benefits covering substantially all eligible employees of participating companies. An employee is eligible if they work for a contributing employer who is obligated to make contributions to the Plan on their behalf. The length of the eligibility period and the date the participant enters the Plan is dependent on the terms of the collective bargaining agreement with the employer that the participant works. In addition, the Plan provides legal benefits and services to all eligible members and their family groups. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Benefits

Insured Benefits

The Plan offers two Point of Service Plan held with Independence Blue Cross and AmeriHealth that provide health benefits (hospital, surgical, and major medical). The Plan also provides fully insured dental, vision, and life insurance benefits for basic life and accident coverage. The Plan also provides a continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Self-Insured Benefits

Sickness and accident benefits are sixty percent of weekly base earnings, not to exceed the maximum. Maximum benefits for home illness participants are \$100 per week up to thirteen weeks with a fifteen-day waiting period. Maximum benefits for hospital stay participants are paid \$125 per week up to twenty-six weeks with no waiting period.

Legal benefits service and representation shall be provided by the Plan Attorney without charge as provided by the Plan or at a discounted rate. For those cases where a fee or charge is indicated, payment is the responsibility of the plan member. Each year, each family group will be entitled to four consultations with the Plan Attorney at his office.

Prescription Benefits are processed through a Pharmacy Benefit Manager (PBM) under an administrative service only (ASO) arrangement. The claims processor pays claims directly to providers and then is reimbursed by the Plan. Despite the use of the claims processor, the ultimate responsibility for payments to providers is retained by the Plan.

C. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with the accounting principles generally accepted in the United States of America as contained in accounting standards codification for Plan accounting ASC 965 issued by the Financial Accounting Standard Board (FASB).

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Payment of Benefits

Premiums paid by the Plan are recorded when paid as premium payments in the accompanying statement of changes in net assets available for benefits.

Claim payments processed by claims processors or pharmacy benefit managers are recorded as paid when the Plan reimburses the service provider. Amounts due to claims processors or pharmacy benefit managers that have not yet been reimbursed by the Plan are recorded in the Statement of Plan's Benefit Obligations.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by its investment advisers, custodians, and the insurance company. See note H for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

The employer contributions are made in accordance with the collective bargaining agreements or amendments between the employers and the Union. These contributions are recognized as an addition to net assets in the month they become due.

Employers' contributions receivable represent amounts due as of December 31, 2024 and 2023 under the terms of the collective bargaining agreement in effect. Interest is accrued on receivables in an amount equal to the greater of the rate set by U.S.C.A. 6621 or liquidated damages set at 20% of the unpaid contributions.

Allowance for Credit Losses

When the Plan records contributions receivables, the Plan records an allowance for credit losses for the current expected credit losses (CECL) inherent in the asset over its expected life. The allowance for credit losses is a valuation account deducted from the amortized cost basis of the assets to present their net carrying value at the amount expected to be collected. Each period the allowance for credit losses is adjusted through earnings to reflect expected credit losses over the remaining lives of the assets.

Furniture and Equipment

Furniture and equipment are stated at cost and are being depreciated under the straight-line method and depreciated over ten-year lives.

Rebates and Refunds

Refunds due from the Plan's insurance carrier are recorded when earned. Refunds due as of the financial statement date have been reported as receivable, with the offset being netted against claims paid. Rebates totaling \$94,591 and \$84,260 have been netted with claims paid in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024 and 2023, respectively.

Accounting Standards Issued But Not Yet Adopted

The Company believes that any new accounting standard issued during the year but not yet adopted will not have a material impact on these financial statements.

Date of Management's Review

Subsequent events have been evaluated through October 9, 2025, which is the date the financial statements were available to be issued.

D. Benefit Obligations

Plan benefit obligations represent health costs incurred by participants and their beneficiaries and dependents during the years ended December 31, 2024 or 2023 but not yet paid. It is the present intention of the Plan to continue obtaining insurance coverage for benefits.

E. Lease

The Fund leases certain office equipment under long-term operating lease arrangements for a period of five years ending May 31, 2029, and the total operating lease payment for office equipment is \$5,740 per year. During the years ended December 31, 2024 and 2023, equipment rental expenses were \$3,370 and \$7,421, respectively.

The United Independent Union leases space to the Fund under a cancellable lease. The Fund paid rent of \$15,808 and \$25,851 for the years ended December 31, 2024 and 2023, respectively. The lease is for a five-year period ending July 31, 2029 with minimum monthly lease payments of \$1,976, and the lessor has the option to increase the rent based on the United States Bureau of Labor Statistics Consumer Price Index for Urban Wage Earners and Clerical Workers, All Items, Philadelphia-Wilmington-Atlantic City. This lease has been excluded from the right of use asset and lease liability.

The Fund's leases have been determined to be cancellable therefore no asset or liability has been recorded.

F. Plan Termination

It is the intent of the trustees to continue the Plan in full force and effect. However, in the event the obligation of employers to make contributions shall terminate, the trustees shall continue to apply the Plan to the purpose for which it was formed. Upon disbursement of the entire Plan, the trust shall terminate. Discontinuance or termination shall not permit any part of the Plan to be used for, or diverted to, purposes other than the exclusive benefit of the participants.

G. Related Party Transactions

The Fund entered into an administration agreement with United Independent Union to provide administrative services on a shared cost basis. A percentage of the costs are shared with the United Independent Union Pension Fund.

For years ending December 31, 2024 and 2023 the Fund paid \$136,533 and \$103,274, respectively for these administrative services. Additionally, the Fund has a lease agreement with the United Independent Union for the rental of office space, see footnote E for additional details.

The Fund pays certain administration expenses for which it is reimbursed a percentage of these expenses from the United Independent Union and the Pension Fund. For the years ending December 31, 2024 and 2023 the total amount reimbursed was \$35,405 and \$46,520, respectively.

The third-party administrator (TPA) and United Independent Union (UIU) are contributing employers with the Fund. The TPA made contributions of \$36,140 and \$30,240 with a receivable due to the Plan of \$6,638 and \$3,688 for the years ended December 31, 2024 and 2023, respectively. The Labor Union made contributions to the Fund of \$31,878 and 35,877, for the years ended December 31, 2024 and 2023, respectively. The Fund paid the third-party administrator \$76,019 and \$74,077 for services rendered during the years ended December 31, 2024 and 2023.

H. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The fair value measurement level of investments within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered Investment Companies: valued at the daily closing price as reported by the fund. Investments consist of a money market fund and open-end mutual funds registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The investments are deemed to be actively traded.

Comm/Collective Trusts: valued at net asset value (NAV) of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV.

Interest bearing cash: valued at amortized cost-plus accumulated interest, which approximates fair value.

- (a) In accordance with Subtopic 820-10, certain investments that were measured at net asset value per share (or its equivalent) have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statement of net assets available for benefits.

I. Investments

During 2024 and 2023, the Plan's investments (including investments bought, sold, and held during the year) appreciated in value by \$480,730 in 2024 and appreciated in value by \$493,767 in 2023.

The following table summarizes investments for which fair value is measured using the net asset value per share practical expedient as of December 31, 2024 and 2023, respectively. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

K. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the statement of net assets available for benefits.

L. Tax Status

The Plan obtained its latest determination letter on January 31, 1994, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRS. Therefore, no provision for income taxes has been

Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require recognition or disclosure in the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. federal, state, or local tax authorities for years before 2021.
