Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Taylored Services, LLC 401(k) Employee Savings Plan (the "Plan"), subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements (the "financial statements").

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Emphasis of Matter

As discussed in Note 1 to the financial statements, the Plan completed its merger into the Yusen Logistics (Americas) Inc 401(k) Plan on December 31, 2024 and all net assets were transferred to the Yusen Logistics (Americas) Inc 401(k) Plan on that date. As a result, the Plan ceased to exist as a separate plan. Our opinion has not been modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America; this includes the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Notes to Financial Statements December 31, 2024 and 2023

1. Description of Plan

The following description of the Taylored Services, LLC 401(k) Employee Savings Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan established in 1996 for the benefit of all full-time and part-time employees of Taylored Services, LLC (the “Company” or “Plan Sponsor”). The Company is responsible for the day-to-day administration and operation of the Plan. The Plan is intended to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code (“IRC”) and similar state tax laws. Capital Group Retirement Plan Services (“Capital Group” or “Custodian”), is the asset custodian, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Capital Group is responsible for the custody and management of the Plan’s assets.

Plan Merger

In connection with the acquisition of the Company by Yusen Logistics (Americas) Inc., the Plan completed its merger, and all net assets were transferred on December 31, 2024 to the Yusen Logistics (Americas) Inc 401(k) Plan, an existing plan sponsored by Yusen Logistics (Americas) Inc. The total net assets transferred to Yusen Logistics (Americas) Inc 401(k) Plan was \$11,184,715. As a result, the Plan ceased to exist as a separate Plan, and all nonvested participants account balances were automatically vested.

Eligibility

Employees of the Company who have reached 18 years of age and have completed three months of service are eligible to participate in the Plan.

Contributions

Each year, participants may contribute up to 92% of pretax annual compensation, subject to elective deferral limits imposed by the Internal Revenue Service (“IRS”) (\$23,000 for 2024). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to \$7,500 in 2024. The Company allows for a safe harbor match of 100% of each participant’s deferral contribution, up to 4% of the participant’s eligible compensation. All employer contributions are invested in the same manner that the participant directs his or her investments. Participants may also rollover amounts representing distributions from other qualified defined benefit or contribution plans.

1. Description of Plan (continued)

Participant Accounts

Individual accounts are maintained for each of the Plan's participants to reflect the participant's contributions, the Company's safe harbor matching contributions, profit sharing contributions, rollovers from qualified plans of the participant's previous employers, and allocations of the Plan's earnings. Allocations of the Plan's earnings are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their salary deferral contributions, plus actual earnings thereon. The portion of the participant's account attributable to the Company's safe harbor matching contributions plus actual earnings, also vests immediately. The portion of the participant's account attributable to the Company's profit-sharing contributions plus earnings, becomes 20% vested every year following two full years of service, as defined, and continues to vest at the rate of 20% for each successive year of service until 100% vested, attaining normal retirement age, death or disability. As a result of the plan merger described in Note 1, all participants became fully vested on December 31, 2024.

Investment Options

Participants may direct their salary deferral contributions to selected investments as made available and determined by the plan administrator. If the participants do not direct the investment of their applicable Plan accounts, then their accounts will be invested in accordance with the default investment alternatives established under the Plan.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of 50% of their vested account balance, or \$50,000. The loans are secured by the balance in the participant's account and bear interest at a fixed rate of prime plus 1%. Loans must be repaid within a five-year period, unless the loan is used to purchase a principal residence, in which case the plan administrator may permit a longer repayment term. Principal and interest are paid ratably through payroll deductions or directly by the participants. Participants may have no more than two loans outstanding at a time.

1. Description of Plan (continued)

Benefit Payments

On termination of service due to death, disability, retirement, or other reasons a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or a rollover of the account balance into another qualified account. Withdrawals by terminated participants, prior to the attainment of age 59½, which are not rolled over into another qualified plan, are also subject to ordinary income taxes, withholdings and penalty.

In-service account withdrawals are permitted for participants with 100% vested account balances upon the attainment of age 59½ or disability. Any withdrawals by participants prior to terminating employment with the Company and prior to age 59½ are subject to ordinary personal income taxes and penalty.

Account withdrawals are permitted by participants who suffer certain financial hardships and meet criteria established by the IRC.

Forfeitures

Forfeitures are the portion of the employer's profit-sharing contributions that is lost by a participant who terminated employment prior to becoming fully vested under the Plan's vesting schedule. Forfeited amounts can be used to offset administrative expenses or any future employer contribution. The Plan used \$6,673 of forfeitures to reduce employer contributions in 2024. At December 31, 2024 and 2023, forfeited non-vested amounts totaled \$0, and \$21,421, respectively.

2. Summary of Significant Accounting Policies

Basis of Presentation

The accompanying financial statements of the Plan are prepared under the accrual method of accounting and in conformity with accounting principles generally accepted in the United States of America ("GAAP").

Contributions and Withdrawals

Contributions by the participants are recognized in the period the participants' wages are paid, and withdrawals from the Plan for participant distributions are recognized when the amounts are paid to the participant, except for cases where refunds are due to the participants in order for the Plan to conform to IRC provisions.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements, as well as the reported amounts of additions and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or would be paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

Management fees and operating expenses charged to the Plan for its investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for applicable investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued unpaid interest. Related fees are recorded as administrative expenses and are expensed when incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses of the Plan may be paid from Plan assets; however certain expenses, such as financial reporting, are paid for by the Company.

3. Investment Information Certified by the Asset Custodians

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-5 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Therefore, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information certified by Capital Group, except for comparing such information certified by the assets custodians to information included in the Plan's financial statements. The following unaudited information regarding the Plan is included in the financial statements as of December 31, 2024 and 2023 and for the year ended December 31, 2024, and was obtained from data that had been prepared and certified as complete and accurate by the custodian: (1) the total value of investments as of December 31, 2024 and 2023, as indicated on the accompanying statements of net assets available for benefits; and (2) all investment information, as indicated on the accompanying statement of changes in net assets available for benefits.

4. Fair Value Measurements

GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below.

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology are observable, other than Level 1 prices, such as quoted prices for similar assets or liabilities; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the asset or liabilities.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

4. Fair Value Measurements (continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following are descriptions of valuation methodologies used for assets measured at fair value:

Mutual Funds (Level 1 inputs) - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price.

Common/collective trust - The Plan's indirect investment in the common/collective trust is valued at the net unit value ("NUV") of units held by the Plan at year-end based on information reported in the common/collective trust's audited financial statements at year-end. The NUV is determined by the total contract value of fund assets divided by the total number of units of the fund owned. The Plan uses a practical expedient permitting a reporting entity to measure the fair value of certain investments using the net asset value per share (or its equivalent) of the investment. Because the Plan has an indirect investment in the contracts held by the common/collective trust, they are not considered fully benefit responsive.

4. Fair Value Measurements (continued)

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

5. Party-In-Interest Transactions

Certain Plan investments are shares of mutual funds managed by American Funds. American Funds is managed by the Custodian as defined by the Plan, and, therefore, is considered a party-in-interest. As a result, these transactions qualify as “party-in-interest” transactions permitted by the DOL’s Rules and Regulations. Notes receivable from participants and the related interest income of \$16,515 are also considered permitted party-in-interest transactions.

6. Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

7. Tax Status

The Company adopted a pre-approved profit-sharing plan provided by Ascensus LLC.

The pre-approved profit-sharing plan provider received an advisory letter from the Internal Revenue Service (“IRS”), dated June 30, 2020, which stated that the pre-approved profit-sharing plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has not received a determination letter specific to the Plan. The plan administrator believes that the Plan is designed and is being operated in compliance with the applicable provisions of the IRC. Therefore, the plan administrator believes that the Plan is qualified and the related trust is tax-exempt.

7. Tax Status (continued)

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

8. Plan Termination

The Plan sponsor has the right under the Plan agreement to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. See Note 1 for further discussion.

9. Subsequent Events

In providing the disclosure contained in this note, the plan administrator evaluated events occurring between the end of the plan year and October 17, 2025, the date the accompanying financial statements were available to be issued.
