Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Other Matter - Supplemental Schedule Required by ERISA**

The supplemental schedule of assets (held at end of year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

## **NOTES TO FINANCIAL STATEMENTS**

### **1. Description of the Plan**

The following description of Trove Recommerce 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### **General:**

The Plan is a defined-contribution plan sponsored by Trove Recommerce, Inc. (the Company) for its employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan became effective on January 1, 2016. The Plan is a defined-contribution plan covering all employees of the Company except for non-resident aliens, union and temporary employees.

#### **Eligibility:**

Employees are eligible to participate immediately upon reaching 18 years of age.

#### **Contributions:**

Contributions to the Plan may include employee deferral contributions, employer matching contributions, employer discretionary profit-sharing contributions and rollover contributions.

The employer discretionary profit-sharing contributions are allocated to each participant's account based on the ratio of the participant's eligible compensation for the year to the total eligible compensation of all participants for the year. There were no profit-sharing contributions during the year ended December 31, 2024.

The Plan permits discretionary matching contributions by the Company. For the years ended December 31, 2024 and 2023, the Company elected to contribute up to 100% of each participating participant's first 4% and 3%, respectively, of eligible compensation. All participants are eligible for matching contributions.

Contributions are limited in accordance with Internal Revenue Service (IRS) regulations. Participants may also contribute amounts representing distributions from other qualified defined-benefit or defined-contribution plans.

## **NOTES TO FINANCIAL STATEMENTS (CONTINUED)**

### **1. Description of the Plan (continued)**

#### **Participant accounts:**

Each participant directs their individual investments including their share of allocated Company contributions into various investment options offered by the Plan. Each participant's account is credited with contributions, appreciation (depreciation) in fair value of investments and interest and dividend income. Allocations are based on participant earnings or account balances as defined by the Plan.

#### **Vesting:**

Participants are immediately vested in their contributions and all employer contributions plus actual earnings thereon.

#### **Participant loans:**

Participants may borrow up to the lesser of \$50,000 or 50% of their vested interest in the Plan and the loan shall not be less than \$1,000. All loans are required to be repaid within five years of the date of the loan, unless the loan is for the purchase of a primary residence, with only one outstanding loan allowable at any time. The loans are secured by balances in the participants' accounts and bear interest at the Prime rate (7.50% and 8.50% as of December 31, 2024 and 2023, respectively), plus 1.00% at the time of issuance. Interest rates on outstanding loans ranged from 4.25% to 9.50% at December 31, 2024 and 2023. Principal and interest is paid ratably through payroll deductions. Outstanding loans must be immediately repaid upon termination of employment and loan defaults are treated as distributions.

#### **Payment of benefits:**

A participant becomes entitled to benefits under the Plan upon retirement at the age of 65, permanent disability or resignation from the Company. In-service withdrawals from a participant's account balance are permitted for hardship withdrawals or upon attaining age 59 ½. Participants who terminate with an account balance greater than \$1,000 may elect to leave their account balance in the Plan.

Subsequent to year-end, the Plan was amended and participants who terminate with an account balance greater than \$5,000 may elect to leave their account balance in the Plan.

## **NOTES TO FINANCIAL STATEMENTS (CONTINUED)**

### **2. Summary of significant accounting policies**

#### **Basis of accounting:**

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America.

#### **Investment valuation and income recognition:**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date and interest income is recognized on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### **Notes receivable from participants:**

As described in Note 1, the Plan allows for participants to borrow against their vested account balance and the loan is secured by the participant's account balance. Participant loans are valued at their unpaid principal balance plus any accrued but unpaid interest.

#### **Contributions:**

Participants' contributions are recognized by the Plan when withheld from the participants' paychecks by the Company.

#### **Administrative expenses:**

Certain expenses of administering the Plan are paid by the Plan to the extent not paid by the Company. Transaction fees are paid by participants.

#### **Expense offset arrangements:**

Certain fees incurred by the Plan for investment management services and recordkeeping are included in the net appreciation (depreciation) in fair value of investments on the statement of changes in net assets available for benefits, as they are paid through revenue sharing, rather than a direct payment.

### **2. Summary of significant accounting policies (continued)**

#### **Payment of benefits:**

Benefits are recorded when paid.

#### **Use of estimates:**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

#### **Subsequent events:**

The Plan Administrator has reviewed and evaluated subsequent events through September 23, 2025, the date the financial statements were available to be issued.

### **3. Tax status**

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and the related trust are designed in accordance with applicable sections of the Internal Revenue Code (the Code). Although the Plan has been amended, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

### **4. Plan termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

During the year ended December 31, 2024, there was a partial Plan termination. This determination was made following a reduction in workforce by the Plan Sponsor, which resulted in the termination of approximately 70% of Plan participants over a 12-month period. Affected participants were already 100% vested in employer matching contributions.

### 5. Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### 6. Refunds of excess contributions

Contributions by highly compensated employees exceeded the maximum actual deferral percentage prescribed by Section 401(k)(3) of the Code during the year ended December 31, 2024. The excess contributions as of December 31, 2024 and 2023 totaling \$116,938 and \$122,088, respectively, were distributed by the Plan to the applicable participants within the allowable time frame as required by ERISA.

### 7. Investments (information prepared and certified by Matrix Trust Company (the Trustee))

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the following information included in these financial statements and supplemental schedule was obtained from data that has been prepared and certified as complete and accurate by the Trustee as of December 31, 2024 and 2023.

For the year ended December 31, 2024, the Plan's investments (including gains and losses on investments bought, sold and held during the year) appreciated in value in the amount of \$976,193, as certified by the Trustee.
