Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

## Notes to Financial Statements

December 31, 2024

### **1. Description of the Plan**

The following description of the Fresh & Ready Foods Retirement Program (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan was a defined contribution plan available to eligible employees of Bleuxus, LLC and affiliated entities (collectively, the Employer), who completed six months of service that included 500 hours and were age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Employer was responsible for the administration of the Plan and entrusted the maintenance of records and the day-to-day administration to TAG Resources (TAG) who processed transactions through Transamerica Financial Life Insurance Company (Transamerica), the custodian.

The Employer approved the termination of the Plan with an effective termination date of December 30, 2021 (termination date). In accordance with accounting principles generally accepted in the United States of America, the Plan used the liquidation basis of accounting in presenting the 2024 and 2023 financial statements. The liquidation basis of accounting did not have a significant impact on the Plan's financial statements.

As a result of the decision to terminate the Plan, effective the termination date, no new participants were admitted to the Plan, all participant accounts became fully vested and contributions ceased. The net assets of the Plan were allocated as prescribed by ERISA and its related regulations. The Plan distributed all assets to participants by May 9, 2024.

#### **Contributions**

Prior to December 30, 2021, participants could contribute up to 90% of their pre-tax annual compensation, as defined in the Plan. In addition, participants who had attained the age of 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants directed the investment of their contributions into various investment options offered by the Plan. Participants could change the investment options previously elected at any time.

Prior to December 30, 2021, eligible employees were automatically enrolled in the Plan unless they affirmatively elected not to participate. Automatically enrolled participants had their deferral rate set at 2% of eligible compensation.

#### **1. Description of the Plan (continued)**

##### **Contributions (continued)**

The Employer could make discretionary qualified nonelective contributions to the Plan; for 2024 the Employer did not make any discretionary qualified nonelective contributions.

Contributions were subject to certain Internal Revenue Service (IRS) limitations.

##### **Participant Accounts**

Each participant's account was credited with the participant's contributions, the Employer's discretionary qualified nonelective contributions and Plan earnings or losses. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account.

##### **Vesting**

Participants were immediately vested in their voluntary contributions and discretionary qualified nonelective contributions plus actual earnings on these contributions.

##### **Notes Receivable from Participants**

Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans were secured by the balance in the participant's account. The loan interest rate was set at 1% above the prime rate, as defined. Principal and interest were paid ratably through payroll deductions.

##### **Payment of Benefits**

On termination of service due to death, disability or early retirement, a participant could elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Participants electing to receive benefits after the normal retirement age could choose either a lump-sum amount or annual installments. For termination of service due to other reasons, a participant could receive the value of the vested interest in his or her account as a lump-sum distribution or roll over their account into another individual retirement account. The Plan permitted in-service and hardship withdrawals under certain conditions.

#### **1. Description of the Plan (continued)**

##### **Forfeitures**

Forfeitures were created when participants terminate employment before becoming entitled to their full benefits under the Plan and were considered nonparticipant-directed investments. Forfeitures could be used to pay administrative expenses and to reduce future Employer contributions. As of December 31, 2023 forfeited non-vested accounts held in the stable value advantage option totaled \$1,967.

#### **2. Significant Accounting Policies**

##### **Basis of Accounting**

The financial statements of the Plan were prepared on the liquidation basis of accounting.

##### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures and changes therein. Accordingly, actual results could differ from those estimates.

##### **Investment Valuation and Income Recognition**

The Plan's investments were reported at fair value except for its benefit-responsive investment contract, which is valued at contract value (Note 5). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Employer determines the Plan's valuation policies utilizing information provided by the custodian. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

##### **Contributions**

Prior to December 30, 2021, contributions from Plan participants and the discretionary qualified nonelective contributions from the Employer were recorded in the year in which the employee contributions were withheld from compensation.

#### **2. Significant Accounting Policies (continued)**

##### **Notes Receivable from Participants**

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed as incurred. No allowance for credit losses has been recorded as of May 9, 2024 and December 31, 2023. If a participant ceased to make scheduled repayments and the Plan administrator deemed the note receivable to be in default, the note receivable balance was reduced and a benefit payment recorded. There were no outstanding notes receivable from participants as of May 9, 2024 and December 31, 2023.

##### **Benefits Paid to Participants**

Benefits are recorded when paid.

##### **Administrative Expenses**

Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Employer. Expenses paid by the Employer were excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and were included in administrative expenses. Investment related expenses were included in net appreciation in fair value of investments.

##### **Subsequent Events**

The Plan has evaluated subsequent events through October 27, 2025, the date the financials were available to be issued. In connection with the Plan's termination, all plan assets were distributed by May 9, 2025.

#### **3. Certified Information**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held as of May 9, 2024 and December 31, 2023, and net depreciation in fair value of investments and interest income from stable value advantage option for the period ended May 9, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Transamerica.

#### 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets the Plan can access.
- Level 2 Inputs to the methodology include:
- Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The fair value measurement level within the fair value hierarchy for assets and liabilities is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

*Pooled separate accounts:* Valued at the net asset value (NAV) which equals the number of shares of the respective underlying fund, multiplied by the closing NAV per share quoted by that fund. The NAV is used as a practical expedient to estimate fair value.

The NAV is determined by Transamerica and is based on the fair value of the underlying assets held by the funds. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statements of net assets available for benefits.

#### 5. Group Annuity Contract

The Plan invested in a fully benefit-responsive investment contract with Transamerica totaling \$3,015 as of December 31, 2023. Transamerica maintained the contributions in a general unallocated account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The effective rate of interest was established every January 1 and July 1 and was based on the daily balance, at a rate that was the daily equivalent of the effective annual rate of interest applicable for the six-month period. There was no guaranteed minimum or maximum interest rate under this contract, no unfunded commitments, and redemption frequency and notice period could occur daily.

The contract met the fully benefit-responsive investment criteria and therefore was reported at contract value. Contract value was the relevant measurement for fully benefit-responsive investment contracts, because it was the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Transamerica, represented contributions made under the contract, plus earnings, less participant withdrawals and expenses. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

#### **6. Related Party and Party-in-Interest Transactions**

Plan investments were in accounts of Transamerica; therefore, these transactions qualified as party-in-interest transactions. Participant contributions were also considered to be party-in-interest transactions.

#### **7. Tax Status**

The Plan adopted non-standardized pre-approved profit sharing plan which had received an opinion letter dated August 17, 2021, from the IRS which stated the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe the Plan is designed and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **8. Risks and Uncertainties**

The Plan invested in various investment securities, which were exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities could occur in the near term, and that such changes could materially affect participants' account balances and amounts reported in the statements of net assets available for benefits.
