NOTES TO FINANCIAL STATEMENTS

**Note 1 - Plan Description:**

The following description of the Old Hickory Clay Co., Inc. (“Company” or “Sponsor”) 401(k) Profit Sharing Plan and Trust (“Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**General**

The Plan was formed on November 1, 2000 (inception of the Plan). The Plan is a qualified, defined contribution plan with a discretionary profit-sharing provision covering all eligible employees of the Sponsor’s controlled group. Ineligible employees consist of both summer help and on-call employees. Employees are eligible to participate in the Plan once they have completed 60 days of service. Participants may enter the Plan on the first day of the calendar month once the time eligibility criteria has been met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Sponsor’s management team oversees governance of the Plan. They determine the appropriateness of the Plan’s investment offerings, monitor investment performance, and report to the Plan Sponsor.

**Contributions**

Each year, participants may contribute up to 100% of pretax annual compensation up to the maximum permitted under law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contributions plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company may make a discretionary matching contribution equal to 100% of deferrals up to 2 percent of the participants’ eligible compensation. The matching Company contribution is invested as directed by the participant. Additionally, discretionary profit-sharing amounts may be contributed at the option of the Company. During the year ended December 31, 2024, the Company made a discretionary matching contribution to the Plan of \$131,917 and a discretionary profit-sharing contribution to the Plan of \$301,770.

**Participant Accounts**

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contributions, (b) Plan earnings (losses), and (c) charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Separate accounts are used to report employee deferrals, employee rollovers, and discretionary employer match and profit-sharing contributions because there are different Plan and IRS rules for each type of contribution.

**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s discretionary matching and profit-sharing contribution portion of their accounts plus actual earnings thereon is based on years of service. A participant is vested 20 percent after two years and 20 percent for each additional year of service.

Termination of employment for any of the following reasons results in immediate vesting of the full value of the participant’s account:

- a) Normal retirement as defined in the Plan,
- b) Total and permanent disability as defined in the Plan,
- c) Death.

**Note 1 - Plan Description (Continued):**

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 6.25% to 9.50%, which are commensurate with local prevailing rates as determined by Plan management. Principal and interest is paid ratably through monthly payroll deductions.

**Payment of Benefits**

Upon separation of service due to death, disability, retirement or termination of employment, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or partial withdrawals. The Plan allows for in-service withdrawals from rollover accounts, for in-service withdrawals for financial hardship, if certain Plan provisions are met, and for in-service withdrawals upon attainment of age 65. In the event of a mandatory distribution of \$1,000 or less, the Administrator will notify the participant of the cash out rules and give the opportunity to elect whether to receive a payment or have the payment rolled over directly to an IRA or another eligible plan.

**Forfeitures**

Forfeited non-vested accounts totaled \$0 at December 31, 2024 and 2023, respectively. Amounts that are forfeited during a Plan year are used to meet the employer's contribution obligation to the Plan or to pay Plan expenses, as directed by the Administrator. During 2024, employer contributions were reduced by \$5,036 from forfeited non-vested accounts.

**Note 2 - Summary of Significant Accounting Policies:**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Sponsor's management team determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases of sales and securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded at the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan payments and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document. These loans are considered a distribution to the participant for which a Federal 1099 tax form is issued. During 2024, the defaulted loans totaled \$26,587.

**Payment of Benefits**

Benefits are recorded when paid.

**Plan Expenses**

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in net depreciation in fair value of investments. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account.

**Note 3 - Certified Investments:**

All investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information provided to Plan management and certified as complete and accurate by American United Life Insurance Company (AUL), the custodian of the Plan.

**Note 3 - Certified Investments (Continued):**

The Plan has a fully-benefit-responsive group annuity contract (GAC) with AUL. AUL maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The GAC is included in the financial statements at contract value as reported to the Plan by AUL. The contract value represents the principal balance plus contributions, earnings, and interest, less participant withdrawals and administrative expenses.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023, was \$1,247,220 and \$1,134,400, respectively. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 0.75%. Such interest rates are reviewed on a quarterly basis for resetting.

**Note 4 - Fair Value Measurements:**

FASB Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Level 1 -** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2 -** Inputs to the valuation methodology include:

- Quoted prices for similar assets in active markets;
- Quoted prices for identical or similar assets in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset.

**Level 3 -** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled separate accounts:* Valued at net asset value (NAV) of shares held by the Plan at year end based on quoted market price. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value.

**Note 5 - Related-Party Transactions and Party in Interest Transactions:**

All Plan investments are provided through American United Life Insurance Company (AUL). AUL is the record keeper and custodian for the Plan and, therefore, these transactions qualify as party-in-interest transactions. All investment fund earnings or losses posted to each Plan participant's account are net of investment management fees charged by each investment fund under the Plan.

Certain administrative costs incurred by the Plan are paid by the Company. The total costs paid by the Company were \$15,000 during the period ended December 31, 2024.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**Note 6 - Plan Termination:**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their employer contributions.

**Note 7 - Tax Status:**

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified, and the related trust is tax-exempt.

**Note 7 - Tax Status (Continued):**

Accounting principles generally accepted in the United States of America require the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits in progress for any tax periods.

**Note 8 - Risks and Uncertainties:**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market values of investments may decline for a number of reasons, including changes in prevailing market and interest rates, increases in defaults and credit rating downgrades. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes would materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

**Note 9 - Subsequent Events:**

Subsequent events were evaluated through October 28, 2025, which is the date the financial statements were available to be issued.
