**1. Description of Plan**

The following brief description of the Strategic Alpha Inc. 401(k) Retirement Plan (the "Plan") is provided for general information purposes only. Participants should refer to the plan document for more complete description of the Plan's provisions.

***General***

The Plan is a qualified defined retirement contribution plan covering eligible employees of Strategic Alpha Inc. (the "Company" or "Employer"). Employees of the Company, excluding employees covered by a collective bargaining agreement between the Employer and employees, non-resident aliens, leased employees, and temporary employees, who have attained 21 years of age may participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

***Contributions***

Eligible employees may elect to contribute an amount or percentage of their pre-tax annual compensation, subject to limitations established by the Internal Revenue Code ("IRC"). The Plan includes an auto enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default rate set at 4% of eligible compensation. Employees who are automatically enrolled will be automatically increased by 1% annually up to a maximum of 10% of eligible compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution retirement plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company makes a safe-harbor Employer matching contribution each pay period of 100% of a participant's elective deferral percentage up to 4%. For the 2024 Plan year, the Company made safe-harbor Employer matching contributions amounting to \$777,572. Additionally, the Company may make a discretionary profit sharing contribution in an amount to be determined annually, based on a discretionary formula. To be eligible for a profit sharing contribution, the employee must be employed as of the last day of the Plan year. This condition will be waived for a participant if: the participant dies; the participant is terminated after having incurred a disability; the participant has reached normal retirement age; or the participant completed at least 500 hours of service during the plan year. For the 2024 Plan year, the Company made discretionary profit sharing contributions amounting to \$279,957.

***Participant Accounts***

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions and (b) Plan earnings (losses) thereon. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from a participant's vested account.

***Vesting***

Participants are immediately vested in their voluntary contributions and the Company's safe-harbor contribution, plus actual earnings thereon. For any discretionary profit sharing contributions, an employee will vest as follows.

Less than 2	0%
At least 2 but less than 3	20%
At least 3 but less than 4	40%
At least 4 but less than 5	60%
At least 5 but less than 6	80%
At least 6	100%

Upon death or disability, the value of the participant's account becomes fully vested.

***Forfeitures***

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$17,791 and \$22,920. These accounts can be used to reduce future Employer contributions. During 2024, \$53,262 of forfeitures were used to reduce Employer contributions.

***Plan Credit Account***

The Plan had a service based pricing arrangement, with a previous trustee, whereby a portion of the revenue earned by the previous trustee is passed through to the Plan for payment of permitted Plan expenses. The Plan Credit Account is a nonparticipant directed account within the Plan. The Plan Credit Account balance was \$0 at December 31, 2024 and 2023. During 2024, \$0 from the Plan Credit Account were used to reduce Plan expenses.

***Notes Receivable from Participants***

Participants may borrow from their accounts a minimum amount of \$500 up to a maximum amount equal to the lesser of \$50,000 or 50% of their account balance. Loans bear interest based on loans granted under similar circumstances by the Company's principal banking institution. Generally, all loan repayments are made through payroll deductions. Loans are required to be repaid within a five-year period. Loans to acquire a principal residence may be repaid within 30 years.

***Payment of Benefits***

Upon termination of service due to death, disability, retirement or other reason, or due to financial hardship, a participant is entitled to receive a distribution in the amount equal to the value of the participant's vested interest in his or her account. Automatic distributions may be made upon termination of employment when the participant's vested account balance is \$5,000 or less.

**2. Summary of Significant Accounting Policies**

***Basis of Accounting and Use of Estimates***

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”), which requires management to make estimates and assumptions that affect assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

***Investment Valuation and Income Recognition***

The Plan’s investments are stated at fair value. The mutual funds and money market funds are valued at the daily closing price as reported by the fund. The funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price and are deemed to be actively traded. Common stocks and exchange traded funds are valued at the closing price reported on the active market on which the individual securities are traded. The self-directed brokerage accounts consisted of common stocks, interest bearing cash, exchange traded funds, and mutual funds.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

***Payment of Benefits***

Benefits are recorded when paid.

**Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value on investments.

**Subsequent Events Evaluation by Management**

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is October 24, 2025.

**3. Information Certified (Unaudited)**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments held and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Vanguard Fiduciary Trust Company, a qualified institution.

**5. Party-in-Interest Transactions**

All investments of the Plan are managed by Vanguard Fiduciary Trust Company. Vanguard Fiduciary Trust Company is the trustee and record keeper as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

**6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer profit sharing contributions.

**7. Tax Status**

On June 30, 2020, the Internal Revenue Service (“IRS”) stated that the prototype adopted by the Plan, as then designed, qualifies under IRC Section 401(a). Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

**8. Risks and Uncertainties**

Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility.
