### Notes to Financial Statements

1. **Description of the Plan** The following description of the Ryan Chevrolet, LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering substantially all employees of Ryan Chevrolet, LLC (the "Company") who are at least 21 years old and who have completed one year of service of at least 1,000 hours. Participants may enter the Plan immediately upon satisfying the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

**Contributions:** Each year, participants may contribute up to 100 percent of pretax annual compensation, as defined in the Plan. After tax contributions are also permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). The Plan provides for automatic enrollment. Any newly eligible employee who has not affirmatively elected to contribute to the Plan or has not affirmatively declined to participate in the Plan will be automatically enrolled in the Plan with a two percent withholding of pretax annual compensation. The Company contributes 50 percent of the first two percent of compensation that a participant contributes to the Plan. Profit sharing amounts may be contributed at the discretion of the Company. Participants must be employed on the last day of the Plan year to receive an allocation of any discretionary profit sharing contribution. Contributions are subject to certain limitations.

**Participant accounts:** Each participant's account is credited with the participant's contributions, the Company's matching contributions, the Company's discretionary profit sharing contributions, if any, and Plan earnings. Investment earnings and losses are allocated based upon the investment performance of each investment in the participant's account. Allocations of the Company's discretionary profit sharing contributions, if any, are based on the participant's eligible compensation using a formula integrated with the social security taxable wage base. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Notes to Financial Statements

**Vesting:** Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company matching and discretionary profit sharing contributions is based on years of continuous service. The portion of the participant's account attributable to Company matching contributions and Company discretionary profit sharing contributions is fully vested after completion of five and three years of service, respectively. Vesting is accrued as outlined in the Plan document.

**Payment of benefits:** Benefits are payable upon retirement at age 65, early retirement at age 59 1/2, disability, death, or termination of employment. Hardship withdrawals and in-service withdrawals at age 59 1/2 are also permitted, subject to provisions described in the Plan document. Withdrawals from after tax contributions are permitted at any time. Benefits are payable in lump sum, installment or ad-hoc payments.

**Administrative expenses:** Certain expenses of maintaining the Plan are paid by the Company. Transaction expenses, such as distribution administration fees, are charged directly to the participant's account and are included in administrative expenses. Participants are also charged an asset based fee for recordkeeping. These fees are included in administrative expenses.

**Forfeited accounts:** At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$16,219 and \$17,651, respectively. These accounts will be used to reduce future Company matching contributions or to pay Plan expenses. During 2024, \$12,563 of forfeited nonvested accounts was used to reduce Company contributions and \$2,388 was used to pay Plan expenses.

#### 2. Significant accounting policies

**Basis of accounting:** The financial statements of the Plan are prepared under the accrual method of accounting.

**Investment valuation and income recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Contributions:** Participant contributions and the related Company matching contributions are recognized in the period the participant contribution is withheld from compensation. Company discretionary profit sharing contributions are recognized in the period the related eligible compensation is paid to the participant.

**Payment of benefits:** Benefits are recorded when paid.

**Use of estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Subsequent events:** The Plan has evaluated subsequent events for disclosure in these financial statements through October 14, 2025, which is the date the financial statements were available to be issued.

**Excess contributions payable:** Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as a liability with a corresponding reduction to contributions.

- 3. Certified information** Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC, the trustee of the Plan.
- 4. Fair value measurements** All assets of the Plan are nonparticipant directed. Company contributions and participant pre-tax deferral contributions are invested in the Drive Balanced Fund. All employee after tax contributions are invested in the Drive Income Fund.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The fair value of the collective trust funds is based on the net asset value ("NAV") on the last business day of the Plan year provided by the entity holding the trust funds. The NAV of the collective trust is used as a practical expedient to estimate fair value and is determined by the fund trustee based on the fair value of underlying assets in the trust, less its liabilities.

All investments of the Plan are measured using net asset value as a practical expedient to estimate fair value and therefore, are not subject to the fair value hierarchy. Investments in collective trust funds, except the Drive Income Fund, can be redeemed each business day at the current net asset value. Redemptions from the Drive Income Fund for participant withdrawals are permitted each business day. Plan level redemptions from this fund require 90 days written notice. There are no other withdrawal limits, redemption frequency limits or redemption notice periods. There were no unfunded commitments for these investments as of December 31, 2024 and 2023.

- 5. Risks and uncertainties**

The Plan provides for investments in various securities that are exposed to risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in future statements of net assets available for benefits.
- 6. Plan termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.
- 7. Tax status**

The Plan is a pre-approved plan of Empower Retirement, LLC which received an opinion letter on November 14, 2022, in which the Internal Revenue Service ("IRS") stated that the form of the plan document was acceptable under the applicable requirements of the Internal Revenue Code ("IRC"). The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

- 8. Party-in-interest transactions** Certain Plan investments are managed by affiliates of Empower Trust Company, LLC. Empower Trust Company, LLC is the trustee as defined by the Plan. In addition, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions qualify as exempt party-in-interest transactions.
