### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Other Matter - Supplemental Schedule Required by ERISA**

The supplemental schedule of Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulation for Reporting and Disclosure under ERISA.

Notes to Financial Statements**

**1. DESCRIPTION OF PLAN**

The following brief description of the Allen Matkins Profit Sharing and 401(k) Plan (Plan) is provided only for general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was adopted by Allen Matkins Leck Gamble Mallory & Natsis LLP (the Partnership) effective January 1, 1993 and most recently amended and restated effective January 1, 2022. The Plan is a qualified profit-sharing plan as described in Internal Revenue Code section 401(a), which includes a qualified cash or deferred arrangement, as described in Internal Revenue Code section 401(k), and is subject to the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility

All partners and employees of the Partnership are eligible to participate in the elective deferral portion of the Plan on the first day of the month after the employee attains age 21 and completes one month of service. All partners and employees of the Partnership, excluding attorney employees, are eligible to participate in the profit sharing contribution portion of the Plan on the first January 1st or July 1st after the employee attains age 21 and completes one year of service with at least 1,000 hours of service during each year without a break of service, and also must be employed at the end of the Plan year. Eligible employees are auto-enrolled at a deferred rate of 3%.

Participant Accounts

The Plan maintains individual accounts for each participant, wherein each participant directs the investment of his or her account in one or more of the available investment funds or may self-direct investments to his or her individual brokerage account. Each participant's account is credited with the participant's contribution and allocations of the Partnership's profit sharing contribution and Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant compensation, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loan repayment term is for a period not to exceed five years, except in the case of a loan that is used to purchase a principal residence of a participant wherein the loan repayment term may be for a period not to exceed fifteen years.

**1. DESCRIPTION OF PLAN (Continued)**

Notes Receivable from Participants (Continued)

The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan Administrator. As of December 31, 2024, interest rates on participant loans are between 5.25% to 10.50%. Principal and interest are paid ratably by employees through semi-monthly payroll deductions, while partners make monthly payments.

Contributions

Participants may elect to contribute a certain amount of his or her eligible compensation, as defined by the Plan. Participant contributions reflect pre-tax salary deferrals and/or after-tax (Roth) salary deferrals. Participants who have attained age 50 before the Plan year-end are also able to make additional catch-up contributions. In addition, participants may also contribute amounts representing distributions from another qualified plan or from an eligible individual retirement account. The Company may make discretionary matching contributions to eligible employees. In 2024, the Company matched 100% of the participant contributions to the extent of 3% of the participant's base salary for the Plan year for salaried attorneys, other than partner, who is regularly scheduled to work at least 75% of a full-time schedule. All employer contributions allocated to the participants and participant contributions are invested as directed by the participants.

The Partnership may make a profit sharing contribution to the Plan on behalf of each eligible participant. This discretionary contribution is allocated on the last day of the Plan year and the allocation formula for the profit sharing contribution must satisfy the minimum allocation gateway as defined in the applicable Treasury Regulations. In 2024, the Partnership elected to make a profit sharing contribution as follows: (1) for participants, excluding the executive director and partners, the contribution is equal to 8% of eligible pay, plus 5.7% of excess pay, as defined in the Plan, (2) for the executive director, the contribution is equal to the maximum contribution that a partner receives, \$46,000, and (3) for partners, the contribution is calculated based on the following table:

Points represent the allocation of numerical points assigned from time to time to a partner utilized by the Partnership in the allocation of profits and losses. For partners who are not on the point system, the Partnership determines a point equivalent that will apply to the partner for determining the appropriate contribution from the preceding table.

**1. DESCRIPTION OF PLAN (Continued)**

Payment of Benefits

On termination of service a participant may elect to have his or her account balance distributed as follows: (1) paid in a single lump sum (the only option if account balance is \$1,000 or less), or (2) a portion paid in a lump sum, and the remainder paid later, or (3) paid in periodic installments over a period not to exceed life expectancy, or (4) used to purchase a single or joint life annuity. If the account balance is between \$1,000 and \$5,000, and no election for distribution is made, the account will automatically be transferred to an individual retirement account (IRA) held by Charles Schwab Trust Bank in the participant's name. Withdrawals by a participant while he or she is an employee are permitted from rollover accounts, in certain cases of financial hardship, once a participant has attained age 59-1/2, or for long-term military service. Such withdrawals will be paid in a single lump sum and must be at least \$1,000.

Vesting

Participants are immediately vested in their contributions and the Employer's profit sharing and matching contribution plus actual earnings thereon.

Plan Termination

Although it has not expressed any interest to do so, the Partnership has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING PRINCIPLES**

Basis of Accounting

The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP), using the accrual method of accounting.

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING PRINCIPLES (Continued)**

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Contract value is the relevant measurement attribute for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date. See Note 5 for disclosures regarding fair value measurements.

Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis, which approximates when interest is received. Dividends are recorded on the trade date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Management fees and operating expenses charged to the Plan for investments in mutual funds, common/collective trusts, and the guaranteed interest account, are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment income for such investments.

Notes Receivable from Participants

Notes receivable from participants are stated at the unpaid principal balance. Interest income associated with the notes receivable is recorded as earned as per the related loan amortization schedules. Related fees (as paid by participants) are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain costs related to administering the Plan, including trustee, investment advisor and third-party administrator fees, have been paid by the Plan, while other fees have been paid by the Partnership at its option and are excluded from these financial statements. Expenses related to specific participant transactions are charged directly against the participant's account and are included in expenses.

**3. FINANCIAL INFORMATION CERTIFIED BY TRUSTEE**

Charles Schwab Trust Bank, the trustee, has certified that the following information included in the financial statements and supplemental schedule as of December 31, 2024 and 2023, and for the year ended December 31, 2024 are complete and accurate:

- a. Investments and notes receivable from participants as included in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023.
- b. All information pertaining to notes receivable from participants loan interest, investment income, including net appreciation (depreciation), and interest and dividends, in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.
- c. Schedule of Assets (Held at End of Year) as of December 31, 2024.

**4. RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares of common/collective trust funds and mutual funds managed by an affiliate of Charles Schwab Trust Bank, the trustee of the Plan. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments.

In addition, the Plan pays expenses for services rendered by or receives other income from Charles Schwab Trust Bank as the Plan recordkeeper and also pays expenses to its third party administrator, investment advisors, auditor, and expenses related to the self-directed brokerage account. During the year ended December 31, 2024, the Plan incurred \$214,910 of administrative and investment expenses.

The above transactions, including notes receivable from participants, qualify as allowable party-in-interest transactions for which there are statutory exceptions.

**5. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Financial Accounting Standard Board (FASB) Accounting Standard Codification (ASC) 820, Fair Value Measurements and Disclosures, with the related inputs to the valuation methodology are described as follows:

- Level 1 - Quoted prices (unadjusted) in active markets for identical assets that the Plan has the ability to access.
- Level 2 - Significant other observable (directly or indirectly) inputs, including quoted prices for similar assets in active markets or in inactive markets and other market observable inputs such as interest rate, credit risks, etc.
- Level 3 - Significant unobservable inputs, including the Plan's own assumptions in determining the fair value of investments.

Notes to Financial Statements (Continued)**

**5. FAIR VALUE MEASUREMENTS (Continued)**

Following is a description of the valuation methodologies used for the Plan's investment assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money Market Fund

The money market fund is valued at the daily closing net asset value of the respective fund. The money market fund held by the plan is an open-ended fund that is registered with the Securities and Exchange Commission. This fund is required to publish their daily net asset and to transact at that price. The money market fund held by the Plan is deemed to be actively traded.

Mutual Funds (Registered investment company)

The mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/Collective Trust Funds

The common/collective trust funds are valued at the net asset value (NAV) units of the common/collective trust. The net asset value, as provided by the trustee, is used as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported net asset value. For the common/collective trust funds, there are no unfunded commitments, redemption frequency is daily and there is no required redemption notice periods.

Self-Directed Brokerage Accounts

Accounts primarily consist of mutual funds, unit investment trusts, common stocks, government securities, and cash and cash equivalents that are valued on the basis of readily determinable market prices (e.g. daily closing price).

**6. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT**

The Plan has a group annuity contract with New York Life Insurance Company ("NYL"), referred to as the Guaranteed Interest Account ("GIA"). The contract is designed to be a fully benefit-responsive traditional investment contract. The group annuity contract provides for a book value record of the amounts deposited to and withdrawn from the GIA. Accordingly, the GIA is at all times equal to the contributions made to the contract plus interest credited, plus dividends, if any, minus expenses withdrawn and minus withdrawals made. Contributions to the GIA are currently invested in a broadly diversified fixed income portfolio within NYL's general account. Fixed income investments in the general account are managed by New York Life Fixed Income Investors Group.

**6. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT (Continued)**

The investments in the general account are intended to provide a stable crediting rate consistent with preservation of principal. The NYL general account is invested primarily in a conservative array of securities and cash-equivalent investments in accordance with the investment restrictions of New York Insurance Law. The primary objective of the general account is to ensure that NYL can meet its obligations to policyholders. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

The crediting interest rate is declared in advance by NYL, every January 1<sup>st</sup> and July 1<sup>st</sup>. The interest crediting rate is subject to a minimum rate provision, but may never fall below 1%, after deductions for any expenses. The key factors that impact the crediting rate under the group annuity contract are the timing and magnitude of the cash flows in and out of the general account as well as prevailing market rates on fixed income assets available for investment by the general account.

The group annuity contract provides that, subject to certain limitations, withdrawals for benefit payments at death, retirement, disability, termination of employment, and for loans, hardship withdrawals or in-service withdrawals as permitted by the Plan are completed at contract value. Certain distributions, including but not limited to distributions resulting from employer-initiated events such as Plan termination, merger, spin-off, and early retirement incentives may be completed subject to a market value adjustment. The Plan Administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

The group annuity contract may be terminated by the contract holder at any time, provided written notice of termination is received by NYL at least 30 days but not more than 60 days prior to the intended termination date. At contract termination, the Plan may elect to receive either an immediate lump sum distribution subject to a market value adjustment or receive a contract value distribution in six annual installments over a period of five years.

**7. TAX STATUS OF THE PLAN**

The Plan has received a determination letter from the Internal Revenue Service dated November 25, 2015, stating that the Plan is qualified under the Internal Revenue Code and, therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the Internal Revenue Code to maintain its qualification. The Plan Administrator believes that the Plan is being operated as designed, and therefore believes that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan takes an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**8. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
