Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Crain Automotive, Inc. 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits – modified cash basis as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits – modified cash basis for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting described in Note 2.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Basis of Accounting

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements and supplemental schedule are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2; this includes determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such

procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the modified cash basis of accounting as described in Note 2.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting as described in Note 2.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

Notes to Financial Statements
December 31, 2024 and 2023

(1) Description of Plan

The Crain Automotive, Inc. 401(k) Profit Sharing Plan (the “Plan”) was established on January 1, 1994. Crain Automotive, Inc. (the “Company”) has appointed an administrator to administer the Plan. The Plan’s trustee is John Hancock Life Insurance Company (the “Trustee”). The following is a description of the major provisions of the Plan that provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General: The Plan is a defined contribution plan established by the Company under the provision of Section 401(a) of the Internal Revenue Code (“IRC”), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Company. All employees of the Company and participating affiliates, who have completed 500 hours of service in a six month period, as defined by the plan document, are eligible to participate, provided they are at least 18 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

Contributions: Participants may elect to defer up to 100% of their annual compensation that does not exceed the dollar limit contained in Section 401(g) of the Internal Revenue Code. Participants defined as highly compensated may not elect to defer amounts exceeding 8% of compensation. Participants who attain the age of 50 before the end of the Plan year are eligible to make catch-up contributions in accordance with, and subject to the limitations of, Section 414(v) of the Internal Revenue Code. The Company matches 20% of each participant’s elective deferrals. Also, the Company may, at its discretion, make an employer profit sharing contribution to the Plan. Employees must have met the eligibility requirements to participate during the year to receive this contribution.

Participant Accounts: Each participant’s account is credited with the participant’s contributions, the Company’s matching contribution and discretionary profit sharing contribution, and an allocation of current Plan earnings or loss. Allocation of earnings or loss is based upon the percentage that each participant’s account for a particular investment option bears to the total of all participant accounts for that same investment option. Additionally, the allocation of the Company’s discretionary profit sharing contribution is based upon the percentage that each eligible participant’s compensation bears to the total compensation of all eligible participants. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting: Participants are always vested 100% in their voluntary salary deferral contributions. The Company’s matching contributions and discretionary profit sharing contributions are 100% vested after an employee is credited with three years of service.

Investment Options: Participants are permitted to direct the Trustee as to the investment of all the assets in their individual account balances in one or more investment options allowed under the Plan. Upon request, participants may obtain a complete listing of all investment options available under the Plan from the Trustee. Participants can change their option elections at any time, which take effect on a daily basis.

Participant Loans: Participants may borrow from their Plan accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan transactions are treated as a transfer to (from) the various investment funds from (to) the participant loan fund. Loan terms range from one to five years, unless the proceeds are used for the purchase of a primary residence, in which case the term is to be for a reasonable number of years. The loans are secured by the vested balance in the participant's account and bear a reasonable rate of interest. Interest rates for loans outstanding as of December 31, 2024 and 2023 ranged from 4.25% to 9.5%. Earnings on these loans are directly allocated to the participants with loans. Principal and interest is paid ratably through weekly and bi-weekly payroll deductions. Under certain circumstances, a loan that is in default or the loan balance of a terminated employee may be considered a distribution from the Plan.

Payment of Benefits: On termination of service due to death, disability, or retirement, participants may elect to receive their account balances either in a lump-sum amount, or in periodic installments over a period not to exceed the life expectancy of the participant or designated beneficiary. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeitures: The Company may, at its discretion, use available forfeitures to reduce employer contributions or to pay Plan expenses. Balances in the forfeiture account may be used at any point in the future if not used in full at the end of the year.

Excess Contributions: Excess contributions refundable totaling \$25,391 were due to participants as of December 31, 2024. Such amounts have been refunded in the following plan year in accordance with the plan document.

(2) **Summary of Significant Accounting Policies**

The following is a summary of the significant accounting policies used by the Plan in the preparation of the accompanying financial statements. Such policies are in accordance with the modified cash basis of accounting which is an Other Comprehensive Basis of Accounting.

Valuation of Investments: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 9 for a discussion of fair value measurement. Purchases and sales of securities are recorded on a trade date basis. Dividends are recorded on the ex-dividend date. Net investment gain includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Basis of Accounting: The Plan prepares its financial statements on the modified cash basis of accounting. Under this method, revenues are recognized when received and expenses are recognized when paid. The modified cash basis of accounting differs from accounting principles generally accepted in the United States of America primarily because the effects of contributions and investment income earned but not received and Plan expenses incurred but not paid are not reflected in the financial statements.

Use of Estimates: The preparation of financial statements in conformity with modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

(3) **Tax Status**

The Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter; however, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

The Plan's information returns are subject to examination by the Department of Labor and the Internal Revenue Service generally for three years after they were filed.

(4) **Risks and Uncertainties**

The Plan invests in a variety of investment funds. Investments in general are exposed to various risks, such as interest rate, credit, and overall volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

(5) **Administrative Expenses**

The Plan pays for administrative expenses related to Trustee's fees, investment management fees, and individual fees, including loan and distribution fees. The fees paid by the Plan for the years ended December 31, 2024 and 2023 were \$72,280 and \$94,656, respectively.

The administrative and investment management fees are allocated to each participant's account on a pro rata basis. Individual fees are charged directly to the participant's account when incurred. All other administrative expenses are paid by the Company.

(6) **Forfeited Accounts**

Forfeited balances were used to pay administrative fees of \$0 and \$16,908 for the years ended December 31, 2024 and 2023, respectively. \$22,290 and \$9,112 was available in the forfeiture account at December 31, 2024 and 2023, respectively.

(7) **Information Certified by the Trustee**

The following is a summary of the unaudited information included in the Plan's financial statements and supplemental schedules that were prepared by John Hancock Life Insurance Company, (the "Trustee"), the Trustee of the Plan and furnished to the Plan administrator. The Plan administrator has obtained certification from the Trustee that such information is complete and accurate.

- Cash
- Investments, at fair value
- Investment income

- Notes receivable from participants
- Interest income on notes receivable from participants

(8) Plan Termination

Although it has not indicated any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

(9) Fair Value Measurement

Under FASB ASC 820-10, three prioritized valuation inputs may be used to determine fair value at the measurement date: Level 1 – quoted prices (unadjusted) in active markets for identical assets or liabilities; Level 2 – observable inputs other than the quoted prices included in Level 1; Level 3 – unobservable inputs. There have been no changes in valuation methodologies during the periods under audit, therefore no recognition of gain or loss is required for these financial statements.

Pooled separate accounts are valued at the net asset value (“NAV”) of units of a pooled separate account (“PSA”) maintained by John Hancock Life Insurance Company (“John Hancock”) held by the Plan at year-end. The NAV, as provided by John Hancock, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the PSA less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The primary investment objective of the PSAs is to allow participants to achieve the same rate of return as the underlying mutual funds, less fee charged by John Hancock. The PSAs do not have any unfunded commitments relating to their investments, or any significant restrictions.

As pooled separate accounts use the NAV practical expedient, they do not fall within the fair value hierarchy. The Plan’s assets held for investment purposes at fair value as of December 31, 2024 and 2023 were as follows:

(10) Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employer association, or relatives of such persons. Certain plan investments consist of pooled separate accounts managed by John Hancock Life Insurance Company. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

(11) Reconciliation of Financial Statements for Schedule H of Form 5500

There were no significant reconciling differences between the financial statements and the Form 5500.

(12) Subsequent Events

The Plan has evaluated subsequent events through October 15, 2025 the date the financial statements were available to be issued.
