## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Retirement Plan Committee of  
Bullivant Houser Bailey PC 401(k) Profit Sharing Plan and Trust  
Portland, Oregon

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Bullivant Houser Bailey PC 401(k) Profit Sharing Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### ***Other Matter — Supplemental Schedules Required by ERISA***

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

**NOTE 1 – DESCRIPTION OF PLAN**

The following brief description of the Bullivant Houser Bailey PC 401(k) Profit Sharing Plan and Trust (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution plan maintained for the benefit of all eligible employees of Bullivant Houser Bailey PC (the Company) who are 18 years of age. The Retirement Plan Committee determines the appropriateness of the Plan's investment offerings, and monitors investment performance. Upon enrollment to the Plan, a participant may direct deferrals and employer contribution in any of the funds offered by the Plan. Participants may change their investment options daily. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Plan Amendments** - Effective September 29, 2023, the Plan was amended to remove the exclusion of hourly employees from participating in the Plan. Hourly employees may participate in the Plan on the date they satisfy the Plan's eligibility requirements.

Effective January 1, 2024, the Plan was amended to remove the exclusion of temporary and seasonal employees from participating in the Plan. Temporary and seasonal employees may participate in the Plan on the date they satisfy the Plan's eligibility requirements.

**Contributions** - Contributions consist of employee elective deferrals, employer matching, and discretionary profit-sharing contributions provided by the Company. Employee elective deferrals, employer matching, and discretionary profit-sharing contributions are recorded in the year in which the employee contributions are withheld from compensation. Participants may voluntarily contribute up to 65% of their eligible compensation, limited to \$23,000 in 2024 and \$22,500 in 2023, respectively, as prescribed by the Internal Revenue Code (IRC). Participants aged 50 and older may elect to make an additional catch-up contribution. The Plan allows participants to designate contributions as Roth contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). The Company may make matching contributions of 100% of a participant's elective deferrals not to exceed \$1,000. Employees are eligible for matching contributions if they have completed one year of service and are employed at the end of the calendar year. The Company may also make a discretionary profit-sharing contribution to be determined by the Company's board of directors. Employees are eligible for discretionary profit-sharing contributions if they have completed two years of service and are employed at the end of the calendar year. A year of service for purposes of eligibility is a consecutive 12-month period during which the employee has 1,000 or more hours of service. For 2024 and 2023, the Company contributed matching contributions of \$100,643 and \$112,458, respectively and profit-sharing contributions of \$377,115 and \$467,967, respectively.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation and their contributions invested in a designated fund until changed by the participant. The deferral is increased annually by 1% up to 15%.

**Participant Accounts** - Each participant's account is credited with the participant's contributions and the Company matching contributions, as well as allocations of the Company discretionary contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant's compensation, account balances or specific participant transactions, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** - Participants are immediately vested at 100% of their voluntary contributions, rollover contributions, employer match contributions, and profit-sharing contributions, plus actual earnings thereon.

**Payment of Benefits** - Participants may elect to receive either a lump-sum amount equal to the value of their vested interest, or annual installments as defined in the Plan document upon retirement, termination of service, death or disability. A terminated participant with a balance of less than \$1,000 may be automatically paid out by the Plan upon termination. Any terminated participants with a balance between \$1,000 and \$7,000 can still be automatically paid out if their balance is rolled into a qualified Individual Retirement Account. Distributions may be made at the participant's election prior to termination upon attainment of age 59 ½ or hardship as defined in the Plan document.

**Expenses** - Administrative expenses may be paid by the Company. Expenses not paid by the Company are allocated to participant's accounts based on account balances. Expenses of plan administration, including computer services, office supplies and payroll expenses of administrative and clerical personnel are provided by the Company without charge to the Plan. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

## **NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting** - The financial statements of the Plan are prepared under the accrual method of accounting.

**Investment Valuation and Income Recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year, and management and operating expenses associated with the Plan's investments.

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

**Use of Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Benefit Payments** - Benefits are recorded when paid. Accordingly, benefits payable to persons that have elected to withdraw from the Plan but are not yet paid at year-end have not been accrued. At December 31, 2024 and 2023, there were no amounts payable to participants.

### **NOTE 3 – FAIR VALUE MEASUREMENTS**

Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

#### **Basis of Fair Value Measurement**

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access at the measurement date.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets in active markets;
- Quoted prices for identical or similar assets in inactive markets;
- Inputs other than quoted prices that are observable for the asset; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. At December 31, 2024, the Plan has changed the methodology used to value the Common/collective trust fund using the practical expedient as described below. There are no other changes to the Plan's methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/collective trust fund:* The Plan holds an investment in the Morley Stable Value Fund, a common/collective trust fund (the CCT) that is comprised primarily of fully benefit-responsive investment contracts. Principal Global Investors Trust Company, formerly Union Bond & Trust Company, is the trustee of the CCT. The objective of the CCT is to provide a diversified group of investments offering competitive levels of yield consistent with a stable fixed income methodology and the careful and prudent assumption of investment risk providing for preservation of capital stability and predictability of returns, liquidity to pay plan benefits and high credit quality. The CCT invests in other conventional, synthetic and separate account investments contracts issued by life insurance companies, banks, and other financial institutions that invest in a portfolio of securities, primarily equity securities, money market funds and US treasuries. Units in the CCT are valued based on the underlying investments, the majority of which are based on quoted prices. The NAV provided by the trustee is used as a practical expedient to estimate fair value. Units in common collective trust funds are not publicly traded, but rather, are redeemable only by the issuer. The value of the Plan's investment in the common collective trust fund represents the value of the Plan's interests in the overall value of the CCT. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the CCT, the investment advisor reserves the right to temporarily delay withdrawal to ensure that securities liquidation will be carried out in an orderly business manner. Investments in common collective trust funds can generally be redeemed without restriction; however, in certain cases, redemption or purchase may be limited to prevent excess and/or short-term trading. In addition, if a fund experiences periods of insufficient liquidity, then the fund may defer honoring any payment request until liquidity is sufficient.

*Self-directed brokerage accounts:* Account primarily consists of mutual funds, common stock, interest-bearing cash, and unit investment trusts. Mutual funds are valued at the daily closing price as reported by the fund. These funds are required to publish their daily NAV and to transact at that price and are deemed to be actively traded. Common stock is valued on the basis of at the closing price reported on the active market on which the individual securities are traded. Interest-bearing cash are valued at carrying value, which is approximate fair value. Unit investment trusts are valued using NAV, calculated as of close of the exchange each day.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **NOTE 4 – INFORMATION CERTIFIED BY THE TRUSTEE OF THE PLAN**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and the supplemental schedule, Schedule H, Line 4i – Schedule of Assets (Held at End of Year), including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest income on notes receivable from participants and interest and dividends for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the trustee of the Plan, Charles Schwab Trust Bank.

#### **NOTE 5 – NOTES RECEIVABLE FROM PARTICIPANTS**

Participants may borrow from their fund accounts, a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the balance in the participant's account and bear interest at a reasonable interest rate as determined by the Retirement Committee. Principal and interest is paid ratably through payroll deductions over a period not to exceed five years, unless the proceeds of the loan were used to acquire the participant's residence, in which case the loan will be no more than 30 years. Interest rates on all outstanding loans ranged from 4.25% to 9.50% at December 31, 2024.

#### **NOTE 6 – CONCENTRATIONS, RISKS AND UNCERTAINTIES**

The Plan provides for investments that are exposed to various risks. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits, and therefore participants' account balances. There was one investment that individually represented more than 10% of the investments held as of December 31, 2024 and 2023. See the Supplemental Schedule of Assets (Held at End of Year) for the complete listing of investments held as of that date.

#### **NOTE 7 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Charles Schwab Retirement Plan Services is the recordkeeper and Charles Schwab Trust Bank is the trustee of the Plan. Investment management and recordkeeper administrative fees paid to Charles Schwab Trust Bank and/or an affiliate of the trustee amounted to \$32,101 and \$33,460 in 2024 and 2023, respectively. As Charles Schwab Trust Bank is the trustee of the Plan, these transactions qualify as party-in-interest transactions.

#### **NOTE 8 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

## **NOTE 9 – INCOME TAX STATUS**

The Plan is an adoption of a non-standardized pre-approved prototype non-standardized profit-sharing plan sponsored by Schwab Retirement Plan Services. The Plan document obtained its latest opinion letter on September 21, 2020, in which the Internal Revenue Service (IRS) stated that the Plan document, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan document has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that, therefore, the Plan qualifies under Section 401(a) and the related trust is tax-exempt as of December 31, 2024 and 2023. See Note 11 for operational issues related to tax status.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **NOTE 10 – PROHIBITED TRANSACTIONS**

During 2024, the Plan's management determined that elective salary deferrals withheld from employees' payroll totaling \$11 were not remitted to the Plan by the Company within the time period required by the Department of Labor. These transactions constitute prohibited transactions as defined by ERISA. The Company is aware of the occurrences and is in the process of taking the appropriate steps to correct the situation.

## **NOTE 11 – VOLUNTARY CORRECTION PROGRAM**

Per Note 9, the form of Plan document currently being used is a pre-approved document, the design of which satisfies the applicable provisions of the IRC. In 2022, the Plan's management discovered that one aspect of the Plan had been operated in a manner that was inconsistent with the terms of the written Plan document. Plan management, in consultation with external legal counsel, has concluded that such inconsistent operation was an "operational failure" as that term is defined under IRS Rev. Proc. 2021-30, and that this operational failure is correctable under the Voluntary Correction Program (VCP) provisions of Rev. Proc. 2021-30. More specifically, the identified operational failure involves the definition of compensation on which elective deferrals were calculated and contributed to the Plan. The Company filed a Voluntary Correction Program application with the IRS on September 29, 2023, to disclose the operational failure and propose a correction of that operational failure to obtain a favorable compliance statement from IRS under Rev. Proc. 2021-30. Plan management has taken steps to prospectively correct this operational failure. To avoid adverse tax consequences arising from the identified operational defect, the Company, as Plan Sponsor, fully intends to take action necessary to obtain a favorable compliance statement under Rev. Proc. 2021-30 with respect to the identified operational failure and to correct the identified operational failure in a manner consistent with the IRS compliance statement, once issued. Accordingly, and notwithstanding the existence of the identified operational failure, which is in the process of being corrected, no provision for income taxes has been included in the Plan's financial statements. The likelihood that the regulators will approve a correction under the VCP is unknown, however, in anticipation that the regulators will approve the correction proposed the Plan Sponsor made additional QNEC contributions to the Plan in June 2025 for non-shareholder employees in the amount

\$76,013 to correct the plan years from 2022 through 2016. In addition, this amount has been recorded as an employer receivable to the Plan as of December 31, 2024, in the accompanying financial statements.

#### **NOTE 12 – SUBSEQUENT EVENTS**

During 2025, the Plan sponsor determined the Company would no longer be engaged in the practice of law effective November 1, 2025, although the Company will remain as a corporate entity through a yet-to-be determined wind-down date. The intention is to end the corporate entity with its liquidation by mid-2026. Most of the employees of the Company will terminate employment by October 31, 2025, resulting in a partial plan termination. All participants affected by the partial plan termination are already fully vested in their plan accounts on the date on which the employees will be terminated.

As of the date of the issuance of the accompanying financial statements, there has been no decision to nor plan amendments made to terminate the Plan, however the Plan Sponsor is currently considering and evaluating their options and is considering a possible plan termination no earlier than January 1, 2026. The Plan's financial statements have not been modified with respect to these matters.

The Plan's management has performed an evaluation of subsequent events through October 15, 2025, which is the date these financial statements were available to be issued.
