I tried filing my Form 5500 on September 3rd 2025 but due to technical issues with the website I was unable to do so. We even created new Efast credentials and Pin and were still unable to file the form. I was told the IT department would fix the issue and I was under the assumption that once it was fixed the form would be filed as I had already gone through and made sure the information was accurate but that did not happen. This was only brought to my attention when I received an email stating that I missed the deadline to file and there may be penalties from the DOL or IRS. I promptly logged in and was finally able to file, which I Did, but I am requesting all fees be waived due to issues outside of my control. In my 10 years in business I have never filed late as I stay on top of these things, but this year was an exception due to technological issues with the filing website.
