## NOTES TO FINANCIAL STATEMENTS

December 31, 2024 And 2023

### 1. Description Of The Plan

The following description of Weissman Designs for Dance 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan with a 401(k) provision established on January 1, 2005, and most recently amended and restated effective January 1, 2016. The Plan covers all employees of Weissman Designs for Dance (the Company) who have completed 250 hours of service within three consecutive months and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### Contributions

A participant may elect to contribute up to 100% of eligible compensation, not to exceed Internal Revenue Code (the Code) limits. Once enrolled, participants have the option to elect to have their contributions increase automatically by 1% per year. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Employees may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions).

The Company elected a safe harbor matching contribution formula equal to the sum of 100% of the first 3% plus 50% of the next 3% of compensation as defined by the Plan Document not to exceed 6%. The Plan also provides for discretionary profit sharing contributions as determined by the Company. No discretionary profit sharing contributions were made for the years ended December 31, 2024 or 2023.

#### Payment Of Benefits

Upon termination of service due to death, disability, retirement, or other reasons, a participant may receive substantially equal installment payments or a lump-sum amount equal to the value of the participant's vested interest in his or her account.

#### In-Service Distributions

Active participants who reach age 59-1/2 may withdraw all or part of their vested accounts.

### Notes To Financial Statements *(Continued)*

#### **Participant Hardship Withdrawals**

A participant may withdraw from the Plan all or a portion of his or her account in the event of an immediate and heavy financial need. Hardship withdrawals are subject to the terms of the Plan Document and provisions of the Code.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, the Company's contributions and an allocation of Plan earnings and expenses. The allocation of earnings is determined by the earnings of the participant's investment selection based on each participant's account balance, as defined in the Plan Document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Notes Receivable From Participants**

Participants may borrow from their account a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, whichever is less. Participants may only have three loans outstanding at any given time.

Loans are secured by the participant's vested account balance and bear interest at the prime rate as published in the Wall Street Journal plus one percentage point. Loan terms may not exceed five years unless for the purchase of a principal residence. Principal and interest, at rates ranging from 4.25% to 9.5%, are paid ratably through payroll deductions, with the final installments due at various dates through September 2048.

#### **Vesting**

Participants are 100% vested in their deferral contributions plus actual earnings thereon and Company safe harbor matching contributions. Vesting in Company discretionary profit sharing contributions is based on years of service. Participants are 20% vested in these contributions after two years of service, increasing 20% each year thereafter, and are fully vested after six years of service. Participants also become fully vested in these contributions upon reaching normal retirement age of 65, or upon disability or death.

### Notes To Financial Statements *(Continued)*

#### **Forfeitures**

When certain terminations of participants in the Plan occur, the nonvested portion of the participant's account, as defined in the Plan Document, represents a forfeiture. Forfeitures are utilized to pay Plan expenses and then to reduce the Company's contributions for the Plan year. However, if the participant is re-employed and fulfills certain requirements, as defined in the Plan Document, the participant's account will be reinstated. No forfeitures were used to pay Plan expenses for the years ended December 31, 2024 or 2023.

#### **Administrative Expenses**

The Company pays expenses for professional services related to Plan administration. The expenses are based on customary and reasonable rates for such service. Transaction charges (for benefit payment and loan transactions) are paid by the Plan by reducing the balances of those participants initiating those transactions.

## **2. Summary Of Significant Accounting Policies**

#### **Basis Of Accounting**

The financial statements of the Plan are presented on the accrual basis of accounting.

#### **Estimates And Assumptions**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

#### **Investment Valuation And Income Recognition**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion on fair value measurements.

Purchases and sales of securities are reflected on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded as earned on the accrual basis. The net change in fair value of investments in the accompanying statement of changes in net assets available for benefits includes realized gains and losses and unrealized appreciation and depreciation.

#### **Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Delinquent notes receivable are recorded as distributions based on the terms of the Plan Document.

#### **Contributions Receivable And Credit Loss Policy**

Amounts due for contributions are stated at the amount that management expects to collect from outstanding balances less an allowance for expected credit losses. The expected credit losses amount reflects management's best estimate of amounts that will not be collected. This assessment considers historical experience, current conditions and, when appropriate, reasonable and supportable forecasts.

The Plan has concluded that no allowance for current expected credit losses was necessary at December 31, 2024 or 2023.

#### **Payment Of Benefits**

Benefits are recorded when paid.

#### **Subsequent Events**

Management evaluates subsequent events through the date the financial statements are available to be issued, which is the date of the Independent Auditors' Report.

### **3. Certified Financial Information**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments, cash, and notes receivable from participants held at December 31, 2024 and 2023, and net change in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Charles Schwab Trust Bank. This information has not been audited by the Plan's independent auditor.

### **4. Fair Value Measurements**

The Plan utilizes an established framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described below:

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

#### **Mutual Funds**

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end investment companies that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

#### **Collective Investment Trusts**

Valued at the NAV of units of a collective trust. The NAV, as provided by Charles Schwab Trust Bank (the Custodian), is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant-directed redemptions can be made on any business day and do not have a redemption notice period. There are no unfunded commitments at December 31, 2024 or 2023. All of the collective investment trusts held by the Plan file an annual report on Form 5500 as a direct filing entity.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right to amend the Plan and to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, all participants would become 100% vested in their accounts.

## **6. Income Tax Status**

Effective January 1, 2011, the Company adopted the Retirement Plan Services L.L.C. Defined Contribution Pre-Approved Plan and Trust. The sponsor received a favorable opinion letter from the Internal Revenue Service (the IRS) on June 30, 2020 which stated that the pre-approved plan document satisfies the applicable provisions of the Code. The pre-approved plan document has been amended since receiving the opinion letter. The Plan itself has not received a determination letter from the IRS. However, the Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan, as amended, is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **7. Risks And Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

## **8. Party In Interest Transactions**

The Plan has an agreement with EPIC Retirement Plan Services to provide recordkeeping services and the Plan invests in collective investment trusts managed by the Custodian. Also, participants have outstanding loans with the Plan as of December 31, 2024 and 2023. These transactions are considered party in interest transactions allowable under ERISA.
