## **Independent Auditors' Report**

To the Plan Administration of

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed the audits of the financial statements of Qosina Corp. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### **Notes to Financial Statements**

#### **NOTE 1 – PLAN DESCRIPTION**

The following brief description of Qosina Corp. 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

##### **General**

The Plan is a defined contribution plan covering all eligible employees of Qosina Corp. (the "Sponsor" or "Company") excluding union employees and non-resident aliens who receive compensation from the Company. The Plan also covers all eligible employees of Components.com, Inc., an affiliate of the Sponsor. Eligible employees can enroll and begin contributing to the Plan on the first day of each calendar month of the Plan year, coincident with or next following satisfaction of the eligibility requirement. The Plan has been amended to comply with the latest applicable tax laws and regulations. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

On July 15, 2023, the Plan transferred its assets and changed its recordkeeper, custodian and trustee from Empower Retirement/Empower Trust Company ("Empower") to Charles Schwab Trust Bank ("Schwab").

##### **Contributions**

Each year, participants may contribute up to 92% of their annual wages up to a maximum (\$23,000 in 2024 and \$22,500 in 2023) permitted by the Internal Revenue Service ("IRS"). Participants who turn age 50 or older in the current calendar year may elect to defer additional amounts (called "catch-up contributions") to the Plan. The maximum catch-up contribution that participants could make in both 2024 and 2023 was \$7,500. The Company will make matching contributions in an amount equal to 100% of elective deferral contributions up to \$1,200. Each Plan year, the Company may, but is not required to, make a discretionary and/or a qualified nonelective contribution to the Plan on behalf of all participants eligible at year end. Such contributions are to be allocated pro-rata over compensation using the Taxable Wage Base under the Social Security Act integration level, provided Internal Revenue Code ("IRC") Section 401(k) is satisfied with any remaining contribution allocated pro-rata over compensation.

##### **Forfeited Accounts**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1,817 and \$8,109, respectively. These accounts are used to pay Plan expenses and to reduce future employer contributions. For the year ended December 31, 2024, Plan expenses of \$28,083 were paid from forfeited non-vested accounts.

##### **Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of the Sponsor's contribution and Plan earnings or losses and charged with an allocation of expenses. Allocations are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### **Vesting**

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Sponsor's contribution portion of their accounts is based on years of continuous service. A participant is 20% vested after two years of credited service, another 20% vested each year thereafter, and is 100% vested after six years of credited service.

### **Notes to Financial Statements**

#### **NOTE 1 – PLAN DESCRIPTION (continued)**

##### **Investment Options**

Upon enrollment in the Plan, a participant may direct contributions to any of the investment options offered under the Plan. Participants may change their investment options at their discretion.

##### **Notes Receivable from Participants**

Participants may borrow against their vested interest up to 50 percent of their balance up to a maximum of \$50,000 and minimum of \$1,000, subject to the provisions set forth in the Plan. A participant can have one loan outstanding at a time, and loan refinancing is not permitted. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 4.25 to 9.50 percent, which are commensurate with local prevailing rates as determined quarterly by the Plan administrator, and are generally payable in installments over periods ranging from one to five years (unless the loan is used for the purchase of a primary residence, in which case the repayment period may be longer). Principal and interest are paid ratably through payroll deductions. A loan that is considered in default is reported as a deemed distribution, which is a taxable event for the participant.

##### **Payment of Benefits**

On termination of service, death, disability or retirement, a participant's entire available account balance is paid in either a lump-sum amount or various annuity options as soon as it is administratively feasible following the termination of employment and the consent of the participant, but in no event later than the 60<sup>th</sup> day following the close of the Plan year in which the participant reaches normal retirement age.

#### **NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

##### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

##### **Investment Valuation and Income Recognition**

Certain investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's retirement committee determines the Plan's valuation policies utilizing information provided by the custodian. See Note 4 for a discussion of fair value measurements.

Fully benefit-responsive investment contracts ("FBRIC") held by a defined-contribution plan are required to be reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)**

##### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (“U.S. GAAP”) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### **Administration of the Plan**

Administrative expenses of the Plan may be paid by the Sponsor or by the Plan at the election of the Sponsor. Currently, the Sponsor pays most administrative expenses. Expenses that are paid by the Sponsor are excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments.

##### **Payment of Benefits**

Benefits are recorded when paid.

##### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan documents. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

#### **NOTE 3 – INVESTMENTS – INFORMATION PREPARED AND CERTIFIED BY EMPOWER AND SCHWAB AS COMPLETE AND ACCURATE**

The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified to be complete and accurate by Empower and Schwab. Empower was the custodian, recordkeeper and trustee of the Plan for the period from January 1, 2023 through July 14, 2023. Effective July 15, 2023 Schwab is the custodian, recordkeeper and trustee of the Plan for substantially all assets except for one guaranteed investment contract still held with Empower, that due to rules of the contract, must be transferred over a 5-year run-out period ending in 2028.

#### **NOTE 4 – FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, “Fair Value Measurement,” provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurements.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

#### **Mutual Funds**

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

#### **Pooled Separate Accounts**

Pooled separate accounts invest in mutual funds in which the fair value of mutual funds are used in determining the Net Asset Value (“NAV”) of the pooled separate accounts. On July 15, 2023, the Plan transferred its assets and changed its recordkeeper, custodian and trustee from Empower to Schwab, and investments that were previously classified as pooled separate accounts were transferred to mutual funds. As of December 31, 2023, no pooled separate accounts were held by the Plan.

#### **NOTE 5 – INVESTMENT CONTRACTS WITH INSURANCE COMPANIES – INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIANS AS COMPLETE AND ACCURATE**

The Plan entered into a fully benefit-responsive investment contracts with Empower and with New York Life Insurance Company (“New York Life”) for the years ended December 31, 2024 and 2023, which maintain the contributions in general accounts. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuers are contractually obligated to repay the principal and a specified interest rate (not to go below 0%) that is guaranteed to the Plan. The crediting rates are based on a formula established by the contract issuers, which is reviewed on a semi-annual basis for resetting. The guaranteed investment contracts do not permit the insurance companies to terminate the agreements prior to the scheduled maturity dates.

Because the guaranteed investment contracts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contracts. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contracts permit redemptions subject to competing fund restrictions.

There are no reserves against contract value for credit risk of the contracts or otherwise. The crediting interest rates are based on a formula agreed upon with the issuers. The average interest rate for the Empower contract was 3.00% for the years ended December 31, 2024 and 2023. The minimum interest rate for the New York Life contract is 2.70% and 3.00% for the years ended December 31, 2024 and 2023, respectively, and the crediting interest rate was 4.75% and 5.25% at December 31, 2024 and 2023, respectively.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

#### **NOTE 5 – INVESTMENT CONTRACTS WITH INSURANCE COMPANIES – INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIANS AS COMPLETE AND ACCURATE (continued)**

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include, but may not be limited, to the following: (1) the complete or partial termination of the Plan; (2) the establishment or activation of, or material change in, any Plan investment fund; (3) an amendment to the Plan or (4) change in the administration or operation of the Plan, including the removal of a group of employees from Plan coverage as a result of the sale or liquidation of a subsidiary or division or as a result of group layoffs or early retirement programs. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at the contract value with participants are probable of occurring. No events or circumstances would allow the issuer to terminate the contract and settle at an amount different than that of the contract value.

#### **NOTE 6 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to amend or terminate the Plan subject to the provisions of ERISA. In the event of the Plan termination, participants will become 100% vested in their accounts. Any unallocated assets of the Plan should be allocated to participant accounts and distributed in such a manner as the Sponsor may determine.

#### **NOTE 7 – TAX STATUS**

On June 30, 2020, the IRS stated that the volume submitter adopted by the Plan, as then designed, qualifies under IRC Section 401(a). The Plan has not received a determination letter specified to the Plan itself; however, the Plan administrator believes that the Plan was designed and was being operated in compliance with the applicable requirements of the IRC, and therefore believes that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements.

#### **NOTE 8 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments represent shares in mutual funds or other investments administered by Schwab which qualify as party-in-interest transactions. Administrative fees paid by the Plan amounted to \$87,443 for the year ended December 31, 2024.

#### **NOTE 9 – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### **NOTE 10 – DELINQUENT REMITTANCES**

During 2024, the Company failed to deposit \$16,428 of participant deferrals within the required time frame as stated by the Department of Labor. There are Department of Labor regulations which require that the employee contributions be transferred to the Plan as of the earliest date on which such contributions can reasonably be segregated from the Company's general assets. In connection with the late remittances to the Plan that will be corrected outside the VFCP, the Company will reimburse the participants for lost earnings as calculated using the Department of Labor lost earnings calculator.

#### **NOTE 11 – SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.
