NOTES TO THE FINANCIAL STATEMENTS
DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following description of the 401(k) Profit Sharing Plan for Employees of United States Equestrian Federation, Inc. (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by the United States Equestrian Federation, Inc. (the Company) for the benefit of substantially all employees of the Company. The Plan was established January 1, 2001 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Eligible employees, as defined in the plan document, are able to make or receive contributions under the Plan beginning on their date of hire. Employees are included as a participant in the plan on the first day of the month coinciding with the date of hire.

Contributions

Employees may make annual Roth and pre-tax deferral contributions up to the maximum annual deferral amount defined by the Internal Revenue Code (IRC). The Plan provides for an automatic employee salary deferral contribution of 2 percent of an employee's eligible compensation, unless the employee opts to elect a different deferral percentage or elects to not make a salary deferral contribution within 30 days of hire date. The automatic contribution begins immediately after a new participant meets eligibility requirements.

The Company will determine annually the rate at which elective contributions will be matched, and the maximum amount of elective contributions which will be matched. The employee must be employed on the last day of the plan year to receive a matching contribution. In addition, the Company may make an additional non-matching discretionary contribution to the Plan, however, no such contribution was made for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions and an allocation of any Company contributions, as well as allocations of plan earnings or losses. Each participant's account is charged with his or her withdrawals and an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Vesting

Participants are vested immediately in their elective and rollover contributions, plus actual earnings thereon. A participant is vested in the Company's contribution portion of their account, if any, plus actual earnings thereon based upon a vesting schedule that provides vesting of 20% after one year of service and increasing by 20% for each additional year of service until fully vested after five years of service. Participants are 100% vested in their entire account balances upon reaching normal retirement age (as defined), disability, or death.

Notes Receivable from Participants

Participants may borrow a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid through payroll deductions.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested account. In-service distributions are allowed for vested employer contributions for participants who are at least 55 years of age or have 20 years of service, and are allowed for all contributions once a participant reaches age 59-1/2. As defined in the plan documents, certain participants are also eligible for hardship distributions, consistent with the provisions of the Internal Revenue Code.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled to \$18,311 and \$8,984, respectively. Forfeited balances of terminated participants' nonvested accounts are used to reduce future Company matching contributions or reduce plan expenses. For the year ended December 31, 2024, no forfeitures were used to pay Plan expenses or reduce Company contributions.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are maintained in pooled separate accounts and represent the number of participation units owned by the Plan. The Plan values its investments at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Changes in fair value of investments are reflected in the statement of changes in net assets available for benefits in the year in which such changes occur. Changes in fair value of investments include the Plan's gains and losses on investments bought and sold as well as held during the year. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Payment of Benefits

Benefits are recorded when paid.

Administrative and Investment Management Expenses

Certain administrative expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment-related expenses are included in net appreciation of fair value of investments.

Subsequent Events

Plan management has evaluated events or transactions occurring subsequent to the statement of net assets available for benefits date for recognition and disclosure in the accompanying financial statements through the date the financial statements were available to be issued, which is October 27, 2025. See Note 10.

3. INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Mutual of America Life Insurance Company, the custodian of the Plan, has certified to the completeness and accuracy of all investments and notes receivable reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and investment-related activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). However, in accordance with Subtopic 820-10, certain investments that were measured at net asset value per share (or its equivalent) have not been classified in the fair value hierarchy.

Investments Measured Using the Net Asset Value per Share Practical Expedient

The following table summarizes investments for which fair value is measured using the net asset value per share practical expedient as of December 31, 2024 and 2023. There are not participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

5. FULLY-BENEFIT RESPONSIVE INVESTMENT CONTRACT

The Plan holds a deposit administration contract that meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

The Interest Accumulation Account is a deposit administration contract issued by Mutual of America Life Insurance Company, the custodian of the Plan. Mutual of America Life Insurance Company maintains the contributions in an unallocated fund, whose assets are invested with other asset in the general account of Mutual of America Life Insurance Company. The account is credited with earnings on the underlying investments and charged for plan withdrawals and administrative expenses charged by Mutual of America Life Insurance Company. The deposit administration contract is included in the financial statements at contract value of approximately \$141,000 and \$62,000 as of December 31, 2024 and 2023, respectively. The deposit administration contract paid a rate of approximately 2.85% and 1.60%, as of December 31, 2024 and 2023.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code
2. Premature termination of the contracts
3. Plan termination or merger
4. Changes to the Plan's prohibition on competing investment options
5. Bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines
2. A breach of material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreements without the consent of the issuer.

6. RELATED-PARTY AND PARTY-IN-INTEREST

Parties-in-interest are defined under Department of Labor regulations as a fiduciary of the Plan, any party rendering service to the Plan, the Company and certain others. Investment management fees are paid to the custodian and group annuity contract holder, Mutual of America Life Insurance Company. Mutual of America Life Insurance Company, is also the Plan's third party administrator. Blue & Co., LLC is the independent auditor of the Plan. The aforementioned parties generally receive payment from the Company. Additionally, the Trustee is a participant in the Plan.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in the company contribution portion of their accounts.

8. TAX STATUS

The Plan has adopted a pre-approved plan document sponsored by Mutual of America Financial Group, which has received an opinion letter from the Internal Revenue Service (IRS) dated November 30, 2020, stating that the form of the pre-approved plan document, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believe that the Plan is qualified and that the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by various federal and state taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the accompanying financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

10. SUBSEQUENT EVENTS

Effective January 1, 2025, the Plan transitioned to a safe harbor 401(k) plan under Section 401(k)(12) of the Internal Revenue Code. Prior to the transition, employer contributions were discretionary.

Under the new safe harbor structure:

- The plan provides for mandatory employer contributions in the form of matching contributions.
- Safe harbor matching contributions are made at 100% of employee's salary deferrals that do not exceed 3% of compensation plus 50% of salary deferrals between 3% and 5% of compensation.
- All safe harbor contributions are subject to the vesting schedule disclosed in Note 1.
