The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to the Financial Statements

1. Description of the Plan

The following description of the S & S Firestone, Inc. 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan Document, adoption agreement, and Plan Summary for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution retirement plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), and became effective April 1, 1994, and was restated effective June 24, 2015. The Plan was most recently amended on March 29, 2022, with an effective date of May 3, 2022. The Plan covers all eligible employees of S&S Firestone, Inc. and its affiliated companies (the Plan Sponsor and Administrator).

Eligibility

Employees are eligible to participate in the Plan once they have at least three months of employment and are age 21 or older. Eligible participants can enter the Plan on the first day of the month on or following their date of eligibility. At that time, participants can begin deferring compensation into the Plan, and become eligible for both the employer matching and employer nonelective contributions.

Contributions

Participants may contribute up to the lesser of 75% of eligible compensation or the maximum allowable annual contribution as defined by the Internal Revenue Code (IRC). Participants may also contribute amounts representing distributions from other qualified defined contribution plans. Participants may contribute a portion or all of the deferral contributions to a Roth 401(k) and those contributions are includable in the Participant's gross income at the time deferred. The Plan Sponsor makes matching contributions of employees' salary deferral amounts of 50% of the first 3% of eligible compensation and 25% of the next 3% of eligible compensation.

Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution and the Plan Sponsor's contributions, an allocation of Plan earnings or losses, and administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan adoption agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Participants direct the investment of their contributions into various investment options offered by the Plan. If no such direction is made, participant accounts are invested in accordance with default investment alternatives as established under the Plan. The Plan Sponsor's contributions are automatically invested in the same investment options at the same percentage as participant deferral contributions.

1. Description of the Plan, continued

Vesting

Participants are vested immediately in their voluntary contributions plus actual earnings thereon. Participants are vested in the Plan Sponsor's matching contribution portion plus earnings thereon according to the following schedule:

The nonvested balance is forfeited upon termination of service.

Participant Loans

Participants may borrow up to a maximum of the lesser of \$50,000 or 50% of their vested balance, reduced by the highest outstanding loan balance in the preceding 12 months. All loans are covered by notes and are repayable over a period not to exceed five years (except for loans for the purchases of a principal residence) through payroll withholdings unless the participant is paying the loan in full. Interest on the loans is based on local prevailing rates as determined by the Plan Administrator, who has set the rates at the prime rate plus 1%.

Payment of Benefits

Upon termination of service, participants may elect to receive either a lump sum amount or installments equal to the value of the participant's vested interest in his or her account. Withdrawals, other than for termination, are permitted under certain circumstances provided by the Plan.

Administrative Expenses

Certain administrative expenses of the Plan are paid by the Plan as provided in the Plan adoption agreement. All other administrative expenses are paid by the Plan Sponsor.

Forfeited Accounts

As of December 31, 2024 and 2023, forfeited accounts totaled \$2,897 and \$5,766, respectively. These accounts may be used to reduce future employer contributions. Employer contributions were reduced by \$40,748 from forfeited nonvested accounts for the year ended December 31, 2024.

1. Description of the Plan, continued

Risks and Uncertainties

The Plan provides for participant directed investment options in various securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

2. Summary of Significant Accounting Policies

The financial statements have been prepared in conformity with accounting principles generally accepted in the United States of America (GAAP) which require management to make estimates and assumptions that affect the reported amounts and disclosures in the financial statements. Actual results could differ from those estimates. The following is a summary of the significant accounting policies consistently followed by the Plan in the preparation of its financial statements:

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains or losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the matching contributions from the Plan Sponsor are recorded in the year in which participant contributions are withheld from compensation.

Notes Receivable from Participants

Participant loans are classified as notes receivable from participants and are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based on the terms of the Plan document.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Subsequent Events

The Plan's management has evaluated subsequent events for accounting and disclosure requirements through October 27, 2025, the date that the financial statements were available to be issued.

3. Information Certified and Provided by Trustee

The Plan's asset information included in this note and throughout the Plan's financial statements and supplemental schedule were prepared by or derived from information provided by the Fidelity Management Trust Company (Fidelity), the trustee of the Plan, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the trustee that asset information provided to the Plan Administrator by the trustee related to the asset information is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to asset information in this note and which appears throughout the financial statements and the supplemental schedule.

Fidelity certified the completeness and accuracy of \$1,751,068 of net realized and unrealized appreciation in the fair value of the investments, \$319,943 of interest and dividends related to the investments, and \$29,650 of interest on notes receivable from participants for the year ended December 31, 2024.

4. Fair Value Measurements

The Plan classifies its investments based on a hierarchy consisting of: Level 1 (valued using quoted prices from active markets for identical assets), Level 2 (not traded on an active market but for which observable market inputs are readily available), and Level 3 (valued based on significant unobservable inputs). The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

4. Fair Value Measurements, continued

Following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trusts: Valued based on the net asset value (NAV) of units of the collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimating fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan Administrator believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another.

5. Exempt Party-in-Interest Transactions

Certain Plan investments are shares of mutual funds managed by Fidelity. Fidelity is the trustee as defined by the Plan and therefore, these transactions qualify as party-in-interest. Administrative expenses of \$84,147 for the year ended December 31, 2024 are comprised of fees paid by the Plan to parties-in-interest for investment management services, investment advisory, and withdrawal charges.

Additionally, indirect fees are paid to Fidelity based on investment account values. These fees range from 0.02% to 0.57% of the investment account value. These fees reduce net appreciation of the fair value of investments on the statement of changes in net assets available for benefits.

6. Tax Status

The Plan uses a prototype Plan document sponsored by Fidelity. Fidelity received an opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

7. Plan Termination

Although it has not expressed any intention to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA.

8. Excess Contributions Payable

During 2025, payments of \$39,031 were made to certain active participants to return to them excess deferral contributions as required to satisfy the relevant nondiscrimination provisions of the Plan for the Plan year ended December 31, 2024.

During 2024, payments of \$81,156 were made to certain active participants to return to them excess deferral contributions as required to satisfy the relevant nondiscrimination provisions of the Plan for the Plan year ended December 31, 2023.

9. Contingencies

The Company has historically treated certain compensation as being excluded from employees' compensation for purposes of administering the Plan. This practice has been consistently followed for all employees since the inception of the Plan. During 2025, it was determined that the definition of compensation, per the Plan document, does include these certain compensation. The Plan Sponsor is correcting the failure in accordance with the IRS Employee Plans Compliance Resolution System (EPCRS) under Revenue Procedure 2021-30. As of October 27, 2025, the Plan Sponsor has initiated the correction process and intends to complete all corrective actions under the Self-Correction Program (SCP) within the permitted timeframe. The Plan has not determined any exposure of loss related to this issue.
