Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Columbia Southern Education Group 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Note 1: Description of the Plan

The following description of the Columbia Southern Education Group 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan that covers all eligible employees of Columbia Southern Education Group, Inc. (the Company) and its subsidiaries. All Company employees are eligible to participate in the Plan if they meet the requirements of being at least 21 years of age and have been credited with 6 months of service. The participants' entry date is the first day of the next quarter after eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute annual compensation up to the federal maximum, as defined by the Plan. Participants may make pre-tax elective deferral contributions or Roth elective deferral contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan allows participants to modify salary deferral elections on the first day of each quarter. Participants may also contribute amounts representing distributions from other qualified benefit or contribution plans.

The Company may elect to make employer matching contributions under the "safe harbor" provision of the Plan documents. The Company elected to make a "safe harbor" matching contribution equal to 100% of participant deferrals up to 3% of the participant's compensation and match 50% of deferrals for compensation between 3% and 5% of total compensation, totaling \$1,154,595 for the year ended December 31, 2024.

The Company may elect to make discretionary employer matching contributions and discretionary profit sharing contributions. For the year ended December 31, 2024, the Company did not elect to make any discretionary employer matching contributions or discretionary profit sharing contributions.

Participant Accounts

Each participant's account is credited/debited with the participant's contribution and allocations of (a) the Company's contribution and (b) Plan earnings/losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note 1: Description of the Plan, Continued

Vesting

Participants are immediately vested in their contributions, discretionary matching contributions, and employer contributions made under the “*safe harbor*” provisions plus actual earnings thereon. Participants vest in the profit sharing contributions plus actual earnings thereon based on years of continuous service. During the first year of service, a participant begins vesting 20% each year and is 100% vested in the Company profit sharing contributions after five years of credited service.

Investment Options

The Plan provides participants with several investment options. These investment options consist of various pooled separate accounts. Plan participants may direct the change of their investment options.

Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant’s vested interest in his or her account. For termination of service due to other reasons, a participant may receive or rollover into a qualified plan the value of the vested interest in his or her account as a lump-sum distribution, net of tax withholdings, if applicable. The Plan allows for in-service withdrawals by participants who have attained the normal retirement age of 59 ½. A participant may also receive hardship withdrawals, subject to certain limitations, as defined in the Plan document.

Forfeited Accounts

Forfeitures are used to reduce employer contributions or to pay Plan expenses for the Plan in the year in which forfeitures are to be allocated. During the year ended December 31, 2024, no forfeitures were used by the Plan.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Note 2: Summary of Significant Accounting Policies, Continued

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Plan Expenses

Certain administrative expenses are paid for by the Plan. All other expenses of maintaining the Plan are paid directly by the Company.

Financial Statement Presentation

Certain amounts in the 2023 financial statements have been reclassified to conform to the 2024 presentation.

Note 3: Investments Certified by the Custodian

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock Life Insurance Company (John Hancock), the custodian, has certified that the following information included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments as shown on the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments for the year ended December 31, 2024, as included in the statement of changes in net assets available for benefits.
- The schedule of assets (held at end of year) as of December 31, 2024, as shown on Schedule H, Line 4i.

At the request of the plan administrator, the Plan's independent certified public accountants did not perform procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule. All other information has been audited in accordance with auditing standards generally accepted in the United States of America.

Note 4: Fair Value Measurement

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). There are three levels of the fair value hierarchy under FASB ASC 820. Level 1 inputs are quoted market prices in active markets for identical investments that the Plan has the ability to access at the measurement date. Level 2 inputs are inputs other than quoted market prices included within Level 1 that are observable for the Plan's investments, either directly or indirectly. Level 3 inputs are unobservable inputs for the Plan's investments.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for the investments measured at fair value.

Pooled separate accounts - These investments are valued at the net asset value (NAV) of units held by the Plan at year-end, as determined by the insurance company. The NAV is used as a practical expedient to estimate fair value. The NAV of pooled separate accounts is based on the market value of the underlying investments and observable inputs. The investment objectives and underlying investments of the separate accounts vary depending on the pooled separate account. There are no unfunded commitments and the investment can be redeemed on a daily basis.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan has concluded that its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The pooled separate accounts, which are measured at net asset value, are not required to be included within the fair value hierarchy. The Plan held these investments totaling \$35,751,723 and \$29,927,543 at December 31, 2024 and 2023, respectively.

Note 5: Parties-in-interest Transactions

Certain Plan investments are managed by John Hancock, the custodian, as defined by the Plan and is a party-in-interest. The Plan incurred certain administrative fees of \$150,021 for the year ended December 31, 2024. The Company pays any other fees related to the Plan's operations.

Note 6: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 7: Tax Status

The Plan has adopted a John Hancock Non-Standardized Defined Contribution Pre-Approval Plan, that the Internal Revenue Service (IRS) approved by a letter dated June 30, 2020. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore believes that the Plan is qualified and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and believes there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 8: Excess Contributions

To meet the relevant nondiscrimination provisions of the Plan, excess contributions totaling \$7,744 and \$1,736 as of December 31, 2024 and 2023, respectively, are recorded as other liabilities on the accompanying statements of net assets available for benefits.

Note 9: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

In August 2025, the Plan changed from John Hancock to Fidelity Management Trust Company and transferred the Plan's assets.
