### Opinion

We have audited the financial statements of EnSafe Inc. Employee Stock Ownership Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

### Note 1 - Description of Plan

The following description of EnSafe Inc. Employee Stock Ownership Plan (the "Plan") provides only general information. Participants should refer to the plan document and summary plan description for complete information of the Plan's provisions, which are available from the plan administrator.

#### General

EnSafe Inc. (the "Company") established the EnSafe Inc. Employee Stock Ownership Plan effective January 1, 1997. The Plan is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code (IRC) of 1986, as amended. Employees of the Company are generally eligible to participate in the Plan after one year of service provided they work a minimum of 1,000 hours during their first twelve months of employment and have attained age twenty-one (21). The Plan is administered by the Trustees as appointed by the Board of Directors. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan receives Company common stock contributed in-kind by the Company. The Plan holds the stock in a trust established under the Plan. All shares of stock are allocated to eligible employees' accounts when received.

The Trustees exercise voting rights for the Company common stock held as a part of the Plan assets. Each participant is entitled to direct the Trustees regarding voting rights on Company common stock allocated to his or her account as it relates to certain matters defined in the Plan Agreement.

#### Contributions

The Company makes discretionary contributions to the Plan as determined by the Board of Directors. The discretionary contributions are used to invest in Company stock and are allocated to participants based upon each participant's eligible compensation in proportion to the total eligible compensation of all participants. Participants must work a minimum of 1,000 hours of service during a plan year and be employed on the last day of a plan year to share in an allocation of the Company common stock for such year. Discretionary contributions totaled \$700,001 for 2024 and \$700,000 for 2023. Employee contributions are not permitted.

#### Participant accounts

Each participant's account is credited with an allocation of the Company's common stock, plus a proportionate interest in the investment income or losses. Each participant's account is also credited with any forfeitures of participant nonvested account balances. Allocations are based upon the participant's eligible compensation or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants vest in all accounts and related investment income or losses based upon years of service with 100% vesting occurring after six years of credited service. In the event of death, disability, normal retirement age (59½), or if the Plan is discontinued, participants become 100% vested in all account balances.

#### Forfeited accounts

Plan forfeitures are allocated to each participant's account based upon the relation of the participant's eligible compensation to total eligible compensation for the Plan year. Forfeitures totaled \$15,357 in 2024 and \$62,227 in 2023. Such forfeitures have been reallocated to participants' accounts in the respective years.

#### Payment of benefits

Distributions on account of death, disability or attainment of normal retirement age, are made in a lump sum in the Plan year following the event. For distributions for other separations from service including termination of employment with the Company, a participant may request to receive a distribution. Withdrawals by a participant while employed are limited to those requested upon the attainment of age 59½. Participants can elect to receive benefits as a single lump-sum payment or installments over a period of time as defined by the plan document. All distributions from the Plan are made in cash.

#### Put option

Under Federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current appraised value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

#### Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company common stock into investments which are more diversified. Participants who are at least age fifty-five (55) or older with at least ten (10) years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five (5) years, a participant may diversify up to twenty-five percent (25%) of the number of post-1986 shares

#### Diversification (continued)

allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to fifty percent (50%). Participants who elect to diversify will receive a cash distribution. The election to diversify is made subsequent to year end based upon the shares of Company stock in the participant's account at year end.

#### Voting rights

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by the Trustees prior to the time that such rights are to be exercised. The Trustees are not permitted to vote any allocated shares outside of the ESOP for which instructions have not been given by a participant. The Trustees are required, however, to vote any unallocated shares on behalf of the collective best interest of Plan participants and beneficiaries.

### Note 2 - Summary of significant accounting policies

#### Basis of accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

#### Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

#### Investment valuation and income recognition

The shares of Company stock are reported at fair value. See note 4 for discussion of fair value measurements. Purchases and sales of EnSafe Inc. common stock are recorded on a trade-date basis. Net appreciation in fair value of investment represents the Plan's gains and losses on EnSafe Inc. common stock bought and sold as well as held during the year.

#### Contributions

Contributions from the Company are recorded in the year in which participant compensation is earned.

#### Payments of benefits

Benefits are recorded when paid.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, are described as follows:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

### Note 4 - Fair value measurements (continued)

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used as of December 31, 2024 and 2023.

The EnSafe Inc. common stock held by the Plan is reported at fair value based upon an appraisal. This appraisal was based upon a combination of the market and income valuation techniques consistent with prior years as illustrated in the following table. The appraiser took into account earnings, revenues, forecasted results, valuation metrics of recent merger and acquisition transactions, and a minority discount factor. The valuation amount was \$72 per share as of December 31, 2024 and \$57 per share as of December 31, 2023. There was a 4:1 stock split during 2023.

The valuation process involves plan management's selection of an independent appraiser. Plan management accumulates the data for the appraiser from the audited financial statements of the Company, historical information and internal budgets of the Company. The recordkeeper prepares a statement of estimated per share value that a participant will receive upon distribution. The appraiser prepares a preliminary report which plan management reviews in detail, discusses and approves.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note 5 - Related party and party-in-interest transactions

The Company provides the Plan with certain management and administrative services for which no fees are charged. The Plan also has a number of service providers that qualify as parties-in-interest under ERISA.

### Note 6 - Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions. Upon such termination of the Plan, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and related regulations. Upon termination of the Plan, the Trustees shall pay all liabilities and expenses of the trust fund.

### Note 7 - Tax status

The Plan has received a favorable determination letter dated June 6, 2017, stating that the Plan qualifies under the applicable sections of the IRC and is, therefore, not subject to tax under present income tax law. The Plan, which has been amended since receiving the determination letter, is required to operate in conformity with the IRC to maintain its qualification. Management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service (IRS). The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

### Note 8 - Risks, uncertainties and concentrations

The Plan invests solely in the Company's common stock, which is exposed to various risks, such as interest rate, market, and credit risk. Market risks include global events which could impact the value of the Company's common stock, such as a pandemic or international conflict. Due to the level of risk associated with the Company's common stock, it is at least reasonably possible that changes in the values of the Company's common stock will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits

The Plan's assets are entirely invested in the Company's common stock. As a result of this concentration, any significant decrease in the fair value of this stock would adversely affect individual participant accounts and the net assets of the Plan.

### Note 9 - Subsequent events

Plan management has evaluated subsequent events through October 27, 2025, which is the date that the financial statements were available to be issued. No significant matters were identified for disclosure during this evaluation.
