NOTE 1 - PLAN DESCRIPTION

The following is a brief description of the Vivamee Hospitality 401(k) Plan (the "Plan"). It is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established on January 1, 2022. The Plan is available to all employees of companies owned by Vivamee Shared Service, Inc. ("Vivamee"). Participating companies owned by Vivamee include: Renault FBS, LLC; Kent Manor FBS, LLC; Vivamee Construction, LLC, LBI National FBS, LLC, and Accountable Equity, LLC. The participating companies mentioned above are collectively referred to as the "Company" or "Companies". The Plan is subject to the Employee Retirement Income Security Act of 1974, as amended ("ERISA") and the Internal Revenue Code of 1986 ("IRC"), as amended. The Plan is administered by Vivamee. All Plan investments are held by Principal Life Insurance Company ("Principal"), which serves as the trustee.

Eligibility

Eligibility for the various classes of employees are determined as follows, once they have attained 21 years of age:

- a) Salaried employees are eligible upon commencing employment.
- b) Hourly employees are eligible on the first day of the month following 60 consecutive days of employment.
- c) Part-time employees whose regularly scheduled service is less than 24 hours per week will become eligible in the event that they complete 1,000 hours in a calendar year, on the first day of the following month.
- d) Seasonal employees will become eligible in the event that they complete 1,000 hours in a calendar year, on the first day of the following month.

Contributions

The Plan provides for four categories of contributions:

- a) ***Elective Deferrals*** – An eligible employee may elect a reduction of compensation up to annual statutory limitations.
- b) ***Rollovers*** – The Plan allows participants to transfer contributions into the Plan from another qualified plan.
- c) ***Employer Profit Sharing Contributions*** – The Employer may make profit sharing contributions for all employees who have attained 21 years of age and completed one year of service in a calendar year (1,000 hours of service). The employer made no such profit sharing contributions during the life of the Plan.
- d) ***Employer Discretionary Matching Contributions*** – The Employer may make matching contributions for all employees who have attained 21 years of age and completed one year of service in a calendar year (1,000 hours of service). The employer made no such matching contributions during the life of the Plan.

NOTE 1 - PLAN DESCRIPTION (CONTINUED)

The Plan includes an automatic salary deferral feature that is triggered for all employees once they become eligible to participate in the Plan, unless the employee opts out of this feature. Automatic deferrals are equal to 3% of compensation and are deposited into an age-targeted retirement fund on a pre-tax basis.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and, (b) plan earnings, and charged with an allocation of administrative expenses and allocated forfeitures. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Benefit Payments

Benefits are recorded when paid. Upon termination of service due to death, disability or retirement, a participant may elect to receive his or her accrued benefit in the form of either a lump sum or installments.

Vesting

Participants are vested immediately in their contributions, rollovers and transfer contributions. Both employer matching and profit sharing contributions are vested to participants according to the following schedule

The Plan may use forfeitures to pay Plan expenses.

Participant Loans

The Plan has a loan provision that allows participants to borrow amounts up to a maximum equal to the lesser of \$50,000 or 50% of the vested account balance. The loans are secured by the balance in the participant's account. Interest rates are calculated at the prime rate +1% at the time of loan initiation. The loans are fully amortizable and must be repaid within five years, except in the case of a loan for the purpose of acquiring a primary residence.

Plan Expenses

Certain administrative expenses are paid by the Plan unless paid by the Employer.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”).

Subsequent Events

The Plan has evaluated all events or transactions that occurred after December 31, 2024, up through the date that the financial statements were available to be issued on October 30, 2025.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be recovered to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the investment date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year. Purchases and sales of securities are recorded on a trade date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ accounts balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Fair Value Measurements

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, Fair Value Measurement, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). Categorization within the valuation hierarchy is based upon the lowest level of input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Fair value is defined as the exit price, or the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and, inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement.

NOTE 3 - INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information marked "Certified by Trustee," which was certified by Principal Life Insurance Company (the "Trustee") as of March 13, 2025, and for the period from January 1, 2025 through March 13, 2025, except for comparing such information certified by the Trustee to information included in the Plan's financial statements and supplemental schedule of assets held at end of year.

NOTE 4 - TAX STATUS

The Plan is designed as a Non-Standardized Pre-Approved Profit Sharing Plan, which received its latest favorable determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan was qualified pursuant to Section 401(a) of the Internal Revenue Code, and, accordingly, that the Plan's net investment income is exempt from income taxes. The Plan has been amended since receiving the determination letter. Plan Management believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC; therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of March 31, 2025, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 5 - RELATED PARTY TRANSACTIONS

Certain Plan investments are shares of common collective trusts and pooled separate accounts managed by the Trustee. Accordingly, these transactions qualify as party-in-interest transactions.
