(TFLIC) and Transamerica Trust Company (TTC) for the year ended December 31, 2024 and for the six months from July 1, 2024 to December 31, 2024 and Reliance Trust Company (Reliance) as of June 30, 2024 and December 31, 2023 and for the six months from January 1, 2024 to June 30, 2024, the custodians of The Bay Co. 401(k) Plan, stating that the certified investment information as described in Note 9 to the financial statements is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by TFLIC and TTC and Reliance agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of The Bay Co. 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free of material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about The Bay Co. 401(k) Plan's ability to continue as a going concern within one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering The Bay Co. 401(k) Plan; and determining whether The Bay Co. 401(k) Plan's transactions that are presented and disclosed in the financial statements are in conformity with The Bay Co. 401(k) Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free of material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with auditing standards generally accepted in the United States of America, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Accordingly, no such opinion is expressed.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about The Bay Co. 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

Other Matter – Supplemental Schedules Required by ERISA

The supplemental schedule of assets and schedule of delinquent participant contributions are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the DOL Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with auditing standards generally accepted in the United States of America. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including the form and content, are presented in conformity with the DOL Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 – DESCRIPTION OF THE PLAN

The following brief description of The Bay Co. 401(k) Plan (the Plan), formerly the SFO Forecast, Inc. 401(k) Plan, provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General: The Plan was established effective October 1, 1995 as an employee stock ownership plan (ESOP). The ESOP was amended and restated into a 401(k) Plan effective January 1, 2013. The ESOP funds were transferred to the 401(k) Plan on February 14, 2013. The Plan is administered by the Plan’s trustees appointed by the Board of Directors of The Bay Company (the Plan Sponsor). The Board of Trustees is responsible for oversight of the Plan.

The Plan is a defined contribution plan covering all employees of the Plan Sponsor except union or leased employees and employees who are employed by an affiliated employer that does not adopt the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

In April 2021, the Plan was amended to reinstate as a Safe Harbor 401(k) Plan effective April 15, 2021. The Plan Sponsor now contributes a safe harbor match of 100% of a participant’s salary deferrals up to 3%, plus 50% of salary deferrals up to the next 2%. Participants maintained rights to employer safe harbor matching contributions earned prior to the effective date.

Contributions: Participants may make voluntary elective deferral contributions subject to limitations prescribed by the Internal Revenue Code (IRC) and rollover contributions from a qualified plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. Each year, the Plan Sponsor may also contribute to the Plan discretionary amounts as determined by the Board of Directors. Any discretionary profit sharing amounts will be credited to participants who were employed on the last day of the plan year. The Plan Sponsor made a required safe harbor matching contribution of \$250,286 and \$195,461, net of forfeitures used, for the years ended December 31, 2024 and 2023, respectively.

Participant Accounts: Separate accounts are maintained for each participant (an elective deferral contribution, an elective Roth deferral contribution, a discretionary employer profit sharing contribution account and ESOP account). Each participant’s account is credited with the participant’s elective contributions, the employer’s discretionary contribution, allocation of plan earnings (less administrative expenses) and forfeitures of the nonvested portion of terminated participants’ accounts. Investment direction for each participant’s account is provided by the participant.

Vesting: Participants are fully and immediately vested in their elective and rollover contribution accounts together with their allocated plan earnings thereon. Vesting in the Plan Sponsor’s contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after three years of credited service.

Vesting in the Plan Sponsor’s contributions plus actual earnings thereon is based on years of service as follows:

Upon death or disability, participants' accounts become fully vested.

Payment of Benefits: Generally, no distributions from the Plan will be made until a participant retires, dies (in which case payment shall be made to the designated beneficiary or, if none, to their legal representatives), becomes disabled or terminates employment. Payments will be made in a lump sum. The Plan allows for in-service distributions for eligible participants who are at least age 59½. These distributions may be paid in installments.

Forfeitures: Forfeitures of nonvested accounts may be allocated to other participants or used to reduce employer contributions or certain plan expenses. Forfeitures of \$41,989 were used to reduce plan expenses during 2024. Forfeited nonvested accounts totaled \$3,580 and \$29,186 as of December 31, 2024 and 2023, respectively.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The significant accounting policies followed by the Plan are reflected below.

Basis of Accounting: The financial statements of the Plan were prepared under the accrual method of accounting.

Investment Valuation and Income Recognition: Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. See Note 4 for further discussion of the investments at contract value. The Plan Administrator determines the Plan's investment valuation policies.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis, and dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (US GAAP) requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Benefit Payments: Benefits are recorded when paid.

Administrative Expenses: Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Fees related to the administration of distributions and terminated employees' accounts are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included under net depreciation in fair value of investments.

The Plan's financial instruments that are subject to fair value measurement and/or disclosure are summarized in Note 3.

Subsequent Events: The Plan has evaluated subsequent events through October 23, 2025, the date the financial statements were available to be issued.

NOTE 3 – FAIR VALUE MEASUREMENTS

Fair Value Measurements: The Accounting Standards Codification establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three-tier fair value hierarchy includes the following categories:

- Level 1 asset and liability fair values are based on quoted prices in active markets for identical assets and liabilities.
- Level 2 asset and liability fair values are based on observable inputs that include quoted market prices for similar assets or liabilities, quoted market prices that are not in an active market, or other inputs that are observable in the market and can be corroborated by observable market data for substantially the full term of the assets or liabilities.
- Level 3 assets and liabilities are financial instruments whose value is calculated by the use of pricing models and/or discounted cash flow methodologies, as well as financial instruments for which the determination of fair value requires significant management judgment or estimation.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Further, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Mutual Funds* – Valued at quoted market prices, which represent the net asset value of shares held by the Plan at year-end. Mutual funds are classified as Level 1 measurements.

The Plan's policy is to recognize transfers between Levels 1 and 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the years ended December 31, 2024 and 2023, there were no transfers between Levels 1 and 2 and no transfers into or out of Level 3, as the Plan did not have Level 2 and 3 investments.

NOTE 4 – INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan has a group annuity contract with Transamerica Financial Life Insurance Company that invests contributions in the Transamerica Stable Value Core Option. The Transamerica Stable Value Core Option is a general account product. The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses. As of December 31, 2024 and 2023, the Plan held \$959,884 and \$797,778, respectively.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

NOTE 5 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain investments of the Plan are shares of mutual funds managed by institutional custodians, which qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included under net appreciation in fair value of investments. Fees paid to the trustee for recordkeeping services and other fees amounted to \$49,753 for the year ended December 31, 2024.

The Plan Sponsor provides certain accounting and administrative services to the Plan for which no fees are charged. These services constitute exempt party-in-interest transactions under ERISA.

NOTE 6 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants will become 100% vested in their employer contributions, if any.

NOTE 7 – TAX STATUS

The Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service (IRS) stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the determination letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan was designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan Administrator believes that the Plan is qualified and the related trust is tax exempt as of the date of the financial statements.

US GAAP requires the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities, which are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.


