The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

1. DESCRIPTION OF PLAN

The following description of Revco Solutions 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

- a. General – The Plan is a defined contribution plan established on April 1, 2008. The Plan is designed to conform to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). All employees of Professional Recovery Consultants, Inc. (the "Company" and "Plan Sponsor") are eligible to participate in the Plan.

On January 1, 2021, the Plan was amended and restated to change the name from Professional Recovery Consultants 401(k) Profit Sharing Plan to Revco Solutions 401(k) Plan (002) and no longer exclude employees that were not formerly employed by Professional Recovery Consultants. On January 20, 2021, plan assets from the Revco Solutions 401(k) Plan (001), formerly known as the CBCS 401(k) Plan, were merged into the Plan. On April 1, 2022, the Plan was amended to recognize service with ARMC Financial Services, LLC and General Service Bureau, Inc. On April 4, 2022 and May 5, 2022, plan assets from the ARMC Financial Services, LLC 401(k) Profit Sharing Plan and the General Service Bureau and Early Out Services Employees Savings Plan, respectively, were merged into the Plan. Effective July 31, 2022, the plan was restated through the adoption of a Non-Standardized Pre-Approved Profit Sharing Plan containing substantially all the same provisions as the previously adopted Non-Standardized Profit Sharing Plan.

Effective May 1, 2024, the Plan was restated through the adoption of a John Hancock defined contribution pre-approved plan containing substantially all the same provisions as the previously adopted ADP Preapproved Profit Sharing Plan, with the exception of the addition of break in service rules and change in vesting schedule from a 5-year graded schedule to a 2-year cliff schedule. In conjunction with the restatement, the Plan selected John Hancock as its insurance company and recordkeeper.

- b. Contributions – Participants may contribute up to the maximum amount allowed by law of pretax and or after tax annual compensation each year, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

The Plan document provides for a discretionary matching contribution by the Company. The Company elected to contribute 50% of the first 6% contributed to the Plan. The Plan document also provides for discretionary profit sharing contribution. The Company did not elect profit sharing contributions for the years ended December 31, 2024 and 2023. Participants direct the investment of all contributions made on their behalf into various investment options offered by the Plan. Contributions are subject to annual limits established by the Internal Revenue Service.

- c. Participant Accounts – Each participant's account is credited with (1) the participant's contribution, (2) the company's contributions, and (3) allocation of (a) plan earnings and (b) administrative expenses that are paid by the Plan. Allocations are based on participant's plan compensation or participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. DESCRIPTION OF PLAN (Continued)

- d. Vesting – Participants are vested immediately in their contributions plus actual earnings thereon. Prior to May 1, 2024, vesting of the Company's discretionary matching and profit sharing contributions portion of their accounts was based on a 5-year graded schedule. Effective May 1, 2024, vesting on employer contributions is based on a 2-year cliff schedule. The Company has elected special vesting provisions in which active participants with 1 year of service as of May 1, 2024 will vest in employer contributions under a 2-year graded vesting schedule. Terminated participants as of May 1, 2024 will vest in employer contributions under a 5-year graded vesting schedule.

Participants will automatically become 100% vested upon attainment of normal retirement age (65) or retirement due to disability or death.

- e. Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A Participant may only have one outstanding loan from the Plan at a time. The loans are secured by the balance in the participant's account and bear interest at prime plus 1.00% at the date of the loan issuance. Interest rates on the outstanding loans as of December 31, 2024 and 2023, range from 4.25% to 9.50% and these loans mature at varying dates from 2025 through 2029. Loans must be repaid within 5 years except for loans for the purpose of acquiring a principal residence whose term shall be determined by the Plan administrator. Generally, principal and interest is paid ratably through biweekly payroll deductions.
- f. Payment of Benefits – Upon termination of service due to death, disability, retirement, or any other reason, the participant or beneficiary may elect to receive a lump-sum payment equal to the value of the participant's vested interest in his or her account. Partial withdrawals or installments are only permitted for participants or beneficiaries who must receive a required minimum distribution under IRS Code Section 401(a) (9). In addition, during active service, a participant can take hardship distributions if certain conditions are satisfied, and a participant, upon the attainment of age 59 ½, can take in-service distributions from their accounts in which they are vested.
- g. Forfeited Accounts – Forfeitures of terminated participants' non-vested accounts are held in a common collective trust fund by the custodian. At December 31, 2024 and 2023, there were \$43,647 and \$12,400, respectively in forfeited non-vested accounts. Forfeitures are used to reduce employer contributions or pay Plan expenses. In 2024, \$23,094 of forfeited funds were used to reduce employer contributions, \$2,652 were used to pay Plan expenses and an additional \$7,734 and \$8,171 were used to fund the 2022 and 2023 employer match true up, respectively. In 2025, \$24,353 of forfeited funds will be used to fund the 2024 employer match true up.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

All investments are reported at fair value, except for the common collective trust fund (See Note 6) which is reported at contract value as provided by the trustee. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the custodian and trustee. See Note 3 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is accrued on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation of the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are reclassified as deemed distributions based upon the terms of the Plan document and loan agreement.

Contributions

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment-related expenses are included in net appreciation or depreciation of fair value of investments.

3. TRUSTEE AGREEMENT

The appointed trustee of the Plan's assets is John Hancock Trust Company LLC as of May 1, 2024. Prior to May 1, 2024, the appointed trustee of the Plan's assets was Reliance Trust Company. The trustee has the authority and power to purchase and sell securities as directed by the Plan's participants. They also authorize benefit payments under the provisions of the Plan.

4. FAIR VALUE MEASUREMENTS

The Plan follows FASB ASC 820, *Fair Value Measurements*, which defines fair value as the price that would be received from selling an asset in an orderly transaction between market participants at the measurement date. When determining the fair value measurements for assets required to be recorded at fair value, the Plan considers the principal or most advantageous market in which it would transact and considers assumptions that market participants would use when pricing the asset or liability, such as inherent risk, transfer restrictions, and risk of nonperformance.

FASB ASC 820 also establishes a fair value hierarchy that requires the Plan to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The categorization of each investment type within the fair value hierarchy is based upon the lowest level of input that is significant to the fair value measurement. FASB ASC 820 establishes three levels of inputs that may be used to measure fair value: Level 1: Quoted prices in active markets for identical assets or liabilities at the measurement date; Level 2: Inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active market for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities; or Level 3: Unobservable inputs that are supported by little or no market activity and that reflect the Plan's own assumptions about market participants and prices.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds

Funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

5. COMMON COLLECTIVE TRUSTS

The Invesco Stable Value Asset ADPZ fund seeks preservation of principal and to provide interest income reasonably obtained under prevailing market conditions and rates, consistent with seeking to maintain required liquidity. At December 31, 2023, there were no unfunded commitments noted. Funds are redeemed daily and there is no redemption notice period.

6. INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by John Hancock Trust Company LLC and Reliance Trust Company, trustee of the plan as of, except for comparing such information certified by the custodian and trustee to information included in the Plan's financial statements and supplemental schedule.

7. PLAN TERMINATION

Although the Company intends to continue the Plan, it reserves the right to amend or terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their account balances.

8. TAX STATUS

On June 30, 2020, the Internal Revenue Service stated that the prototype adopted by the Plan, as then designed, qualifies under Section 401 of the Internal Revenue Code (IRC). The Plan has not received a determination letter specific to the Plan itself; however, the Plan administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

9. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Transactions between the Plan and the Plan's recordkeeper qualify as party-in-interest transactions. For the year ended December 31, 2024, ADP and John Hancock were paid direct compensation of \$20,419 and \$18,317, respectively, for services.

Marsh McLennan Agency (MMA) is the Plan's retirement plan advisor. Transactions between the Plan and the retirement plan advisor qualify as party-in-interest transactions. For the year ended December 31, 2024 MMA was paid direct compensation of \$16,906, for plan services.

10. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for plan benefits.

11. CONCENTRATIONS

At December 31, 2024, 19% and 17% of investments were held in the American Funds 2035 and 2060 Target Date Funds, respectively.

At December 31, 2023, 16% and 18% of investments were held in the American Funds 2030 and 2040 Target Date Funds, respectively.

12. SUBSEQUENT EVENTS

The Plan has evaluated events and transactions that occurred between December 31, 2024 and October 15, 2025 which is the date the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

On July 15, 2025, plan assets from the Wakefield and Associates, LLC plan were merged into the Revco plan. Plan management is responsible for oversight of the Plan and determine the appropriateness of the Plan's investment offerings and monitors investment performance.
