### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Construction 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### Opinion

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

---

### 1. DESCRIPTION OF THE PLAN

The following description of the Construction 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

**General** – The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and was established October 1, 1997. The Plan covers certain construction and craft personnel of Black & Veatch Holding Company and its subsidiaries and affiliates (collectively, the “Company”). Charles Schwab Bank (“Charles Schwab”) is the Plan’s trustee and recordkeeper.

Effective January 1, 2023, the Plan was amended and restated to adopt the Third Cycle Restatement to bring the Plan into compliance with legislative and regulatory changes set forth in IRS Notice 2017-37. There were no significant changes to the primary provisions of the Plan.

**Eligibility** – Employees of Black & Veatch Construction, Inc. and Overland Contracting, Inc. may participate in the Plan upon hiring, except as described in the Plan document.

**Contributions** – Participants may elect to contribute up to 60% of their compensation as defined in the Plan Document, subject to certain Internal Revenue Code (“IRC” or “Code”) provisions.

In 2024, the Company matched 50% of the first 6% of each participant’s pay contributed to the Plan, excluding catch up contributions. Matching contributions for 2024 were \$294,952 and were partially funded through forfeitures of the Plan.

**Plan Transfers** – Funds of \$68,034 were transferred from the Plan to the Black & Veatch Retirement Program, another qualified defined contribution plan maintained by the Company. Funds of \$47,746 were transferred to this Plan from other related plans.

**Participant Accounts** – Each participant’s account is credited with the participant’s contributions, the Company’s contribution and plan earnings or losses and is charged with a fixed quarterly fee for administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Investment Options** – Participants may direct their contributions and Company contributions into a variety of investment options offered by the Plan including a self-directed investment option, all of which are held in the Master Trust (see note 3). The self-directed investment option allows participants to direct contributions to various investments permitted by the Plan. Allocations must be in increments of 1%. A participant may change such allocation and

may transfer all or a portion of the value of his or her account among the fund options at any time.

**Vesting** – Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the matching contribution portion of their accounts plus actual earnings thereon is based on years of service. A participant is 100% vested after three years of credited service.

**Forfeitures** – Forfeitures occur upon termination of employment by a participant who is not fully vested in the Plan. Forfeitures will be used by the Company to reduce future employer contributions and pay expenses. During 2024, \$78,820 was used to reduce the employer match. Unallocated forfeitures at December 31, 2024 and 2023 were \$0.

**Payment of Benefits** – Upon termination of an employee’s participation in the Plan as a result of retirement, death or permanent disability, the employee or beneficiary is immediately vested in the Company matching contributions, plus earnings thereon, and is entitled to the full value of their participant account balance paid in a lump sum form. In the event of termination of employment for any other reason, a participant is entitled to the full value of their contributions (employee account), the earnings thereon, plus the vested portion and related earnings of the employer account.

**In-Service Withdrawals** – Hardship withdrawals are available to the plan participants for reasons as defined in the Plan Document. Participants who have attained the age of 59 ½ may elect to receive a distribution of all or any portion of their account balances in a single lump sum payment, prior to termination of employment.

**Notes Receivable from Participants** – Participants may borrow from their fund accounts, the lesser of (a) \$50,000, or (b) 50% of the participant’s vested account balance. The minimum that may be borrowed is \$1,000 and a participant may have only two outstanding loans at any time. Loans to participants bear interest equal to the Prime rate plus 1%. Participant loan fees are paid by individual Plan participants.

**Administrative Expenses** – The majority of costs and expenses incurred in administering the Plan are paid by the Company. Expenses paid by the Plan during 2024 were \$8,995.

**Termination of the Plan** – Although the Company has not expressed any intent to do so, it has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the Plan and under ERISA. In the event that the Plan should be terminated, all participants become 100% vested in their account.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** – The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“US GAAP”).

**Use of Estimates** – The preparation of financial statements in conformity with US GAAP requires management to make estimates and assumptions that affect the reported amounts

of assets, liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition*** – Investments of the Plan in the Master Trust are reported at fair value. The Plan’s interest in the Master Trust is reported at estimated fair value based upon the fair values of the underlying investments held within the Master Trust. Both participating plans holds units of participation in the Master Trust. Net assets, investment income (loss) and administrative costs relating to the Master Trust are allocated to the individual plans based upon their interest in each of the underlying participant-directed investments. Purchases and sales are recorded on a trade-date basis. Dividends and interest income are recorded on the accrual basis.

***Notes Receivable from Participants*** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance is considered necessary.

***Contributions*** – Employer and employee contributions are reported in the year services are rendered to the Company by the Plan participants.

***Payment of Benefits*** – Benefit payments are reported in the year paid.

***Date of Management’s Review*** – Subsequent events have been evaluated through August 26, 2025, which is the date the financial statements were available to be issued.

### **3. INVESTMENT IN MASTER TRUST**

The Plan entered into a Master Trust Agreement and a Master Trust was formed to hold the assets of this Plan, and the assets of the Black & Veatch Retirement Program. The investment assets of the Master Trust are held in a trust account at Charles Schwab. Use of the Master Trust permits the commingling of the assets of the Plans for investment and administrative purposes. Although assets are commingled in the Master Trust, supporting records are maintained for the purpose of allocating the net earnings of the investment accounts to the participating plans, and to the individual participants’ accounts, based on their individual investment selections and account balances.

The Master Trust invests in investment securities, which hold securities including U.S. Government securities, corporate debt instruments, and corporate stocks. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

#### 4. FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and

the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs consist of unadjusted quoted prices for identical assets in active markets that the plan has the ability to access.

Level 2 – Inputs consist of 1) quoted prices for similar assets in active markets, 2) quoted prices for identical or similar assets in inactive markets, 3) inputs other than quoted prices that are observable, and 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term.

Level 3 – Inputs consist of unobservable inputs where there is little or no market activity, and the reporting entity makes estimates and assumptions related to the pricing of the asset including assumptions regarding risk.

The assets fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Master Trust – Valued at fair value based on the fair value of the underlying investments of the fund (consist of mutual funds, separately managed accounts, stable value fund, and self-directed brokerage accounts).

Mutual Funds and Unit Investment Trusts – Valued at the net asset value (NAV) of shares held by the plan at year end based on published quoted prices.

Separately Managed Accounts – The fair value of these investments are based on the unit price, which is calculated by dividing each fund's value, consisting of all underlying holdings in the fund, by the number of the units of the fund that are outstanding. The number of units that are outstanding is derived from observable purchases and redemption activity in the collective investment fund.

Collective/Collective Trusts – The investment advisor calculates a NAV based on the contract value of its underlying investments. This investment is valued daily, can be redeemed daily with no restrictions and without prior notice. There are no unfunded commitments.

Stable Value Fund – The stable value fund is a separate account which invests primarily in wrapper contracts (also known as synthetic guaranteed investment contracts) and cash equivalents. The advisors calculate a unit value (similar to a net asset value "NAV") of the separate account daily.

Self-Directed Brokerage Accounts – Includes mutual funds, unit investment trusts, certificates of deposit, common stocks, convertible preferred stocks US government securities and corporate bonds permitted by the Plan.

Corporate Bonds, Municipal Obligations, and US Government Securities – Valued daily by a pricing service at the closing price reported on the active market on which the individual securities or similar securities are traded. (Held in the self-directed brokerage accounts.)

Certificates of Deposit – Valued at fair value by discounting related cash flows based on current yields of similar instruments with comparable durations considering the credit-worthiness of the issuer. (Held in the self-directed brokerage accounts.)

Common Stocks and Preferred Stocks – Valued at the closing price reported on the active market on which the individual securities are traded. (Held in the self-directed brokerage accounts.)

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. The Plan’s investments are reported at fair value as follows at December 31, 2024 and 2023:

(a) Certain investments that were measured at net asset value per share (or its equivalent) have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to certain line items presented in Note 3. These investments are valued daily and may be redeemed daily without restrictions and with no notice requirements. Additionally, there are no unfunded commitments.

The separately managed accounts were established for the investment of assets of the Plan, as well as other qualified benefit plans of the Company. Under the terms of the respective fund agreements, a portion of the assets held in the Black & Veatch Master Trust is invested in two separately managed accounts, both consisting of separate holdings of cash and equity securities. Shares of the separately managed accounts are held by Charles Schwab and the underlying assets are managed by the respective fund managers, Winslow Capital Management, Inc. and Putnam Capital Management, Inc. The two funds that are available for separately managed accounts are the Putnam Large Cap Value Fund and Winslow Large Cap Growth Fund.

The Stable Value Fund is an actively managed diversified portfolio of sectors and/or securities. Shares of the Stable Value Fund are held by Charles Schwab and the underlying assets are managed by Invesco Advisors.

## **5. INFORMATION CERTIFIED BY THE TRUSTEE**

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Charles Schwab Bank, the trustee of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate with respect to investments as of December 31, 2024 and 2023, and for the year ended December 31, 2024:

- Investment in the Master Trust
- Gain on interest in Master Trust
- Notes receivable from participants and related interest income
- Schedule of Assets (Held at End of Year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

## **6. TAX STATUS**

The Plan has received a favorable opinion letter from the Internal Revenue Service, dated September 21, 2020, indicating that it is qualified under Section 401 (a) of the Internal Revenue Code (the Code). Subsequent to the issuance of the opinion letter, the Plan has been amended. The Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan, as amended, is qualified and the related trust is tax-exempt.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **7. EXEMPT PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments held in the Master Trust are mutual funds managed by Charles Schwab. Charles Schwab is a trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest.

Certain Plan investments held in the Master Trust are separately managed accounts managed by Winslow Capital Management Inc. and Putnam Capital Management, Inc. These two entities are investment managers of the Plan and, therefore, these transactions qualify as party-in-interest.

The Plan pays certain fees to Charles Schwab to administer the Plan. These transactions qualify as party-in-interest. Notes receivable to participants are party-in-interest transactions.

**8. SUBSEQUENT EVENTS**

Bird Electric Enterprises, LLC 401(k) Plan assets for craft professionals merged into this Plan effective January 1, 2025.
