## **Note 1. Description of the Plan**

### **General**

The following description of George's Inc. Medical Plan and Trust (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions, which is available from the plan administrator.

The Plan provides health and other benefits to eligible employees of George's Inc. and the other participating affiliated companies (Company). Affiliated companies that also participate in the Plan include George's Processing, Inc.; George's Farms, Inc.; George's Gas Company, Inc.; George's of Missouri, Inc.; George's Chicken, LLC; George's Foods, LLC; and George's Family Farms, LLC. Certain plan assets are held in a voluntary employees' beneficiary association (VEBA) trust (Trust). The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974*, as amended (ERISA).

### **Benefits**

The Plan provides health benefits (medical, hospital, surgical, and major medical) and life insurance benefits to full-time participants (with at least 30 hours of work per week) and to their beneficiaries and covered dependents. The Plan also provides benefits to certain terminated employees under the *Consolidated Omnibus Budget Reconciliation Act*.

### **Insured Benefits**

The Plan fully insures the life insurance benefits. The Plan purchases annual insurance contracts for these insured benefits. Premiums for basic life insurance are paid to the insurance company from the general assets of the Trust.

### **Stop-Loss Coverage**

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount as well as its aggregate exposure for all claims).

### **Self-Insured Benefits**

Plan benefits, other than life insurance, are self-insured. The claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative services only (ASO) arrangements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by the general assets of the Trust. Despite the Plan's utilization of third-party claim's processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

The Plan utilizes a pharmacy benefit manager (PBM) which periodically makes refunds to the Plan based on the Plan's actual utilization pattern of specific drugs.

### **Contributions**

The Company contributes to the plan amounts needed to fund benefits in excess of contributions by eligible active employees. Employees contribute specified amounts to the Plan, determined periodically by the Company based on the type of coverage and the amount of deductible selected by the participant and the participant's length of participation in the Plan.

***Plan Termination***

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to, and contributions required of, participants to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, incurred but not reported (IBNR) claims, claims payable and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Cash Deposits***

At December 31, 2024, the Plan's cash account exceeded federally insured limits by approximately \$629,000.

***Payment of Benefits***

Premiums paid by the Plan are recorded as premium payments in the accompanying statements of changes in net assets available for benefits.

Claim payments are recorded when paid by the third-party claims processor. Amounts due to claim processors that have yet to be reimbursed by the Plan are recorded as accounts payable – claims in the accompanying statements of net assets available for benefits. The third-party claims processor processes health, disability, and death claims to active participants, dependents, and beneficiaries, but the responsibility for payments to participants and providers is retained by the Plan. These payments are recorded as benefits paid to participants in the accompanying statements of changes in net assets available for benefits.

***Stop-Loss***

Premiums for stop-loss insurance are included in premium payments in the accompanying statements of changes in net assets available for benefits. Stop-loss refunds totaling \$972,587 and \$370,557 for the years ended December 31, 2024 and 2023, respectively, have been netted with benefits paid to participants in the accompanying statements of changes in net assets available for benefits.

***Refunds***

Refunds due from the Plan's PBM are recorded when earned. Refunds due as of the financial statement date have been reported as a receivable, with the offset being netted against benefits paid to participants. Pharmacy rebates totaling \$2,975,734 and \$2,807,789 have been netted with benefits paid to participants in the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, respectively.

***Other Plan Benefits***

Plan obligations for health claims incurred but not reported are estimated based upon historic claims experience and actual claims reported subsequent to the plan year-end. Additional accruals are included for the estimated ultimate cost of future claims only if such claims are covered as of the Plan's fiscal year-end and the Plan is obligated to pay for the care regardless of continued participation in the Plan.

***Administrative Expenses***

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

**Note 3. Related-Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

As of December 31, 2024 and 2023, the Plan had \$878,758 and \$1,781,834, respectively, deposited in a checking account at a bank related to the Company by common ownership. The Plan pays no fees to the bank for its services. Funds in the amount of \$5,026,442 and \$4,767,510 for the years ended December 31, 2024 and 2023, respectively, were paid by the Plan to insurance providers and other parties-in-interest for premiums, clinic expenses, and administrative expenses.

The Company provides certain administrative services at no cost to the Plan.

Amounts currently payable to or for participants, dependents, and beneficiaries are recorded on Form 5500 for benefit claims that have been processed and approved for payment and claims incurred but not reported prior to December 31 but not yet paid as of that date.

**Note 5. Tax Status**

The VEBA trust funding certain benefits of the Plan received an exemption letter from the IRS dated April 24, 1992 stating that the trust, as then designed, was tax-exempt under the provisions of Section 501(c)(9) of the Internal Revenue Code. However, as a result of the Plan's funding policy, from time, to time, the trust may be subject to income taxes. No federal or state income taxes have been recorded in the financial statements. The plan administrator believes that the Plan and related trust are currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 6. Subsequent Events**

Subsequent events have been evaluated through October 21, 2025, which is the date the financial statements were available to be issued.
