Note 1. Description of Plan

The following description of Leading Solutions, LLC 401(k) Profit Sharing Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan, which was established on January 1, 2015, and subsequently amended with a restatement effective date of January 1, 2023 and June 9, 2023, is classified as a defined-contribution plan, covering all employees of Leading Solutions, LLC (“LS”). All employees of LS, which are age 18 or older are eligible to participate in the Plan, effective the first day of the month following the date upon which the requirements are met. There are no eligibility service requirements in order to become a participant of the Plan, make elective deferrals and receive matching contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Effective June 13, 2023, the Plan transferred or disbursed all assets from Mid Atlantic Trust Company (the “former Plan Custodian”) to Empower Annuity Insurance Company (“EAIC”) and Empower Trust Company, LLC (“Empower” or the “current Plan Custodian”). The Plan also adopted a new Plan operating document with effectively the same provisions.

Contributions

Participants may elect to contribute a percentage of their annual compensation on any combination of Pre-Tax Elective Deferrals and Roth Elective Deferrals, subject to Internal Revenue Service (“IRS”) limitations.

Employees of LS are automatically enrolled in an elective deferral percentage of 3% of their compensation upon their first day of eligibility in the Plan. Elective deferrals will be increased automatically each year for LS employees who were automatically enrolled in the Plan, by 1% up to a maximum elective deferral percentage of 6%, the date of increase will be based on the first day of the Plan year.

During 2024, LS made Safe Harbor/Qualified Automatic Contribution Arrangement (“QACA”) basic matching contributions in an amount equal to 100% of the participant’s elective deferrals up to 1% of the participant’s annual compensation, as defined, plus 50% of the participant’s elective deferrals in excess of 1% but not greater than 6% of their annual compensation. LS also has the discretion to make additional profit-sharing contributions to the Plan. There were no discretionary profit-sharing contributions made to the Plan by LS during the year ended December 31, 2024.

LS contributions to the Plan are recorded in the period in which they become obligations of LS.

Participant Accounts

Under the Plan, a separate account is maintained for each participant. Each participant’s account is credited with the participant’s contributions, employer matching contributions, allocations of Plan earnings, and is charged with an allocation of administrative expenses (if any). Participant contributions and employer matching contributions are allocated, at the participant’s election, to investment funds held at the current Plan Custodian. Participants may change their investment options at any time with certain exceptions.

Plan earnings are allocated based on the actual earnings of the respective participant’s investments. The benefit to which a participant is entitled is the vested benefit that can be provided from the participant’s account.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50%, of their vested account balance. The former Plan Custodian allowed participants to have two loans outstanding at any given time but that policy was revised with the current Plan Custodian’s loan policy, which allows only one note outstanding at any given time. The notes are collateralized by the balance in the participant’s account and bear interest at a rate equal to 1% above the prime rate. Principal and interest are paid ratably through payroll deductions.

Participant notes receivable are recorded at their unpaid balance, plus accrued but unpaid interest. If collection of the participants’ notes is in default, foreclosure on the note and attachment of security will not occur until a distribution eligibility requirement is met under the Plan.

Vesting

Participants are immediately vested in their rollover contributions and elective deferral contributions, plus earnings thereon. Upon the death or permanent disability of a participant, their entire account balance becomes fully vested.

Vesting in the Employer’s Safe Harbor/QACA contribution, plus actual earnings thereon, is based on years of continuous service, as follows:

Payment of Benefits

Upon retirement or other separation from service, a participant is entitled to receive an amount equal to the vested portion of the balance in their account. The Plan provides for several benefit payment options. There were no unpaid amounts allocated to participants who elected to withdraw from the Plan at December 31, 2024 and 2023. Benefits are recorded upon distribution.

Forfeited Accounts

Forfeited balances of participants’ non-vested accounts are used to reduce future LS contributions or may be used to pay Plan expenses. There were unallocated forfeitures of approximately \$30,000 and \$3,000 at December 31, 2024 and 2023, respectively, that could be used to offset future Employer contributions and Plan expenses. During the year ended December 31, 2024, \$2,500 was used to offset plan expenses. No forfeitures were used to reduce employer contributions.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (“GAAP”).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates and assumptions.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan’s valuation policies utilizing information provided by the trustee. See Note 4 for discussion of fair value measurements.

Investments in fully benefit-responsive investment contracts are reported at contract value. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. See Note 5 for discussion of fully benefit-responsive investment contracts.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Corrective Distribution Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2023 excess contributions to the applicable participants before March 15, 2024.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Notes Receivable from Participants

Interest income is recorded when received. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Administrative Expenses

Certain administrative expenses are paid directly by LS at its discretion and are not reimbursed by the Plan. Investment fees, commissions, and related expenses are included in net change in fair value of investments in these financial statements. Participant notes receivable administration fees are paid by the participants. Plan administration costs charged to the Plan for the year ended December 31, 2024 were approximately \$11,000.

Subsequent Events

In preparing these financial statements, LS has evaluated events and transactions for potential recognition through September 29, 2025, the date the financial statements were available to be issued.

Note 3. Certification of Plan Trustees and Custodians

Empower, as the current Plan Custodian and Trustee, holds the Plan's investments and executes all investment transactions starting June 9, 2023. The former Plan Custodian and Trustee held the Plan's investments and executed all investment transactions prior to June 9, 2023.

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Plan Trustees, qualified institutions, have certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedules is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedules.

Note 4. Fair Value Measurement

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") Topic 820 are described below:

- Level 1.** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2.** Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3.** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common investment trust: These funds are valued at the net asset value (“NAV”) of units of the collective fund. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the funds will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily.

Note 5. Investment Contract with Insurance Company

The Plan Custodians offer a fully benefit-responsible investment contract, which has the Empower Investments Fixed Account (the “EIFA”) as the only underlying option. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula established by the contract issuer and is reset quarterly. The crediting interest rate for the EIFA averaged approximately 1.45% in 2024 and 1.30% in 2023.

This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measurement for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by the issuer, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contracts totaled approximately \$51,000 and \$10,000, respectively at December 31, 2024 and 2023.

The Plan’s ability to receive amounts due is dependent on the issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Withdrawals influenced by Employer-initiated events, such as reallocation of investments, may result in a distribution at other than contract value, and are subject to certain restrictions. The Plan administrator believes that any events that would limit the Plan’s ability to transact at contract value with participants are not probable of occurring.

Note 6. Exempt Party-In-Interest Transactions

Certain Plan investments are funds managed by Empower. Empower is the trustee as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. Fees paid to the trustee by the Plan for administrative services were approximately \$11,000 for the year ended December 31, 2024.

Note 7. Plan Termination

Although it has not expressed any intent to do so, LS has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the amounts credited to the accounts of all affected participants become fully vested.

Note 8. Income Tax Status

The Plan is intended to be a qualified trust under Section 401(a) of the Internal Revenue Code ("IRC") and is subject to the provisions of ERISA. The Plan operated under two plan documents during 2023. The original Plan was a prototype plan and received a determination of qualification from the IRS dated August 31, 2020. Effective June 9, 2023, the Plan adopted a new Volume Submitter Profit Sharing Plan document (the "Amended Plan") that was adopted with substantially the same provisions as the old prototype plan document. The Amended Plan, as adopted, is a non-standardized pre-approved profit-sharing plan with a cash or deferred arrangement ("CODA") that has received an opinion letter, dated November 14, 2022, from the IRS stating that the form of the plan is acceptable under Section 401 of the IRC for use by employers for the benefit of employees. The Plan administrator believes that the adopted and amended Plan is currently designed, and is being operated, in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified, and the related trust is tax-exempt.

Note 9. Prohibited Transactions

During 2023, it was discovered that LS incorrectly calculated certain employee deferrals, which is considered a prohibited transaction per ERISA.

IRS guidelines required that the Plan sponsor remedy the underfunding, including lost earnings, for those participants who were impacted. During the year ended December 31, 2023, LS made qualified non-elective contributions to the Plan of approximately \$2,100, which represented 100% of the missed employee deferrals from the date of the missed deferral through the year ended December 31, 2023, as well as the related computed lost earnings.

Note 10. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.
