NOTES TO FINANCIAL STATEMENTS**AVALA 401(k) Plan**

December 31, 2024 and 2023

Note 1 - PLAN DESCRIPTION

The following description of the AVALA 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

a. General

The Plan is a defined contribution plan covering all employees of Fairway Medical Center LLC d.b.a. AVALA and AVALA Physicians Network, LLC, (the “Employers”) who are age eighteen or older and not considered an “Excluded Employee”. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Effective April 1, 2025, Avala Holdings will be a participating employer in the Plan.

b. Contributions

Participants may contribute, by salary reduction pursuant to Section 401(k) of the Internal Revenue Code (the “Code”), up to 100% of their pretax annual compensation, as defined in the Plan, not to exceed statutory limits. Participants are also permitted to make Roth (after-tax) elective deferrals, subject to annual statutory limits. Participants may also contribute amounts representing eligible rollover distributions from other qualified plans.

The Employers’ may contribute to the Plan a discretionary matching employer contribution on behalf of eligible participants equal to a discretionary percentage, to be determined by the Employers’ each payroll period. For the years ended December 31, 2024 and 2023, the Employers’ elected to match 75% of a participant’s contributions up to 6% not to exceed 4.5% of a Participant’s eligible compensation. The total Employers’ contributions for December 31, 2024 totaled \$511,147 net of forfeitures of \$87,520.

In any year, the Employers may also make discretionary non-elective contributions and/or qualified non-elective contributions. The Employers made no discretionary non-elective contributions or qualified non-elective contributions for the year ended December 31, 2024.

c. Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Employers' contributions and plan earnings. Participant accounts are charged with plan losses and an allocation of administrative expenses that are paid by the Plan. Allocations of Employers' contributions are based on participant compensation or salary deferrals, as defined in the plan document, and allocations of plan earnings or losses and expenses are based on account balances or specific participant transaction. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

d. Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Employers' discretionary matching employer contributions and discretionary profit-sharing contribution portion of their accounts, plus actual earnings thereon, is based on either the general or elapsed time method and is dependent upon if you were an employee before or after January 6, 2024. If you became an employee after January 6, 2024, vesting credit is based on your years of service under the elapsed time method, which is based upon your date of employment with the Employers. Prior to this date, vesting credit for years of service is based upon the following:

To earn a year of service under the general method, a participant must be credited with at least 1,000 hours of service during any plan year.

e. Investment Options

The Plan provides a participant-directed investment program, whereby participants select the investments for their accounts. The Plan currently offers various investment options to the participants. These investment options represent several different alternatives to investing with different risk and return characteristics. Participants may change their investment options daily.

f. Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes bear an interest rate that is determined at the origination of the note by the Plan administrator based on prevailing interest rates and is fixed over the life of the note. Principal and interest is paid ratably through payroll deductions. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

g. Payment of Benefits

On termination of services due to death, disability, or retirement or other reasons, a participant will receive a lump sum amount equal to the value of the participant's vested interest in his or her account. Upon termination of service, a participant whose vested account balance is greater than \$1,000 but less than \$7,000 will be distributed to an Individual Retirement Account. Participants with vested account balances of \$1,000 or less will receive an involuntary distribution of their account balances. Additionally, a participant may request an in-service withdrawal of all or part of his or her account balance upon reaching age 59½ or part of the elective deferral portion of his or her account may be withdrawn as a hardship distribution, as defined in the plan document.

h. Forfeitures

As of December 31, 2024 and 2023, forfeited accounts totaled \$112,321 and \$60,025, respectively. These accounts will be used to reduce future plan expenses or employer contributions. For the year ended December 31, 2024, forfeitures totaling \$87,520 were used to reduce the employer contributions.

Note 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following are the significant accounting policies followed by the Plan:

a. Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Note 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

b. Use of Estimates

The preparation of financial statements in conformity with the accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

c. Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, except for fully-benefit responsive investment contracts, which are reported at contract value based on information provided by Fidelity Management Trust Company. Fair value is the price that would be required to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note 4 for a discussion of the fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year. Related investment fees are netted against investment income.

d. Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

e. Payment of Benefits

Benefits are recorded when paid.

f. Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employers. Expenses that are paid by the Employers are excluded from these financial statements. Investment-related expenses are included in net appreciation of fair value of investments.

Note 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

g. SECURE 2.0 Act of 2022

On December 29, 2022, the SECURE 2.0 Act was enacted to help improve retirement savings. The SECURE 2.0 Act made wide-ranging changes, both mandatory and elective, to qualified plans and its provisions have various effective dates.

Significant provisions were as follows:

- The RMD age was increased from 72 to 73, effective January 1, 2023, and to age 75, effective January 1, 2033;
- The excise tax for failure to take RMDs was reduced from 50% to 25% of the RMD amount that was not taken, beginning January 1, 2023; and
- All catch-up contributions for participants with compensation of more than \$145,000 (indexed for inflation) are required to be designated as Roth 401(k) contributions beginning after December 31, 2023. However, in August 2023, the Internal Revenue Service (IRS) announced an administrative transition period that delays this requirement until taxable years beginning after December 31, 2025.

The Plan will incorporate changes in its plan document and administration to the extent required by the “SECURE 2.0 Act”.

h. Subsequent Events

The Plan has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued.

Note 3 - INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule of assets (held at end of year), including investments as of December 31, 2024, and net appreciation in fair value of investments and interest and dividend income for the year ended, was obtained and derived from information provided to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan for the 2024 Plan year, in accordance with Section 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments as of December 31, 2023, was obtained and derived from information provided to the plan administrator and certified as complete and accurate by Voya Retirement Insurance and Annuity Companies, the trustee of the Plan for the 2023 Plan, in accordance with Section 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

Note 4 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy which prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the overall fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

- *Money market and Mutual funds*: Valued at the daily closing price as reported by the fund. Money market and Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price (Level 1). The money market and mutual funds held by the Plan were deemed to be actively traded.

Note 4 - FAIR VALUE MEASUREMENTS (Continued)

- *Pooled Separate Accounts:* The fair value of the mutual funds and money market fund held in pooled separate accounts for which a quoted market price is not available, are valued using NAV per share as a practical expedient. The estimated fair value of separate account assets are based on the fair value of the underlying assets owned by the separate account and generally based on observable valuation inputs.

Based on a reevaluation of the criteria for concluding that an investment has a readily determinable fair value, the fair value of the pooled separate accounts as of December 31, 2023 has been reclassified to Level 2 in the fair value table to conform with the current year presentation. This reclassification has no impact on net assets available for benefits as of December 31, 2023.

Note 5 - INVESTMENT CONTRACT WITH INSURANCE COMPANY

In December 2023, the Plan entered a fully benefit-responsive investment contract with Lincoln National Life Insurance Company (“Lincoln National”) with an effective date of January 6, 2024. Lincoln National maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan.

Note 5 - INVESTMENT CONTRACT WITH INSURANCE COMPANY (Continued)

The guaranteed investment contract is fully benefit responsive; therefore, contract value is the relevant measurement. Contract value, as reported to the Plan by Lincoln National, totaled \$290,790 at December 31, 2024 and represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise. Minimum guaranteed interest rate is 1.00% and interest is updated quarterly. The interest rate at December 31, 2024, was 3.4%.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Corporation or other Corporation events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The guaranteed investment contract may be terminated at any time giving notice of contract termination at least 90 days but not more than 180 days in advance of the payout initiation date.

Prior to January 6, 2024, the Plan's group annuity contract was with Voya Fixed Account. Because the group annuity contract was fully benefit-responsive, contract value was the relevant measurement attribute for that portion of the net assets available for benefits attributable to the group annuity contract. The group annuity contract was presented on the face of the Statements of Net Assets Available for Benefits at contract value and totaled \$317,121 at December 31, 2023. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Note 5 - INVESTMENT CONTRACT WITH INSURANCE COMPANY (Continued)

The Voya Fixed Account guaranteed principal and a minimum guaranteed interest rate for the life of the product as well as featuring two declared interest rates: a current rate, determined at least monthly, and a guaranteed minimum floor rate declared for a defined period. Voya's determination of credited interest rates reflected a number of factors, including mortality and expense risks, interest rate guarantees, the investment income earned on invested assets and the amortization of any capital gains (losses) realized on the sale of invested assets. Voya assumed the risk of investment gain or loss by guaranteeing the principal amount and promising a minimum interest rate. However, early withdrawals could be subject to contract surrender charges and market value adjustments which could result in the loss of principal and earnings.

Certain events limited the Plan's ability to transact at contract value with Voya. Such events included the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsors events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the Employee Retirement Income Security Act of 1974.

Note 6 - RISK AND UNCERTAINTIES

The Plan provides for various investments in certain mutual funds, a money market fund and a general account. Investment securities, in general, are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 7 - PLAN TERMINATION

Although they have not expressed any intent to do so, the Employers have the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, all amounts credited to participant accounts will be paid to the participant in accordance with the plan document.

Note 8 - TAX STATUS

Effective January 6, 2024, the Plan adopted a non-standardized pre-approved profit-sharing plan with CODA. The document sponsor received a favorable opinion letter from the IRS dated June 30, 2020, which states that the non-standardized pre-approved plan is acceptable under the Internal Revenue Code (IRC) Section 401. Although the Plan has been amended since receiving the letter, the Plan administrator and legal counsel believe the Plan is designed, and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code, and therefore believe that the Plan is qualified, and related trust is tax-exempt.

Previously, the Employers adopted a non-standardized profit sharing plan on January 1, 2000, restated April 1, 2022, and amended in both 2022 and 2023. The non-standardized profit sharing plan received a favorable tax opinion letter in which the IRS stated that the Plan, as designed, was in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9 - RELATED PARTY TRANSACTIONS

Effective January 6, 2024, certain plan investments are shares of mutual funds, a money market fund and a group annuity contract and participant loans issued and managed by affiliates of Fidelity Management Trust Company. Additionally, an affiliate of Fidelity Management Trust Company provides recordkeeping services. Fidelity Management Trust Company acts as the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment. The plan sponsor pays directly any other fees related to the Plan's operations.

Between January 1, 2023, to January 5, 2024, the Plan included various investments in certain mutual funds, a money market fund, a group annuity contract and participant loans issued and managed by Voya Retirement Insurance and Annuity Companies ("Voya"). These specific investments issued by or managed by Voya qualify as party-in-interest transactions. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
